This clause shall be valid for 18 months from date of despatch/shipment or 12 months from date of successful installation of the items at site, which ever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.
- 2. The minimum FOB/FCA charges in case of partial order for reduced quantity/ items shall have to be indicated by the bidder. In case this is not indicated specifically, the charges quoted would be prorate calculated and the same will be binding on the bidder.
- 3.
