Name of Manufacturer, Reel no., API or IS license number including monogram & date of manufacture, Length of rope, Diameter of rope, Type of construction, Lay, Grade, Type of core, Purchase Order No., Net weight and Gross weight shall be paint stenciled on the body of the Reel
