(6) To evaluate the inter-se ranking of the offers, Assam Entry Tax on purchase value will be loaded as per prevailing Government of Assam Guidelines as applicable on bid closing date. Bidders may check this with the appropriate authority while submitting their bids.

(7) Bidder must mention page no./nos. in every pages of their offer.

(8) Bidders should submit their bids (preferably in tabular form) explicitly mentioning compliance / non compliance to all the NIT terms and conditions of NIT.

(9) Bidder should clearly mention their name and address on the outside of the envelope containing their offer.

The successful bidder shall submit Performance Security @10% of PO value within 30 days of receipt of the formal purchase order failing which OIL reserves the right to cancel the order. Bidders should undertake in their bids to submit Performance Security as stated above.

The Performance Security shall be in any one of the following forms :

(a) A Bank Guarantee in the prescribed OIL's format valid for 3(three) months beyond the Warranty period indicated in the Purchase Order /contract agreement.

The Performance Security for capital nature items like plant and machinery etc. shall be valid for 12 months from the date of commissioning plus 3(three) months or 18 months from the date of shipment/despatch plus 3(three) months whichever concludes earlier. However, for consumables like chemicals, cement, tubular etc. the Performance Security shall be valid for 12 months from the date of shipment/despatch plus 3(three) months.

The validity requirement of Performance Security is assuming despatch within stipulated delivery period and confirmation to all terms and conditions of order. In case of any delay in despatch or non-confirmation to all terms and conditions of order, validity of the Performance Security is to be extended suitably as advised by OIL.

- Special Notes :**
1. All items shall be brand new and of reputed make as per the specifications, standards and description given in the tender.
 2. All Torque Wrenches should be compact, light weight, rigid to suit the rugged oilfield working conditions.
 3. Torque wrenches must be made out of hardened alloy steel.
 4. Offer must include one extension tube and one ratcheting head with each torque wrench.
 5. Bidder must have manufacturer's name/identification mark embossed on each of the items supplied.
 6. Bidder must provide the following documents along with the offer without which the offer will be considered technically non-responsive:
 - i) Technical literature showing all technical details including dimension, weight, metallurgy etc. for each model of Torque Wrench.
 - ii) Bidder must ensure in their offer that calibration certificates as mentioned above will be provided along with the supply.
 7. Bidder should be OEM or authorised dealer of OEM or authorised stockist of OEM:
 8. In case of imported item, certificate of country of origin is to be provided along with the offer.
 9. Offer from a Bidder must include for all Torque Wrenches. Offer for only part of the tender items shall be considered non-responsive.
 10. All Torque Wrenches must be from single manufacturer.

UNDERTAKING by the bidder:

1.0 The items shall be warranted for the material, the design and the purported operation. Such warrantee shall be to the extent, that if any defect/failure attributable to faulty workmanship, design or material occur in the tools within a period of one year or 18 months (whichever is less) from the date of receipt of the tools, the supplier shall replace such defective tools free of cost.

2.0 The supplier shall provide warrantee certificate covering the terms mentioned in point 1.0 above at the time of supply and all bidders shall furnish with their offer undertaking to provide the aforesaid warrantee in the event of an order.
