(2) The offer should be submitted in Duplicate.

(3) Any sum of money due and payable to the contractor (including Security Deposit refundable to them) under this or any other contract may be appropriated by Oil India Limited and set-off against any claim of Oil India Limited (or such other person or persons contracting through Oil India Limited) for payment of a sum of money arising out of this contract or under any other contract made by the contractor with Oil India Limited (or such other person or persons contracting through Oil India Limited).

(7) Bidder must mention page no./nos. in every pages of their offer.

(8) Bidders should submit their bids (preferably in tabular form) explicitly mentioning compliance / non compliance to all the NIT terms and conditions of NIT.

(9) Bidder should clearly mention their name and address on the outside of the envelope containing their offer.

(10) In the event of receipt of only a single offer against the tender within B.C.date, OIL reserves the right to extend the B.C. date as deemed fit by the company. Special Notes : 1. The bidder must be an OEM or an authorized dealer of the OEM of the offered item. In case of an authorized dealer, he must have minimum three years of experience of selling with support services of the quoted or similar items of the OEM. Copy of authorized (OEM) manufacturer's dealership certificate for the last three continuously reckoned prior to the date of opening of the technical bid must be provided with the offer.

2. The bidder must mention make & model of the offered item

3. The bidder must forward technical and product catalogue / leaflet with dimensions of the offered item along with the offer.

4. Item should be brand new, unused and free from all manufacturing defects. Bidder should confirm the same while quoting.

5. Bidder should warrant [in the event of order] that the product will be free from all defects & fault in materials, workmanship & manufacture. The clause shall be valid for 18 months from date of receipt or 12 months from the date of commissioning of the item, whichever is earlier.

6. Bidder shall confirm that defective materials, if rejected shall be replaced by the supplier at their own expense. Bidder is to confirm the same.
