- Special Notes : 1.0 The anti corrosive compound should be of Hempel make epoxy based coating Hempadur 856771 or Equivalent of reputed make.
 - 2.0 The bidder should be Original Equipment Manufacturer (OEM) of the anti corrosive coating or their authorized dealer. The bidder other than OEM must submit a copy of valid dealership certificate from OEM along with the offer.
 - 3.0 In case equivalent anti corrosive coating is offered, the bidder in support of their product must submit the printed technical literature/document along with the MSDS giving comparison with the item description to justify equivalency of their offered product failing which the offer is liable for rejection.
 - 4.0 The bidders are to confirm in their offer that they will submit manufacture's inspection, test, MSDS and guarantee certificate along with the supply of materials.
 - 5.0 The bidder is required to submit the brief description of method for application of their offered products along with the bid.
 - 6.0 The product must be compatible with potable/river water application as our Pontoons are in the river water. In this regard the bidder must submit the certification from OEM or OEM's printed technical literature indicating compatibility of the offered product with potable/river water.
 - 7.0 The bidder should ensure that shelf life of the coatings should be at least one (01) year from the date of manufacture and the bidder must specify the shelf life of the offered coatings in their bid.
 - 8.0 The bidder must guarantee against their product and workmanship for a minimum period of one (01) year from the date of completion of application of coatings in the pontoons.
 - 9.0 The bidder must note that the scope of the order consists of the followings:
 - (a) Supply of materials
 - (b) Application of two coats of materials to a total thickness of 200 microns
 - (c) Surface preparation by abrasive/shot blasting wherever it is required as per OEM's recommendations or to the satisfaction of Head-FE or his authorized representatives.
 - 10.0 Prior to starting the job, a joint inspection of OIL and Supplier will be carried out for application of coatings in Pontoons. Thereafter, a joint action plan will be drawn to carry out the job.
 - 11.0 In case any materials like putty, primer, etc. required for application of their offered products, the bidder shall be required to supply the same at their own cost. However, the supplier has to take prior approval from Head-FE or his authorized representatives for application of above materials.

- 12.0 The surface preparation includes removal of existing paints from the surface, cleaning and making surface ready for application of the anti corrosive coatings to the satisfaction of HEAD-FE or his representatives. The supplier must take extra care for not to occur any pilferage/spillage of paints onto the river during application of the materials.
- 13.0 In case any minor repairing job needs to be carried out during application of coatings, the bidder will be required to carry out the same under the supervision of OIL. All the materials including welding machine, if required, will be provided by the OIL. The supplier must obtain work permits from IM/Head-FE or his authorized representatives prior to execution of the application/repairing jobs.
- 14.0 Unused/excess material to be returned to the company.
- 15.0 Since pontoons are in operation proper safety measures to be taken while carrying out the job by the supplier and it is to be as per as per advice of Head-FE or his authorized representatives.
- 16.0 Any item found damaged during inspection /transportation will have to be replaced by the vendor free of cost.
