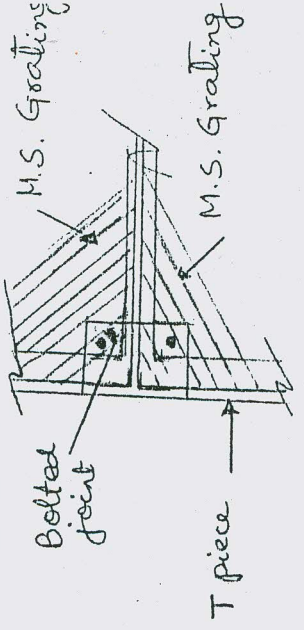

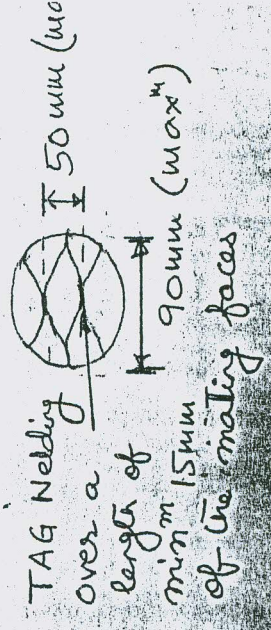

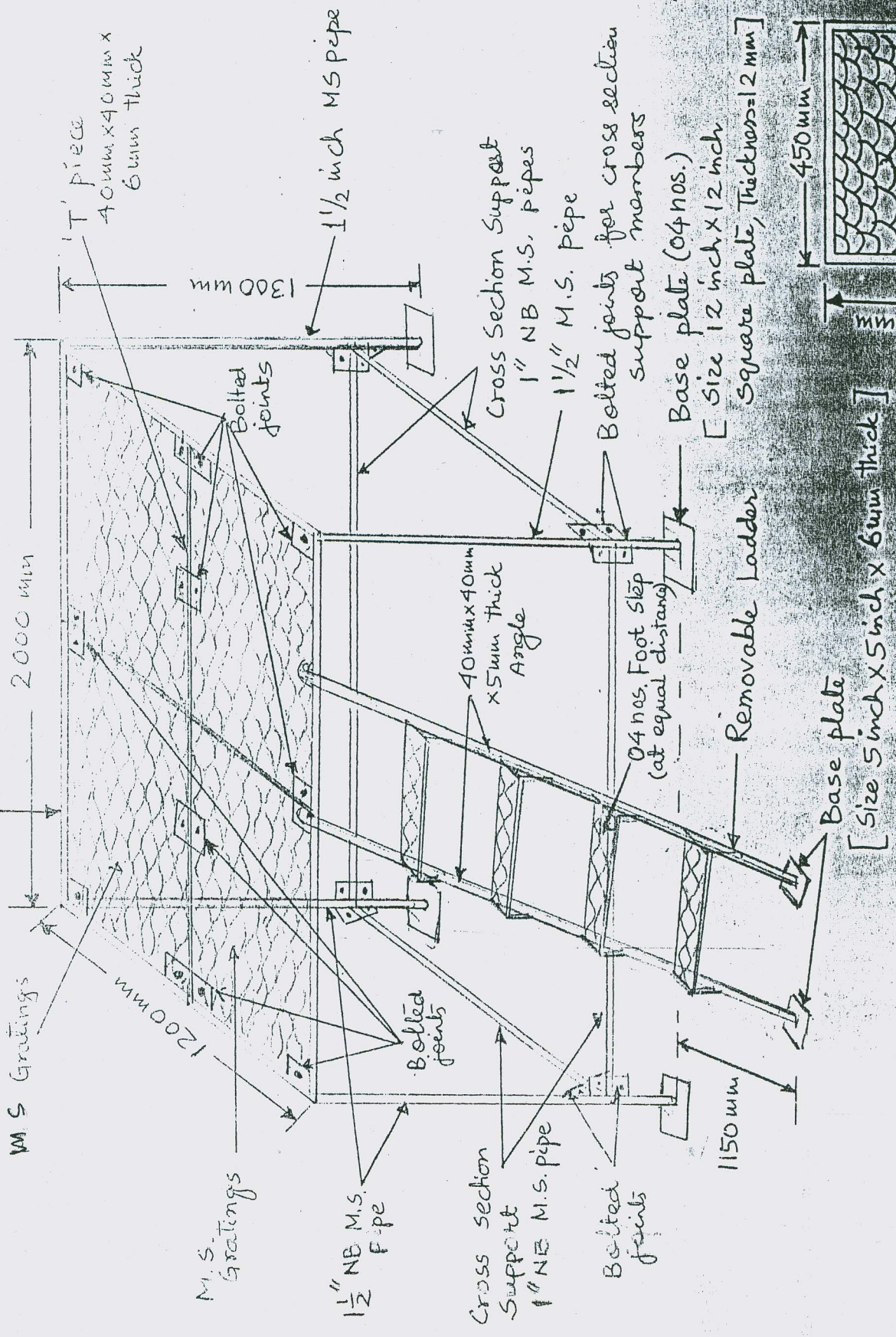
Section A-A'
