In cash of discrepancy, the rates, quoted in words shall be considered to be correct.
- **6.** Before tendering, the Tenderer is advised to inspect the work site with permission from the **GM [PL-PS3] Jorhat** or his representative to assess the nature and extent of the work and the conditions under which it will be carried out, may also seek such clarification from this office as deemed necessary.
- 7. The Company reserves the right of rejecting any or all tenders or accepting and tenders in part without assigning any reason, the tender papers if personally not collected after notification will be sent to the applicant by registered post. - 11. The work may be split-up among more than one contractor at the sole discretion of the Company.
- 12. The work shall have to be started within 7 (seven) days from the date of work order.
- 13. Time shall be regarded as the essence of the contract and the failure on the part of the contractor to complete the work within the stipulated time shall entitle the Company to recover liquidated damage and/or penalty from the contractor as per terms of the tender contract.
- 14. The Schedule tenderer will be required to enter into a formal contract which will be based on his tender on the OIL Standard Form of Contract.
- 15. The successful tenderer(s) shall furnish a Performance Security deposit in form of Bank Draft as specified above before signing the formal contract, if applicable. The security deposit together with Earnest Money will be treated as security money and will be refunded to the contractor after satisfactory completion of the work, but part or whole of which shall be used by the Company in realization of liquidated damages if any, or for adjustment of compensation/loss due to the Company for any reason.
