- 10. Conditional tenders are liable to be rejected at the discretion of the company.
- 11. The work may be split-up among more than one contractor at the sole discretion of the company.
- 12. The work shall have to be started within 7 (seven) days from the date of work order.
- 13. Time shall be regarded as the essence of the contract and the failure on the part of the contractor to complete the

work within the stipulated time shall entitle the Company to recover liquidated damage and/or penalty from the contractor as per terms of the tender contract.
