- 5. Before tendering, the Tenderer is advised to inspect the work site with permission from the **Dy.G.M.(PL-PS3)**, **Jorhat** or his representative to assess the nature and extent of the work and the conditions under which it will be carried out, may also seek such clarification from this office as deemed necessary.

In such case OIL registered contractor shall be debarred from further tendering for a minimum period of 6 (six) months.

- b) Once a withdrawal letter is received from any bidder the offer will be treated as with drawn and no further claim/correspondence will be entertained in this regard.
- 8. The tender must be valid for 180 days from the date of opening of tender.
- 9. Conditional tenders are liable to be rejected at the discretion of the company.
- 10. The work may be split-up among more than one contractor at the sole discretion of the company.
- 11. The work shall have to be started within 7 (seven) days from the date of work order.
- 12. Time shall be regarded as the essence of the contract and the failure on the part of the contractor to complete thework within the stipulated time shall entitle the Company to recover liquidated damage and/or penalty from the contractor as per terms of the tender contract.
