No over-writing shall be allowed, but all corrections may be inserted in the blank space above the corrected words/figure and must be initiated. In cash of discrepancy, the rates, quoted in words shall be considered to be corrected.
- 6. Before tendering, the Tenderer is advised to inspect the work site with permission from the **CEPL (O) NT** or his representative to assess the nature and extent of the work and the conditions under which it will be carried out, may also seek such clarification from this office as deemed necessary.
- 7. The company reserves the right of rejecting any or all tenders or accepting and tenders in part without assigning any reason, the tender papers if personally not collected after notification will be sent to the applicant by registered post. - 13. Time shall be regarded as the essence of the contract and the failure on the part of the contractor to complete the work within the stipulated time shall entitle the Company to recover liquidated damage and/or penalty from the contractor as per terms of the tender contract.

- 15. The successful tenderer(s) shall furnish a security deposit in form of Bank Draft as specified above before signing the formal contract.
