BID REJECTION CRITERIA (BRC) / BID EVALUATION CRITERIA (BEC)

1.0 FINANCIAL CAPABILITY: BIDDERS MUST HAVE

The average annual financial turnover of the Bidder during the last three years (**ending 31st March 2013**) should be not less than **Rs 96,000.00**

For proof of annual turn over any of the following document / photocopy must be submitted along with the bid.

- a) A certificate issued by a practicing chartered / Cost accountant firm, with membership number certifying the annual turn over and nature of business.
- b) Audited Balance Sheet and Profit and Loss account.

2.0 Experience: Bidders must have;

Experience of having successfully completed similar work during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

- (i) Three similar completed works each costing not less than ` **1,28,000.00**
Or
- (ii) Two similar completed works each costing not less than ` **1,60,000.00**
Or
- (iii) One similar completed works each costing not less than ` **2,56,000.00**

Similar Work means supply of piping work

3.0 EVALUATION OF BIDS:

The Bids will be evaluated as per the Bid Evaluation Criteria (BEC) as stated herein under:

BID EVALUATION CRITERIA (BEC)

- 4.1 Bids conforming to the technical specification, terms and conditions stipulated in the bid document and considered and subject to qualifying the Bid Rejection Criteria will be considered for further evaluation.
- 4.2 To ascertain the inter-se-ranking, the comparison of the responsive bids will be made on the basis of total amount quoted for the items of SOQ of the tender.
- 4.3 Any discount/rebates offered shall not be considered for evaluation of bids. However, if the lowest bidder happens to be the final acceptable bidder for award of contract and if they have offered any discount/rebate the contract shall be awarded after taking into consideration such discount/rebate after negotiation or otherwise.
- 4.4 In case more than one bidder emerges as lowest bidder due to equal rate quoted by the bidder, then the lowest bidder will be decided by draw of lots. Company's decision in this regard is final and binding to all bidders.
