1.0 Financial capability: Bidders must have

Average Annual financial turnover as per Audited Annual Reports for the last three accounting years (ending 31st March, 2014) should be at least ₹1,65,000.00

For Proof of Annual Turnover any of the following documents /photocopy must be furnished:

- A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
- Audited Balance Sheet and Profit & Loss account.

2.0 Experience: Bidders must have;
