BID REJECTION CRITERIA /BID EVALUATION CRITERIA (BRC)

[A] Financial capability: Bidders must have

- 1. Average Annual financial turnover as per Audited Annual Reports for the last three accounting years (ending 31st March, 2014) preceding scheduled bid opening date should be at least Rs. 1,17,300.00
- 2. For Proof of Annual Turnover any of the following documents /photocopy must be furnished
 - A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
 - Audited Balance Sheet and Profit & Loss account.

[B] Experience: Bidders must have;

- (a) Experience of having successfully completed similar works (<u>Similar work mean providing vehicles on hire</u>) during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:
 - (i) Three similar completed works each costing not less than **Rs. 1,56,400.00 Or**
 - (ii) Two similar completed works each costing not less than Rs. 1,95,500.00

(iii) One similar completed works each costing not less than Rs. 3,12,800.00

Documentary proof must be furnished in support of the experience by way of purchase order / work order / contract document along with completion certificate i.e Service Entry Sheet(SES)from the organization to whom such services have been rendered.

(C) The Bidder must have a business office establishment for at least one year within 50 Km radius of the area of operation where the services need to be provided.
