## 1.0 Financial capability: Bidders must have

- 1. Average Annual financial turnover as per Audited Annual Reports for the last three accounting years (ending 31<sup>st</sup> March, 2014) preceding scheduled bid opening date should be at least Rs. 2.36.100.00
- 2. For Proof of Annual Turnover any of the following documents /photocopy must be furnished
  - A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
  - Audited Balance Sheet and Profit & Loss account.

### 2.0 Experience: Bidders must have;

- (a) Experience of having successfully completed similar works ( <u>Similar work mean providing vehicles on hire</u>) during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:
  - (i) Three similar completed works each costing not less than Rs. 3,14,800.00
