3.0 Quotation should be submitted in duplicate.

In the authorisation letter, it is to be clearly mentioned that you are authorising your dealer/stockist/channel partner to quote on your behalf against the tender (Tender no should be clearly mentioned)

In the event the dealer/stockist/channel partner do not mention the name of their OEM/principal on the body of the envelope and fail to submit Authorisation Letter, the offer shall be treated as unsolicited offer and will not be considered for opening.

Further, the authorised dealer should submit a copy of valid dealership certificate from their OEM.

5.0 Bidders are to quote for Unit Material value, Packing/Forwarding Charges (if any), Taxes & Duties as applicable, Transportation charges etc. upto OIL's Office at Jodhpur, Payment Terms, Delivery Period, Net Weight, Gross Weight & Volume in their offer.

11.0 Original signed offer should be submitted in sealed envelope. No offers should be sent by Telex, Cable, E-mail or Fax. Such offers will not be accepted.

12.0 Bids containing incorrect statement will be rejected.

13.0 Bids shall have no interlineations, erasures or overwriting except as necessary to correct the errors made by the bidder, in which case, such corrections shall be initiated by the person(s) signing the bid. Any bid not meeting this requirement shall be rejected.

However, if any of the Clauses of the tender stipulated above contradict the Clauses of the booklet MM/RP/GLOBAL/2011 elsewhere, those in this tender document shall prevail.

Special Notes : 1. All items should be brand new, unused and of prime quality.

2. Offer shall be clear, un-ambiguous (with no alternatives) and complete with all data sheets, catalogues etc.

3. Quotation should be forwarded in a tabular form, enlisting the compliance and deviations of the technical specifications for ease in scrutiny.

4. Offer from bidder other than OEM must provide valid documentary evidence / authorization certificate from OEM along with the bid.

5. The bidder must offer up to date products and declaration of the same has to be provided. Bidder other than OEM has to provide such declaration from OEM. Obsolete products will not be considered for evaluation. OEM also has to confirm that the spares for the items will be available in the market for the next minimum 10 years from the date of purchase.

6. For the items & accessories the bidder has to provide guarantee / warranty for a minimum period of 12 months from the date of successful commissioning or 18 months from the date of supply, whichever is earlier. However, the bidder has to provide minimum 2 years guarantee / warranty for the sensors from the date of successful commissioning. The bidder has to confirm the same in writing during submission of bid. Warranty / Guarantee Certificates are to be provided along with the material supply.

7. Test / calibration certificate for each item should be provided along with the material. The bidder has to confirm the same in writing during submission of bid.

8. The bidder should state the address of their service centre along with the bid. Bids from bidders having their authorized service centre in India will only be considered for evaluation.

9. The offered detectors are to be approved by the Directorate General of Mines Safety (DGMS) for use in Zone-1 & Zone-2 Hazardous Areas of Oil Mines and the relevant valid certificate copy to be supplied along with the material. The Bidder has to provide a firm confirmation in this regard during submission of offer. However, the bidder may supply materials with DGMS field trial permission certificate and the payment in that case will be to the extent of 50% of total cost of the items. The balance 50% shall be made on submission of DGMS approval. The items will be considered as successfully commissioned only after obtaining valid DGMS approval for the items.

10. If any manufacturing defects / transit damages observed after receipt of the materials or any malfunction observed in the items & accessories during the warranty/guarantee period; then the defective items or accessories must be replaced/repared within a short period of time by the bidder at their own expenses at no extra cost to OIL. Warranty/ Guarantee period will not be counted during the equipment faulty period.

11. Packing must be adequate to avoid damages during transit.
