from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India.

- 8. ANNEXURE- A

BID EVALUATION CRITERIA/BID REJECTION CRITERIA

BID REJECTION CRITERIA

The bids shall in general conform to the specifications and terms and conditions given in the tender. Bids shall be rejected in case the goods offered do not conform to the required minimum/maximum parameters stipulated in the technical specifications and to the respective international / national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the following requirements will have to be particularly met by the bids, without which the same will be considered as non-responsive and be rejected.

(I) <u>BID REJECTION CRITERIA (BRC)</u>

A. Technical:

- 1. The bit manufacturer should have an experience of minimum 5 (five) years in manufacturing 26 inches OD Polycrystalline Diamond Compact bit. For this purpose the period reckoned shall be the period prior to the date of opening of the techno-commercial bid.
- 2. The bit manufacturer should also have the experience of supplying at least 3 (three) numbers of 26 inches OD Polycrystalline Diamond Compact bit, in the last 5 (five) years preceding the bid closing date of this tender.
- 3. Documentary evidence to substantiate supply record should be submitted in the form of copies of relevant Purchase Orders along with copies of any of the documents in respect of satisfactory execution of each of those Purchase Orders, such as:
 - (i) Bill of Lading (OR)
 - (ii) Delivery challans received by Consignee (OR)

- (iii) Central Excise Gate Pass / Tax Invoice issued under relevant rules of Central Excise / VAT (OR)
- iv) Any other documentary evidence that can substantiate the satisfactory execution of each of the purchase order cited above

Note: Order copy to be enclosed with relevant page number bearing signature of purchaser or authenticated by purchaser.

B. COMMERCIAL:

- i) Bids are invited under **Single Stage Composite Bid System**. Bidders shall quote accordingly under Single Stage Composite Bid System.
- ii) Validity of the bid shall be minimum 120 days from the date of Bid Closing Date. Bids with lesser validity will be straightway rejected.
- iii) Bidders must confirm that Goods, materials or plant(s) to be supplied shall be new of recent make and of the best quality and workmanship and shall be guaranteed for a period of 12 months from the date of shipment/dispatch against any defects arising from faulty materials, workmanship or design. Defective goods/materials or parts rejected by OIL shall be replaced immediately by the supplier at the supplier's expenses at no extra cost to OIL.
- iv) Performance Guarantee @ 10% of order value shall be applicable in the event of order. Bidder to confirm submission of Performance Guarantee while quoting failing which offer shall be treated as rejected as per para 1.9 of BRC of section D of general terms and Condition for Global Tender (MM/GLOBAL/E01/2005-JULY2012).
- v) OIL shall be entering into an Integrity Pact with the bidders as per format enclosed vide Annexure XII of the tender document. This Integrity Pact proforma has been duly signed digitally by OIL's competent signatory. The proforma has to be returned by the bidder (along with the technical bid) duly signed (digitally) by the same signatory who signed the bid, i.e., who is duly authorized to sign the bid. Uploading the Integrity Pact with digital signature will be construed that all pages of the Integrity Pact has been signed by the bidder's authorized signatory who sign the Bid. If any bidder refuses to sign Integrity Pact or declines to submit Integrity Pact with the offer, their bid shall be rejected straightway.
