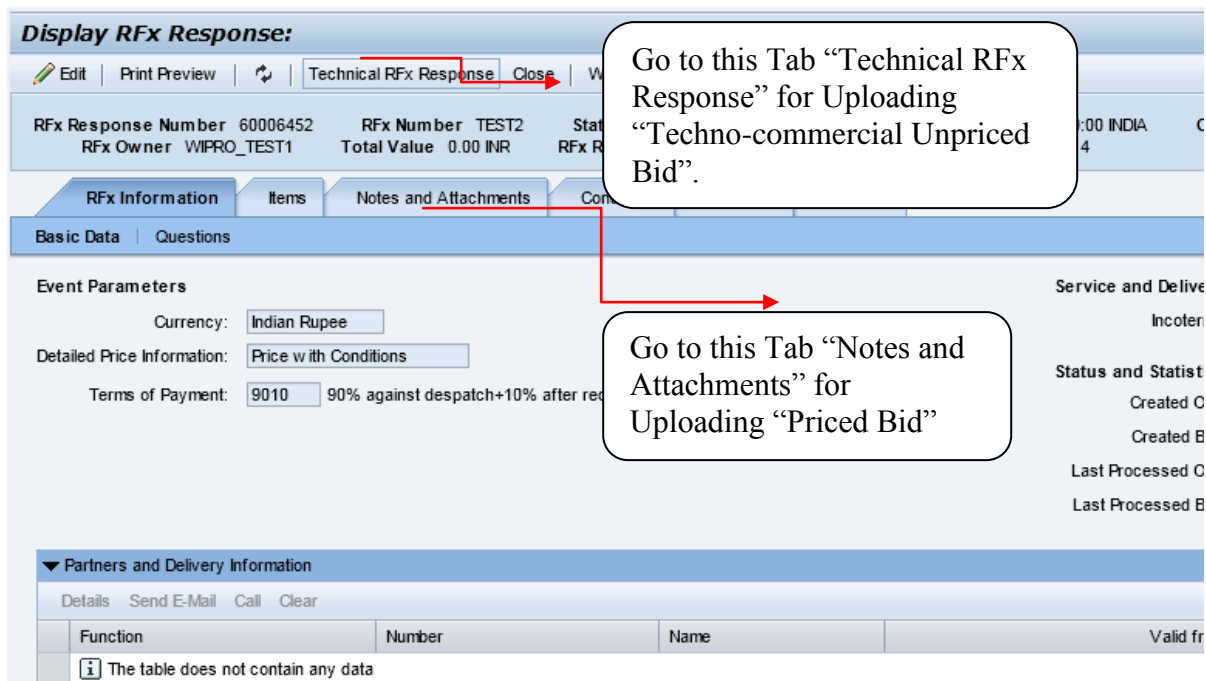

A. ITEM DESCRIPTION:

Conventional double tube, swivel type core barrel designed to provide maximum core recovery in all types of formation with the following specification:

6.3/4" [171.45mm] X 4" [101.60mm] X 60 ft [18288mm] (Two number of Core barrel each of 30 feet length). Baker Hughes Inteq 250P or Equivalent conventional high torque core barrel with 4.1/2" [114.30mm] API IF [NC-50] RH box top outer tube connection complete with accessories suitable for 8.1/2" hole, consisting of the following:

2. Swivel assembly

2. Bidders shall furnish a recommended 3 years operational spares list. Unit price to be indicated in their priced bid which will not be considered for evaluation purpose.
3. Bidder must forward relevant original company catalogues, literatures, drawings, technical specifications, assembling and running procedure of quoted core barrel etc. along with the offer.
4. Bidder should indicate the name of manufacturer and country of origin.

11. All of the items will be procured from the same source.

BID REJECTION CRITERIA(BRC)/BID EVALUATION CRITERIA(BEC)

BID REJECTION CRITERIA/BID EVALUATION CRITERIA

The bids shall conform generally to the specifications and terms and conditions lay out in the tender. Bids shall be rejected in case the goods offered do not conform to the required minimum / maximum parameters stipulated in the technical specifications and to the respective international / national standards wherever stipulated. Notwithstanding the general conformity of the bids to the stipulated specifications and terms and conditions, the following requirements will have to be particularly met by the bids, without which, the same shall be considered as non-responsive and stand rejected.

A. BID REJECTION CRITERIA (BRC) - TECHNICAL:

1. The Original Equipment Manufacturers (OEM) must enclose copies of valid API Spec 7-1 certificates and also for the last 5(Five) years (i.e. continuous without having any break in between), preceding from the original bid closing date along with the offer.
2. In case the Original Equipment Manufacturers (OEM) authorizes their approved distributor / authorized agent / sole selling agent to submit the bid, then the offer should be accompanied with relevant authorization certificate without which the offer will be rejected. Moreover the OEM should confirm that the responsibilities for warranty and supply of spares, as mentioned elsewhere in the tender, shall lie on them.
 - 2.1 The Original Equipment Manufacturers (OEM) can authorize only one distributor / authorized agent / sole selling agent to submit the bid.
 - 2.2 In case the Original Equipment Manufacturers (OEM) authorizes more than one distributor / authorized agent / sole selling agent to submit the bid, all the offers received from his approved distributors / authorized agents / sole selling agents will be rejected.
3. The Original Equipment Manufacturers (OEM) must guarantee uninterrupted supply of spares and availability of service for at least 10 years with effect from delivery of the Item / product for the item / product to be supplied under the Tender / Order, if order is awarded to them by OIL.

B. COMMERCIAL:

1.0 COMMERCIAL:

- 1.0 Bids are invited under Single Stage Two Bid System. Bidders shall quote accordingly under Single Stage Two Bid System. Bidder to note that no price details should be furnished in the Technical (i.e. Unpriced) bid. The “Unpriced Bid” shall contain all techno-commercial details except the prices which shall be kept

blank. The “Priced Bid” must contain the price schedule and the bidder’s commercial terms and conditions. Bidder not complying with above submission procedure will be rejected.

- 2.0 **Bid security of US\$ 7800.00 or Rs. 5,25,880.00 shall be furnished as a part of the TECHNICAL BID.** Any bid not accompanied by a proper bid security in ORIGINAL will be rejected without any further consideration. For exemption for submission of Bid Security, please refer Clause No. 9.8 (Section A) of General Terms and Conditions for Global Tender. **The Bid Security shall be valid up to 24/12/2016. Bid shall be rejected straightway if Original Bid Security is not received within the Bid Closing Date & time mentioned in the Tender and/or Bid Security validity is shorter than the validity indicated in Tender and/or Bid Security amount is lesser than the amount indicated in the Tender.**
- 4.0 Successful bidder will be required to furnish a Performance Bank Guarantee @10% of the order value. The validity of Performance Security should be for a period of 12 months from the date of commissioning or 18 months from the date of dispatch/shipment, whichever concludes earlier. Bidder must confirm the same in their Technical Bid. Offers not complying with this clause will be rejected.
- 5.0 The prices offered will have to be firm through delivery and not subject to variation on any account. A bid submitted with an adjustable price will be treated as non-responsive and rejected.
- 6.0 **Validity of the bid shall be minimum 120 days from the Bid Closing date. Bids with lesser validity will be rejected.**
- 7.0 Bids received after the bid closing date and time will be rejected. Similarly, modifications to bids received after the bid closing date & time will not be considered.
- 8.0 Bidders shall quote directly and not through Agents in India. Offers made by Indian Agents on behalf of their foreign principals will be rejected. Similarly offers from unsolicited bidders will be rejected.
- 9.0 Bids containing incorrect statement will be rejected.
- 10.0 Offers should be submitted with Integrity Pact duly signed by the authorized signatory of the bidder. If any bidder refuses to sign Integrity Pact or declined to submit Integrity Pact with the offer, their bid shall be rejected straightway.
- 11.0 No offers should be sent by Telex, Cable, E-mail or Fax. Such offers will not be accepted.

The Tools covered under this tender will be used by OIL in the PEL/ML areas issued/renewed after 01/04/99, applicable Customs Duty for import of goods shall be ZERO. Indigenous bidders shall be eligible for Deemed Export and should quote Deemed Export prices. Excise Duty under Deemed Export exempted. Necessary Project Authority Certificate (PAC) shall be issued by OIL towards this.

Bid Evaluation Criteria:

The bids conforming to the specifications, terms and conditions stipulated in the enquiry and considered to be responsive after subjecting to the Bid Rejection Criteria will be considered for further evaluation as per the Bid Evaluation Criteria given below:

COMMERCIAL:

- 1.0 The evaluation of bids will be done as per the Commercial Bid Format (SUMMARY) detailed vide Para 12.0 of BRC.
- 2.0 If there is any discrepancy between the unit price and the total price, the unit price will prevail and the total price shall be corrected. Similarly, if there is any

discrepancy between words and figure, the amounts in words shall prevail and will be adopted for evaluation.

- 3.0 For conversion of foreign currency into Indian currency, B.C. selling (Market) rate declared by State Bank of India, one day prior to the date of price bid opening shall be considered. However, if the time lag between the opening of the bids and final decision exceed 3(three) months, then B.C. Selling(Market) rate of exchange declared by SBI on the date prior to the date of final decision shall be adopted for conversion and evaluation.
- 4.0 Offers not complying with the payment terms indicated in the enquiry shall be loaded with one percent above the prevailing Bank rate (CC rate) of State Bank of India for duration of commissioning time indicated in the tender plus transit time (3 months) for evaluation purpose.
- 5.0 To ascertain the inter-se-ranking, the comparison of the responsive bids will be made as under, subject to corrections / adjustments given herein.

5.1 **When only foreign bidders are involved:**

Comparison of bids will be done on the basis of "GRAND TOTAL VALUE" which is estimated as under:

Banking charge in the country of the foreign bidder shall be borne by the bidder.

5.2 When only domestic bidders are involved or when more than one domestic bidders are in contention in case of mixed response:

5.3 **When both foreign and domestic bidders are involved:**

The Grand Total Value of domestic bidder (inclusive of customs duty on imported raw material and components etc. and applicable terminal excise duty on the finished products and Sales Tax) excluding inland transportation to destination, Assam Entry Tax and Insurance charges worked out as per Para 5.2 above and Grand Total Value of the foreign bidder worked out as per Para 5.1 above will be compared. No price preference will be allowed to indigenous bidders except that for capital goods, the domestic manufacturers would be accorded a price preference to offset CST to the extent of 4% or actuals, whichever is less subject to 30% local content norms as stipulated for World Bank Funded project to the satisfaction of OIL. When more than one domestic bidders fall within price preference range, inter-se-ranking will be done on Total value basis.

Note: If the Government of India revises these evaluation criteria the same as applicable on the bid closing date will be adopted for evaluation of the offers.

- 6.0 Other terms and conditions of the enquiry shall be as per General Terms and Conditions for Global Tender. However, if any of the Clauses of the Bid Rejection Criteria / Bid Evaluation Criteria (BEC / BRC) mentioned here contradict the Clauses in the General Terms & Conditions of Global Tender of the tender and/or elsewhere, those mentioned in this BEC / BRC shall prevail.
