1. The items shall be brand new, unused & of prime quality. Bidder shall warrant (in the

event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18 months from date of receipt or 12 months from date of successful commissioning of the items at site whichever is earlier. The defective materials, if any, rejected by us shall be replaced by the supplier at their own expense. Bidders must confirm the same while quoting.

2. The overshot along with all the components should be suitable for fishing operation with all types of drilling and work-over fluids.

3. The bidder should forward Operation, service & maintenance manual (indicating assembling & disassembling procedures, drawing and spare parts book having illustrated drawings and exploded views of the items with part no). One set must be forwarded with the quotation and three sets with the consignment.

4. The bidder should forward a list of recommended spares for two years operation indicating year wise requirement with breakup of such spares indicating price and part no of each & every item. However the cost of these spares will not be considered for bid evaluation purpose.

5. All parts should be suitably marked for identification purpose. Additionally P.O. No. should be die stamped on the body of the overshot (in the event of order).

6. The item should be suitably coated with a protective coating both internally & externally to prevent corrosion and rusting during transit.

7. Threading and gauging of the rotary shoulder connections of overshot should be as per API Spec.7-1 [latest edition]. Valid API Spec. 7-1 certificate should be forwarded with the bid.

8. Bidder must sign & submit the technical check list enclosed with this tender.

9. Bidder must indicate the name of manufacturer & country of origin.

10. In case bidder is not the Original Equipment Manufacturer (OEM), proper authorization certificate is required with back-up warranty & guarantee from OEM to quote against this tender, failing which offer will be rejected.

11. All the item will be procured from the same source and the bidder is to quote for all the items with accessories.

12. The bidder must specify the offered item in details & should forward relevant product catalogue with drawing & literature of the offered item.
