1.0 This Amendment no. 3 dated 06.02.2017 to tender no. SGI3628P17 for Primavera Software is issued for amendment as under–

**(i) Item Descriptions (Page 1) of the tender amended as under -**

**(ii) Clause no. 1.1, 1.3, 1.6, 1.8, 1.9, 1.10 and 1.11 under Annexure – AA amended as under –**

1.1 License shall be for **8(eight)** users including Annual Technical Support (Software update and Product support) for 1(one) year.

1.3 Package should include setting up of an Application Server with license for **8(eight)** users (Installation of Primavera Client on 8 (eight) users machine - 2 at Guwahati, 2 at Noida and **4 at Duliajan**).

1.6 The software is to be installed at **OIL, Pipeline Headquarters, Guwahati**.

1.8 Training (Fundamental + Advance) shall be provided at the following locations -

- 1) Oil India Limited, Pipeline Headquarters, Narangi, Guwahati
- 2) Oil India Limited, Corporate Office, NOIDA
- 3) **Oil India Limited, Field Headquarters, Duliajan**

1.9 Following line amended under the clause -

Training duration will be for 5 days each at Guwahati, NOIDA and **Duliajan office (total 15 days)** - 8 hrs/day.

1.10 Bidder should quote for Annual Technical Support Services for 3(Three) years **(year wise) – Offshore Model** which shall start after expiry of 1st year of Annual Technical Service. **Same shall be considered for evaluation.**

1.10.1 Bidder should also quote per diem rate for visits for onsite technical support which shall be applicable for minimum three years from the date of expiry of 1<sup>st</sup> year of Annual Technical service. All travel and stay charges as required shall be borne by the bidder. **Same shall not be considered for evaluation. (New Clause added)**

1.11 **Payment Terms:** Payment shall be released as under -

- a) 50% against supply of Software.
- b) 30% against supply of hardware, installation and commissioning of the whole system.
- c) 20% against submission of hard copy of the license for operating the software.

**Payment for Annual Technical Support Services for 3(three) years - Offshore Model shall be released against each service and submission of bill in the event OIL enters into contract for the same. (New Clause added)**

(iii) **New Clause no. 1.12 has been added under Annexure - AA as under –**

Oil may enter into Annual Technical Support Services for 3(three) years as per the quoted rates. A Separate Contract shall be signed for the same. However, the bidder has to provide PBG for 10% of the Annual Technical Support Services Contract value with validity upto 3(three) months beyond the expiry of the contract.

(iv) **Clause no. (A) 1.1 under Annexure – AA (BID REJECTION CRITERIA & BID EVALUATION CRITERIA) amended as under –**

**1.1** The bidder should have a minimum experience of supplying and installing at least **2(Two)** user of Primavera software in any firm or organization in last five (05) years.

(v) **Clause no. (B) 1.0 under Annexure – AA (BID REJECTION CRITERIA & BID EVALUATION CRITERIA) amended as under –**

**1.0** Annual Financial Turnover of the bidder during any of preceding three financial/accounting years from the original bid closing date should be at least **INR 11,77,500.00.**

(vi) **Clause no. (C) 2.0 under Annexure – AA (BID REJECTION CRITERIA & BID EVALUATION CRITERIA) amended as under –**

**2.0** **Bid security of INR 47,100.00 shall be furnished as a part of the bid.** Any bid not accompanied by a proper bid security in ORIGINAL will be rejected without any further consideration. For exemption for submission of Bid Security, please refer Clause No. 8.8 of General Terms and Conditions vide MM/LOCAL/E-01/2005 for E-Procurement LCB Tenders. **The Bid Security shall be valid till 15.08.2017.**

- (vii) Clause no. (C) 10.0 under Annexure – BB (BID REJECTION CRITERIA & BID EVALUATION CRITERIA) amended -
