1. BEC Clause No. 2.2.1 (ii), Page – 28 of the Tender Document, is being amended as –

The Bidder should be an independent developer / service provider of 'AI Based Reservoir Modeling Software and associated Services' in Domain of E&P Oil & Gas Industry since last 3 years.

In this regard the bidder must submit contract document showing details of work and the contract document should be more than 3 years old from the bid closing date.

- 2. BEC Clause No. 2.2.1 (iii), Page 28 of the Tender Document, is being deleted.
- 3. BEC Clause No. 2.2.1 (iv), Page 28 of the Tender Document, is being amended as –

The bidder should have authored/co-authored at least (three) 03 peer reviewed papers and journal publications in reputed industry publications related to AI-Reservoir Modeling over the last seven (7) years prior to original Bid closing date.

4. BEC Clause No. 2.2.3 (i), Page - 30 of the Tender Document, is being amended as -

The primary bidder shall have experience in supporting the creation of AI Based reservoir predictive models or conventional reservoir model for at least (one) 01 full field dynamic reservoir simulation model over the last 7 years.

In this regard the primary bidder must submit contract documents showing details of work and a job completion certificate showing work order number / contract no, nature of job done and date of completion.

5. New BEC Clause No. 2.2.3 (v) is being added as -

The Technical Collaborator / Joint Venture Partner should collaborate with only one Primary bidder for this tender. Multiple bid submissions

by Primary bidder or Technical Collaborator / Joint Venture Partner may result in the rejection of their bids.

6. SOW Clause No. 2.2.1 I (1), Page – 110 of the Tender Document, is being amended as –

BIDDER should propose a solution that is ready to be deployed on public cloud. As per the MEITY guidelines, proposed CSP (Cloud Service Provider) should be from the selected empaneled major cloud service providers by MEITY (Ministry of Electronics and Information Technology). In this regard the bidder needs to submit the MeITY empanelment certificate of the proposed CSP and PROFORMA-XXIV along with the technical bid.

- 7. SOW Clause No. 2.2.1 I (5), Page 111 of the Tender Document, is being deleted.
- 8. SOW Clause No. 2.2.2 J (2), Page 112 of the Tender Document, is being deleted.
- 9. SOW Clause No. 5 Special Terms and Conditions (Other Condition), Page 129 of the Tender Document, is being amended as –

The Bidder will assign a Reservoir Champion with single point responsibility for the entire project cycle. In case of the bidder is participating in a technical collaboration or Joint Venture with another party, the Reservoir Champion needs to be assigned by the technical collaborator or the Joint Venture Partner.

Any issue regarding the project design or implementation related issues shall be addressed by this Reservoir Champion.

10. New Clause is being incorporated in the Table B of SCC of Tender Document as Clause No. 10 as follows –

OIL will honour the terms of contract related to Intellectual Property rights of Software provided. Detailed terms related to Proprietary Rights, Patents, Copyrights, Confidentiality, Indemnity, Software Licensing and Usage, etc. will be mutually agreed upon by OIL and the successful bidder. Such terms will be incorporated in the agreement after placement of LOA on the successful bidder.

11. PROFORMA-XXIV is being incorporated with the Tender Document as per format attached along with this Corrigendum.

All others terms and conditions of the Bid Document remain unchanged.
