

- 1. Each Party agree to co-operate in good faith and commit to the provision of capable and adequate resources as required for the execution of the individual scope of work as provided in 'Annexure-A' hereto, should a contract be awarded to "....." (Bidder).
- 2. This Agreement is applicable to the PROJECT and shall be binding on the parties for the entire contract period in case of PROJECT award. Notwithstanding the Agreement, the responsibility of completion of PROJECT under the contract will be with the Bidder.
