- i) Parking Charges, toll charges etc. will be reimbursed at actual against documentary evidence.
- ii) The rates mentioned above is inclusive of all tax liabilities excluding GST.
- iii) **Adjustment of Rates due to Change in Fuel Price:** The Rates shall remain firm throughout the duration of the Contract. However, in the event of any change in Petrol/Diesel price **Kolkata** during the currency of the contract, per KM rates in the contract shall be adjusted (increased/decreased) by 0.3% (zero point three percent) for every 1% (one percent) of increase or decrease of fuel price at **Kolkata**. The base rates of fuel for this purchase will be the rates prevailing at **Kolkata** on the date of Bid Obening, i.e., 05.09.2017. The quoted hourly rate would remain constant/unchanged during the tenure of the contract.
