CORRIGENDUM NO. 1 TO IFB NO. DCT6631P22

This Corrigendum against Tender No. DCT6631P22 for "Hiring the services of 44(forty four) Nos. readily available 24/28 seater fully built diesel buses is issued to notify the following amendments:

1.0 **Clause 3.0** of the COVERING LETTER / INSTRUCTION TO BIDDERS (ITB) has been amended as below in place of the existing:

3.0 BID SUBMISSION:

- 3.1 The applicants will have to submit the following documents:
 - (i) Duly filled up Application Format (Annexure-I) in duplicate.
 - (ii) Duly filled up Format for Bidder details (Annexure-II)
 - (iii) Court Affidavit in original as per Format (Annexure-III)
 - (iv) Court Affidavit in original as per Format (Annexure-IV), if applicable.
 - (v) Bid Security declaration as per Format (Annexure-V).
 - (vi) Self-attested photocopies/copies of
 - a) Valid Registration Certificates.
 - b) Latest Road Tax Payment Certificates.
 - (vii) Required documents as per clause 11.1
 - (viii) Any other document as per terms of the Tender.

The applicants/contractors shall have to submit the up-to-date Insurance, Fitness, Pollution, Road Tax Certificates, and Road Permit, on or before placement of the vehicle. Without the above up to date documents the Contractor(s) will not be allowed to place the vehicle(s) and the LOA(s) issued/ Contract(s) awarded shall stand terminated without any notice. Also, vehicles will not be placed on Company's duty in case any discrepancy is found during inspection and the LOA(s) issued/ Contract(s) awarded shall stand terminated without any notice.

2.0 Clause **11.0** has been amended to insert the following in addition to the existing.

11.0 BID REJECTION CRITERIA (BRC):

11.1 TECHNICAL CRITERIA:

The bidder shall have experience of 01 (one) SIMILAR work of minimum **Rs. 15.93** lakhs (Rupees Fifteen Lakhs Ninety Three Thousand Only) in Public Sector Undertaking (PSU) / Central Government Organization / State Government Organization/ Government Corporations in previous 07 (seven) years to be reckoned from the original bid closing date i.e. within the period **24/04/2014** to **23/04/2021**(both day inclusive).

Documentary evidence must be submitted along with the Techno-Commercial Bid. The documentary evidence must be in the form of Job Completion Certificate / Gross Payment Certificate / Work Execution Certificate etc. as applicable showing:

- (a) Gross value of job done; and
- (b) Nature of job done; and
- (c) Time period covering as per the NIT.

Only Letter of Intent (LOI) / Letter of Award (LOA) / Contract(s)/ Work Order(s) and/ or Service Entry Sheet (SES) are not acceptable as evidence. However, if Letter of Intent (LOI) / Contract(s)/Work Order(s) and/ or Service Entry Sheet (SES) are issued from OIL, then the same will be considered as evidence subject to successful verification with OIL's own records of execution.

Notes to clause 11.1

- (i) "Similar Work" means- Services involving Light Passenger Vehicles / Buses/Heavy Vehicles/ Logistic Equipment's or any other Transport Services.
- (ii) The bidder must have experience of providing similar services to Public Sector Undertaking (PSU) / Central Government Organization / State Government Organization/Government Corporations for any length of time during the last 07(seven) years ending on 23/04/2021(Original Bid Closing Date) i.e. for any length of time within the period 24/04/2014 to 23/04/2021(both day inclusive). During this period of 07(seven) years, bidder must have successfully carried out one similar work of minimum Rs. 15.93 lakhs. Accordingly, the Starting Date and/or the Job Completion Date of the work need not necessarily fall within the seven years period of 24/04/2014 to 23/04/2021; but the value of work done must be of requisite amount within the period.
- (iii) Bidder(s) executing similar nature of work which is still running will also be taken into consideration if the bidder(s) meets the prescribed value within the period as mentioned above (i.e 24/04/2014 to 23/04/2021) in one similar work.
- (iv) Similar work executed by a bidder for its own organization/subsidiary shall not be considered as experience for the purpose of meeting the experience.
- 3.0 With this amendment, all the clauses from (a) to (m), existing under Clause 11.0 will, now, appear under clause 11.2 of the COVERING LETTER / INSTRUCTION TO BIDDERS (ITB) of the Tender.
- 4.0 All other Terms and Conditions of the Original Tender/Bid Document (Considering all previous Amendments if any) shall remain unchanged.
