The installation shall have at least 02 (two) nos. of Gas Compressor Packages out of which at least one compressor package must be of following specification:
 - (i) Type: Reciprocating balanced opposed 2 throw
 - (ii) Flow: 2700 NM3 per hour or above
 - (iii) Prime Mover: Engine Driven
 - (iv) Engine Rating: 500 KW or above

- **II.** Experience in Operation and Maintenance of Natural Gas Compressor packages having PLC based instrumentation and control system under single contract. The experience must satisfy all the criteria as required under clause no. 1.2 above. The experience shall include at least 02 (two) nos. of Gas Compressor Packages either in one installation or multiple installations, out of which at least one compressor package must be of the following specifications:
 - i) Type: Reciprocating balanced opposed 2 throw
 - ii) Flow: 2700 NM3/Hr or above
 - iii) Prime Mover: Engine Driven
 - iv) Engine Rating: 500 KW or above

Additionally, the bidder shall also have experience in Operation and Maintenance of other process utilities, such as Electric motors, Generators, UPS, Pumps, Diesel Engines, firefighting systems, etc. in any contract, executed in Central Govt./State Govt./Public Sector Undertaking/State Govt. Enterprise/any E&P Company.
