3. Additional clauses incorporated in SCC Part III under heading “Oracle Technical Support Licenses for the following product for three years from 16.09.2017 to 15.09.2020” as detailed in Annexure – II.
4. Tender document sale date extended upto 12.06.2017. Revised Bid Opening Date: 13.06.2017 (14:00 Hrs)

All others terms and conditions of the Bid Document remain unchanged.

**A. Bid Evaluation Criteria:**

The bid shall conform to the specifications and terms and conditions given in the Bidding Documents. Bids will be rejected in case material and services offered do not conform to the required parameters stipulated in the technical specifications. Notwithstanding the general conformity of the bid to the stipulated specifications, the following requirements will have to be particularly met by the Bidders without which the same will be considered as non-responsive and will not be considered for evaluation. All the documents related to BEC shall be submitted along with the Technical Bid.

**(i) Technical Criteria:**

1. Bidder must have experience of at least one SIMILAR work of minimum **Rs22,86,000.00 (Rupees Twenty-Two Lakhs and Eighty-Six Thousand only)** in previous 7 (seven) years reckoned from the original bid closing date.

Note: “The similar works or similar nature of job is defined as Annual Technical Support for Oracle Database 11g and above.

2. For proof of requisite experience of **SIMILAR work, self-attested** photocopies of following documents must be submitted along with the bid:

Contract documents / Work Order showing details of works supported with Completion Certificate issued by PSUs / Govt. organisation / Public Limited Company for the *similar work* mentioned BEC Clause (i) Technical Criteria: 1 above confirming the following:

- a. Contract number,
- b. Gross value of job done,
- c. Contract period / Contract start and completion date.

3. The Bidder has to be Oracle Corporation, USA or Oracle (India) Private Limited (Oracle) / Joint Venture of Oracle / Subsidiary of Oracle/ Authorized partner of Oracle / Business Partner of Oracle. Joint Venture companies, subsidiaries and authorized partners must submit documentary evidence to this effect and authorization letter from Oracle to quote for this Enquiry, failing which, their offer will be rejected.
4. SIMILAR work executed by a bidder for its own organization / subsidiary will not be considered as experience for the purpose of meeting BEC.
5. If the prospective bidder is executing SIMILAR work which is still running and the contract value executed prior to due date of bid submission is equal to or more than the minimum prescribed value in the BEC such experience will also be taken in to consideration provided that the bidder has submitted last certificate of payment along with Contract Agreement / Work order showing details of work of the running contract.
