(c) If the application is not accompanied by a copy of valid employment exchange card from Exploration & Production (E&P) area of OIL **or if the applicant(s) fails to submit the above mentioned copy of valid employment exchange card within the stipulated time, as per declaration given by him/her as per Annexure –I,**
