BID REJECTION CRITERIA (BRC)

[1] Financial capability: Bidders must have

Average Annual financial turnover as per Audited Annual Reports for the last three accounting years should be at least Rs.5,31,000/-.

For Proof of Annual Turnover any of the following documents /photocopy must be furnished:

- A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
- Audited Balance Sheet and Profit & Loss account.

[2] Experience: Bidders must have;

Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the followings:

2.1 Three similar completed works each costing not less than **Rs7,08,000./-**

Or

- 2.2 Two similar completed works each costing not less than **Rs.**8,85,000/-
- 2.3 One similar completed works each costing not less than **Rs.14,16,000/-**

Similar work means:

i. Major Overhauling anid Commissioning of reciprocating I.C. engine of minimum 400 BHP or plunger type reciprocating high pressure pump requiring minmum 400 BHP input power in PSU or other Central/State Government Organization.

- [3] For proof of experience, the following document must be submitted along with the bid:
- 3.1 In case of OIL contractor, copy of certificate of completion (COC)/Work Order showing gross value of job. It may be clearly noted that simply mentioning of OIL COC/WO no. will not be accepted.
