#### [2] Experience: Bidders must have;

Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the followings:

2.1 Three similar completed works each costing not less than **Rs 2,64,200./-**

2.2 Two similar completed works each costing not less than **Rs.3,30,300/-**
