BID REJECTION CRITERIA (BRC)

[1] Financial capability: Bidders must have

Average Annual financial turnover as per Audited Annual Reports for the last three accounting years ending March, 2014 should be at least ₹ 76,800.00

For Proof of Annual Turnover any of the following documents /photocopy must be furnished

- A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
- Audited Balance Sheet and Profit & Loss account.

[2] Experience: Bidders must have;

- 2.1 Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:
 - i) Three similar completed works each costing not less than ₹ 1,02,400.00 Or
 - ii) Two similar completed works each costing not less than ₹ 1,28,000.00 Or
 - iii) One similar completed works each costing not less than ₹ 2,04,800.00

(Similar works means supply Providing the Manpower Services.)

[3] For proof of experience, the following document must be submitted along with the bid:

- 3.1 In case of OIL contractor, copy of certificate of completion (COC)/Work Order showing gross value of job. It may be clearly noted that simply mentioning of OIL COC/WO no. will not be accepted.
- 3.2 Certificate issued by any other firms of repute within last three years experience from the date of opening the bid, showing:
 - a) Gross Value of Job done;
 - b) Nature of job done; and
 - c) Time period covering the financial year(s) as per NIT.

However, the originals of these documents shall have to be produced by the bidder, as and when asked for.

[4] EVALUATION OF BIDS:
