Documentary evidence must be submitted along with the Un-Priced Techno-Commercial Bid. The proof of annual turnover should be either in the form of audited Profit & Loss account and Balance Sheet or certification from Chartered / Cost Accountant firm indicating the Firm registration no. and Membership no.

- 4.2 The bidder shall be in the business of providing similar services to Public Sector Undertaking (PSU) / Central Government / State Government Organization/ Corporations having the experience of successfully executing the following assigned SIMILAR work(s) during the last 7(seven) years ending on 29.02.2016:
- (a) Single contract of minimum value of Rs. 149 Lakh (Rupees One Hundred and Forty Nine Lakh)

6.0 Exemption of Tender Fee:

If the bidder is a Micro or Small Enterprise under the Micro, Small and Medium Enterprises Development Act, 2006 and is registered with District Industries Centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by Ministry of Micro, Small and Medium Enterprises, then they are exempted from payment of tender fees for the items/services for which they are registered.
