On receipt of requisite Bid Document Cost, USER_ID and initial PASSWORD will be communicated to the bidder (through e-mail) to the address given in the application and will be allowed to participate in the bidding through OIL's E-Procurement portal. Bidders, who have not participated in OIL e-tender earlier, should mention as “New Bidder” in the application form. For bidders who have already participated in OIL e-Tender, user name & password will remain same and no new password will be issued. Bidders having OIL's vendor code must have to mention their vendor code in the application form. Bidders have to register their name in e-portal against their interested bid for allowing them to participate.

PSUs and SSI units registered with NSIC claiming exemption from payment of tender fee should submit their request with all credentials at least 7 days in advance to get access for participation in the tender.
