



- (ii) Complete technical details / specifications of the equipment with catalogue, etc. as per tender requirement.
- (iii) Documentary evidence established in accordance with BRC / BEC part.
- (iv) Statement of Non-Compliance (if any).
- (v) Bid Security (scanned copy). Hard copy of original Bid Security (Only in case of bidder(s) submitting bid security in the form of Bank Draft / Banker's Cheque/ Bank Guarantee) should be sent separately to reach on or before 12.45 Hrs (IST) on the bid closing date failing which the bid shall be rejected.

responsive bids. OIL's determination of bid's responsiveness is to be based on the contents of the Bid itself without recourse to extrinsic evidence.

- 13.7 A Bid determined as not substantially responsive will be rejected by the Company and may not subsequently be made responsive by the Bidder by correction of the non-conformity.

- d) Issue to the Contractor from time to time during the progress of the work such further drawings and instructions as shall be necessary for the purpose of proper and adequate execution and maintenance of the works and the Contractor shall carry out and be bound by the same.
- e) Order deviations in Part II and III of this Contract. All such deviation orders shall be in writing and shall show the financial effect, if any, of such deviation and whether any extra time is to be allowed.
- 4. The Contractor shall have no claim against the company in respect of any work which may be withdrawn but only for work actually completed under this contract. The contractor shall have no objection to carry out work in excess of the quantities stipulated in Part-II if so ordered by the company at the same rates, terms and conditions.
- 5. The Company reserves the right to cancel this Contract at any time upon full payment of work done and the value of the materials collected by the contractor for permanent incorporation in the work under this contract particularly for execution of this contract up to the date of cancellation of the Contract. The valuation of the work done and the materials collected shall be estimated by the company's Engineer in presence of the contractor. The Contractor shall have no claim to any further payment whatsoever. The valuation would be carried out exparte if Contractor fails to turn up despite reasonable notice which will be binding on the Contractor.
- 6. The Contractor hereby undertakes to indemnify the Company against all claims which may arise under the under noted Acts:
 - i) The Mines Act.
 - ii) The Minimum Wages Act, 1948.
 - iii) The Workman's Compensation Act, 1923.
 - iv) The Payment of wages Act, 1963.
 - v) The Payment of Bonus Act, 1965.
 - vi) The Contract Labour (Regulation & Abolition) Act, 1970 and the rules framed there under.
 - vii) Employees Pension Scheme, 1995.
 - viii) Inter-State Migrant (Regulation of Employment and Condition of Service) Act. 1979.
 - ix) The Employees Provident Fund and Miscellaneous Provisions Act, 1952.
 - x) AGST Act.
 - xi) Service Tax Act.

or any other Acts or Statute not here in above specifically mentioned having bearing over engagement of workers directly or indirectly for execution of work. The Contractor shall not make the Company liable to reimburse the Contractor for the statutory increase in the wage rates of the Contract Labour appointed by the Contractor. Such Statutory increase in the wage rates of Contract Labour shall be borne by the contractor.

- 7. The Contractor shall clear away all rubbish and surplus material from the site on completion of work and shall leave the site clean and tidy.
- 8. The duration of the contract shall be **156 weeks** from the date of issue of Letter of Award. On account payment may be made, not often than monthly, up to the amount of 100% of the value of work done. Final payment will be made only after satisfactory completion of the work. Such final payment shall be based on the work actually done allowing for deviations and any deductions and the measurement shall be checked and certified correct by the Company's Engineer before any such final payment is made.

- 11. However, Service Tax portion payable directly by the Service Provider (if applicable) shall be reimbursed to the Contractor on the basis of the documentary evidence.
- 2. Contractors are required to raise monthly Service Tax Invoices for reimbursement of Service Tax against the contract. In absence of Service Tax Invoices, Service Tax will not be reimbursed and the consequences of the same shall entirely rest upon the Contractor.
- 3. The rates shall be quoted per unit as specified in the "PRICE BIDDING FORMAT" attached under "Notes and Attachments" tab. Bidder should note that no pricing information is furnished in the "c-folder" (Un-priced Techno-Commercial Bid) otherwise the bid will be rejected.
- 4. Mobilisation Period: 30(Thirty) days from the date of issue of Letter of Award.
- 5. Tenure of Agreement: 3(Three) years from the date of issue of Letter of Award.
- 6. The quantities mentioned above are purely for evaluation purpose only. However, payment shall be made as per actuals.

OIL INDIA LIMITED (A Govt. of India Enterprise) DULIAJAN (ASSAM)

1.0 WORK ORDER:

- i) Soon after this contract is signed by both the parties i.e. the Contractor and the Company, the contractor will apply for labour clearance within 7 days from the date of signing of the contract to the competent authority and on receipt of same the Company shall issue Work Order/ Purchase Order, specifying the actual date of commencement of the works/ service and the date of its completion based on the contract provisions.
- ii) During the execution of the works, the Contractor must maintain a uniform rate of progress to complete the works within the stipulated scheduled time.

2.0 COMPLETION TIME:

The contractor has to complete the job of repairing/revamping of each crew hut within 60 days from the date of handing over of the crew hut to the contractor by OIL.

3.0 CONTRACTOR'S RESPONSIBILITY:

The contractor and / or his authorised representative/ supervisor must have sufficient practical knowledge of the job and must know about tools/ tackles & equipment required for the job & also safety of the operations. The contractor must meet the following requirement.

- i) All vehicles, equipment, tools, tackles & materials etc. required for the job are to be supplied by the contractor.
- ii) The contractor should use sufficient experienced manpower to execute the crew hut repairing/revamping job in minimum three nos. of crew huts simultaneously, if required.

4.0 SCOPE OF WORK (SOW):

Works under this contract are repairing and renovation of damaged crew huts pertaining to Production (Oil) department. For repairing of crew hut the company will hand over the damaged crew huts to the contractor in phased manner which will be normally two numbers at a time. However, depending upon work exigency OIL may handover more/less than two numbers of crew hut for repairing/revamping at a time. The contractor within 15(fifteen) days from the date of issue LOA, will submit the tentative work program for execution of the contract to GMP (Oil) or his representative.

The broad scope of work against the same is as under:

- i. Transportation of damaged crew hut required for repairing & renovation to Contractors base within 50 km from Duliajan and delivery of the repaired crew hut at Duliajan
- ii. Removal of damage MS plates and CHEQURED plate and any other damaged material of the damaged crew hut.
- iii. Repairing/renovation of the damaged crew huts.
- iv. Painting and letter writing on the repaired crew huts.
- a. Transportation of damaged crew hut: The contractor will arrange for transportation of damaged crew hut required for repairing & renovation to Contractors base within 50 km from Duliajan and delivery of the repaired & renovated crew hut at Duliajan. The location for the same will be shown by OIL's representative. All the vehicles, crane and equipment required for safe transportation, loading and unloading of the crew hut are under the scope of the contractor. The contractor will be solely responsible for Safety of his/her equipment & manpower during loading/unloading/repairing/transportation of crew hut. Prior to safe transportation of the same, the representative of OIL and the contractor will inspect the extent of damage of the crew huts and will fix the probable quantity of materials required to be changed.

- b. Removal of damage MS plates and CHEQURED plate of damaged crew hut. After transportation of the crew huts to contractor's base station/ workshop, the contractor will thoroughly examine the extent of damage and will intimate the representative of OIL in writing about the same. On receipt of the same, within 5(five) days, the representative of OIL will physically verify and approve the same. The contractor will remove the damaged MS and Chequred plate of the crew only after obtaining approval from OIL's representative. New MS/ Chequred plates of thickness that of the original thickness will be placed in the said portion and the same will be fixed with welding. The MS plate used for the same should be of TATA/SAIL make. The contractor should produce the relevant documents in support of the same to the OIL's representative.
- c. Supply and fixing of wooden frame (75mm x 50mm or 75mm x 100mm) on the inner wall/roof of the crew hut. The frame should be fixed by using $\frac{1}{2}$ " dia bolt only.
- **d.** Supply of Water proof Commercial ply of thickness 12 mm and fixing of the same in the inside wall of the crew hut with proper riveting arrangement. Prior to fixing of the ply, the inner metallic surface of the huts should be painted with one coat of red oxide paint.
- **e. Hard board for ceiling:** Supply and installation of MDF hard board of thickness 8mm in the inside surface of the roof. Prior to fixing of the hard board, the inner metallic surface of the huts should be painted with one coat of red oxide paint.
- **f.** Painting of the crew hut: After repairing/renovation of the crew huts the outer surface and roof of the same is to be painted by applying two coats of enamel paints. Prior to application of enamel paint, the surface of the huts should be cleaned properly and painted with one coat of red oxide paint. The paint used for this purpose should conform to IS: 2932. The painting job is to be carried out with the help of spray painting machine only.

5.0 MEASUREMENT OF WORKS:

a) Measurement of works:

- i) The quantities detailed in this contract represent only the estimated quantities of works and they are not to be taken as the exact quantity of the works to be executed by the Contractor in fulfillment of his/her obligations under this contract. The quantities of works to be considered for purpose of payment shall be those actually executed either in accordance with the written instruction/certification of the OIL's Engineer.
- ii) In respect of works in progress, the measurement of works shall be on the basis of either a percentage of actual progress made in relation to the contract quantity of the works as assessed by the OIL's Engineer wherein applicable and at the discretion of the OIL's Engineer wherever applicable.
- iii) All measurements shall be duly recorded by the Engineer of OIL and the Contractor shall agree to such measurement by signing the same. Measurement so recorded shall be treated as legally binding on both parties.
- iv) The OIL's Engineer shall be free to reject any materials/ equipment/workmanship supplied/carried out by the Contractor if such materials/workmanship are not up to the required specifications/standard and differ from the previously approved samples for purpose of measurement.

6.0 PAYMENT TERMS:

Payment will be released against each service line items for the quantity of work completed as per certification of OIL's representative as progressive payment during the progress of the contract. However, Payments will be released only once in a month.

7.0 **RIGHT OF INSPECTION**:

OIL shall have the right but not the obligation to inspect the works during its progress. The Contractor shall provide proper access for such inspection.

8.0 PERFORMANCE GUARANTEE:

Workmanship and quality of materials supplied by the Contractor are to be guaranteed for a minimum period of twelve (12) months from the date of handing over of each renovated/repaired crew hut to OIL. The Contractor shall repair and replace any defects occurred by way of bad/poor workmanship or defective / substandard materials supplied during the guarantee period of twelve (12) months for each crew hut.

9.0 **SPECIAL CONDITION OF THE CONTRACTS:**

Bidder should submit Bank Account no, PAN, VAT, Service Tax account no. and PF code no. etc as applicable at the time of signing of the contract.

- c) Due notice would be given for any change of personnel under item(b) above.
- d) We hereby accept the responsibility for the safety of all the personnel engaged by us and for the safety of the Company's personnel and property involved during the course of our working under this contract. We would ensure that all the provisions under the Oil Mines Regulations, 1984 and other safety rules related to execution of our work would be strictly followed by our personnel. Any violation pointed out by the Company's Engineers would be rectified forthwith or the work suspended till such time the rectification is completed by us and all expenditure towards this would be on our account.
- e) We confirm that all persons engaged by us would be provided with the necessary Safety Gears at our cost.
- f) All losses caused due to inadequate safety measures or lack of supervision on our part would be fully compensated by us and the Company will not be responsible for any lapses on our part in this regard.
 - g) We shall abide by the following HSE (Health, Safety & Environmental) POINTS:

GENERAL HEALTH, SAFETY & ENVIRONMENT (HSE) POINTS:

- 1. It will be solely the Contractor's responsibility to fulfill all the legal formalities with respect to the Health, Safety and Environmental aspects of the entire job (namely; the person employed by him, the equipment, the environment, etc.) under the jurisdiction of the district of that state where it is operating. Ensure that all subcontractors hired by him comply with the same requirement as the contractor himself and shall be liable for ensuring compliance all HSE laws by the sub or sub-sub contractors.
- 2. Every person deployed by the contractor in a mine must wear safety gadgets to be provided by the contractor. The Contractor shall provide proper Personnel Protective Equipment as per the hazard identified and risk assessed for the job and conforming to statutory requirement and company PPE schedule. Safety appliances like protective footwear, Safety Helmet and Full Body harness has to be DGMS approved. Necessary supportive document shall have to be submitted as proof. However, it will be the Contractor's sole responsibility to ensure that the persons engaged by him in the mines use the proper PPE while at work. All the safety gears

mentioned above are to be provided to the working personnel before commencement of the work.

- 3. The Contractor shall prepare written Safe Operating Procedure (SOP) for the work to be carried out, including an assessment of risk, wherever possible and safe methods to deal with it/them. The SOP should clearly state the risk arising to men, machineries & material from the mining operation / operations to be done by the contractor and how it is to be managed.
- 4. The contractor shall provide a copy of the SOP to the person designated by the mine owner who shall be supervising the contractor's work.
- 5. Keep an up to date SOP and provide a copy of changes to a person designated by the Mine Owner /Agent /Manager.
- 6. Contractor has to ensure that all work is carried out in accordance with the Statute and SOP and for the purpose he may deploy adequate qualified and competent personnel for the purpose of carrying out the job in a safe manner. For work of a specified scope/nature, he should develop and provide to the mine owner a site specific code of practice in line.
- 7. All persons deployed by the contractor for working in a mine must undergo Mines Vocational Training, initial medical examination, PME. They should be issued cards stating the name of the contractor and the work and its validity period, indicating status of MVT, IME & PME.
- 8. The contractor shall submit to DGMS returns indicating Name of his firm, Registration number, Name and address of person heading the firm, Nature of work, type of deployment of work persons, Number of work persons deployed, how many work persons hold VT Certificate, how many work persons undergone IME and type of medical coverage given to the work persons.
- 9. The return shall be submitted quarterly (by 10th of April, July, October & January) for contracts of more than one year. However, for contracts of less than one year, returns shall be submitted monthly.
- 10. It will be entirely the responsibility of the Contractor/his Supervisor/representative to ensure strict adherence to all HSE measures and statutory rules during operation in OIL's installations and safety of workers engaged by him. The crew members will not refuse to follow any instruction given by company's Installation Manager / Safety Officer / Engineer / Official / Supervisor/Junior Engineer for safe operation.
- 11. Any compensation arising out of the job carried out by the Contractor whether related to pollution, Safety or Health will be paid by the contractor only.
- 12. Any compensation arising due to accident of the Contractor's personnel while carrying out the job, will be payable by the contractor.

The frequency of periodic medical examinations should be every five years for the employees below 45 years of age and every three years for employees of 45 years of age and above.
- 17. To arrange daily tool box meeting and regular site safety meetings and maintain records.

- 18. Records of daily attendance, accident report etc. are to be maintained in Form B, E, J (as per Mines Rules 1955) by the contractor.
- 19. A contractor employee must, while at work, take reasonable care for the health and safety of people who are at the employee's place of work and who may be affected by the employee's act or omissions at work.
- 20. A contractor employee must, while at work, cooperate with his or her employer or other persons so far as is necessary to enable compliance with any requirement under the act or the regulations that is imposed in the interest of health, safety and welfare of the employee or any other person.

- 25. The contractor should frame a mutually agreed bridging document between OIL & the contractor with roles and responsibilities clearly defined.
- 26. For any HSE matters not specified in the contract document, the contractor will abide the relevant and prevailing Acts/rules/regulations/ pertaining to Health, Safety and Environment.
