Documentary evidence must be submitted along with the Technical Bid.The proof of annual turnover should be in the form of audited Balance Sheet and Profit & Loss Account or certification from Chartered / Cost Accountant firm indicating the Code Number.

- **4.2**The bidder shall be in the business of providing similar services to Public Sector Undertaking(PSU) / Central Government / State Government Organization/ Corporations having the experience of successfully executing the following assigned SIMILAR work(s) during the last 7(seven) years as on the bid closing date(**07.07.2015**)
- (a) One executed work of value not less than Rs. 223.50 lakhs(Rupees Two Hundred Twenty Three Lakhs Fifty Thousand).
