Alternatively, applicants already having User ID & Password for OIL's e-portal can pay their requisite Bid Document Cost & Bid Security against the individual IFBs through the online payment gateway. No physical tender documents will be provided. On receipt of requisite Bid Document Cost, USER_ID and initial PASSWORD will be communicated to the bidder (through e-mail) to the address given in the application and will be allowed to participate in the bidding through OIL's E-Procurement portal. Bidders, who have not participated in OIL e-tender earlier, should mention as "New Bidder" in the application form. For bidders who have already participated in OIL e-Tender, user name & password will remain same and no new password will be issued. Bidders having OIL's vendor code must have to mention their vendor code in the application form. Bidders have to register their name in e-portal against their interested bid for allowing them to participate.			
For new bidders User ID and Password shall be provided by OIL within 3 to 5 days from the date of request from the bidder for online submission of Bid. Therefore bidder should not delay in making request till the last moment in their own interest. In case of delay because of late request by the bidders OIL shall not be responsible for non-submission of Bid in absence of user ID and Password.			
PSUs and SSI units registered with NSIC claiming exemption from payment of tender fee should submit their request with all credentials at least 7 days in advance to get access for participation in the tender.
