#### 5.0 GUIDELINES FOR PARTICIPATING IN OIL'S E-PROCUREMENT:

5.1 In order to bid for OIL e-tenders all the bidders are required to obtain a legally valid **Digital Certificate Class 3 [Organization]** along with Encryption Certificate as per Indian IT Act from the licensed Certifying Authorities (CA) operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India. Digital Signature Certificate comes in a pair of Signing/verification and Encryption/decryption certificate. Bidder should have both the Signing/verification and Encryption/decryption certificate for Signing and encryption, decryption purpose respectively. The driver needs to be installed once, without which the DSC will not be recognized. While participating on e-Tendering the DSC token should be connected to your system.

Encryption certificate is mandatorily required for submission of bid. In case bidder created response with one certificate (using encryption key) and bidder change his Digital Signature Certificate then old certificate (used for encryption) is required in order to decrypt his encrypted response for getting the edit mode of the response. Once decryption is done, bidder may use new DSC certificate for uploading and submission of their offer. It is the sole responsibility of the bidder to keep their DSC certificate properly. In case of loss of the certificate, OIL INDIA LTD is not responsible.

The authenticity of above digital signature shall be verified through authorized CA after bid opening. If the digital signature used for signing is not of "Class - 3" with Organizations name, the bid will be rejected.

Digital Signature Certificates having "**Organization Name**" field other than **Bidder's Name** are not acceptable. However, aforesaid Digital Signature Certificates having Bidder's Name in the "Organization Name" field are acceptable.

Bidder is responsible for ensuring the validity of digital signature and its proper usage by their employee.

The bid including all uploaded documents shall be digitally signed by duly authorized representative of the bidding company.

- 5.2 For participation, applicants already having User ID & Password for OIL's E-Procurement Portal need to register against the IFB. New vendors/existing vendors not having User ID & Password for OIL's E-Procurement Portal shall obtain User ID & password through online vendor registration system in E-Portal.
- 5.2.1 Bidders without having E-Tender Login ID and password should complete their online registration at least 07 (Seven) days prior to the scheduled Bid Closing Date and time of the

- 5.2.2 Necessary Login ID & Password will be issued by OIL only after submitting the complete online registration by the Bidder. In the event of late registration/incomplete registration by Bidder, OIL INDIA LIMITED shall not be responsible for late allotment of User ID & Password and request for bid closing date extension on that plea shall not be entertained by Company.

- 5.4 Details of process for submission of Bid Security (EMD) through the online payment gateway are available in Vendor User Manual under E-Procurement Portal. - 5.5 The link to OIL's E-Procurement portal has been provided through OIL's web site (www.oil-india.com).

#### 6.0 EXEMPTION OF BID SECURITY:

In case any bidder is exempted from paying the Bid security, they should request OIL with supporting documents. The detailed guidelines for exemption of the Bid security are given below.

- 6.1 MSEs Units (manufacturers/Service Providers only and not their dealers/ distributors) who are already registered with District Industry Centers or Khadi & Village Industries Commission or Khadi & Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts & Handloom or any other body specified by Ministry of MSME are exempted from payment of Bid Security (EMD) irrespective of monetary limit mentioned in their registration, provided they are registered for the item they intend to quote/participate..
- 6.2 Central Government Departments and Central Public Sector Undertakings (CPSUs) are also exempted from submitting bid security.
- 6.3 In case bidding MSE is owned by Schedule Caste or Schedule Tribe entrepreneur, valid documentary evidence issued by the agency who has registered the bidder as MSE owned by SC/ST entrepreneur should also be enclosed.
- 6.4 For availing benefits under Public Procurement Policy (Purchase preference & EMD exemption), the interested MSE Bidders must ensure that they are the manufacturer/ service provider of tendered item(s) and registered with the appropriate authority for the said item(s). Bids without EMD shall be rejected, if the technical offer does not include a valid copy of relevant MSE Certificate issued by appropriate authority specifying the item as per tender. Therefore, it is in the interest of such MSE Vendors to furnish a copy of complete certificate to the concerned tender handling officer of OIL at least seven (7) days prior to the scheduled Bid Closing Date of the tender; seeking clarification/confirmation as to whether their registered item is eligible for EMD exemption or not. Late communication in this regards and request for bid closing date extension on that plea shall not be entertained by Company.

#### 7.0 PRE-BID CONFERENCE:

7.1 A Pre Bid Conference is planned to be held on 20.12.2016 & 21.12.2016 at Duliajan, Assam to explain the requirements of Company in details to the interested prospective Bidders and to understand bidders' perspective including exchange of views/clarifications, if any, on the Scope of Work, Bid Rejection/Bid Evaluation Criteria and other terms & conditions of the Tender. The parties who purchase the bid documents shall be allowed to

- 7.2 Maximum two (2) representatives from each prospective Bidder, who purchased the tender document, shall be allowed to participate in the pre-bid conference. All costs associated to attend the pre-bid conference by their representatives shall be borne by the interested Bidders.
- 7.3 The prospective bidders shall submit their queries/clarifications against the tender through E mail / Fax /Courier addressed to CGM Contracts, Oil India Ltd., Duliajan-786602, Assam and such queries must reach OIL's office at Duliajan latest by 17.12.2016 up to 03:30 p.m. IST. OIL shall provide clarifications to only those queries received within this date. Queries/ Clarifications against the tender received beyond 17.12.2016 will not be entertained and replied. OIL will not be responsible for non-receipt or late receipt of any bidder's query in OIL's office
- 7.4 However, clarifications/exceptions/deviations, if required any, should be brought out by the bidder prior to or during the Pre Bid Conference only. After processing these suggestions, as a sequel to the pre-bid conference, Company may communicate the changes in this regard, if agreed any, through an addendum to tender document to the prospective bidders who purchased the tender document. Company will not accept any exception/deviation to tender conditions/specifications once the same are frozen after the pre-bid conference and the non-compliant bid (s) shall be rejected outright against this tender.

#### **IMPORTANT NOTES:**

Bidders shall take note of the following important points while participating in OIL's e-procurement tender:

i) The bid along with all supporting documents must be submitted through OIL's e-procurement site only except 'Original Bid Security' (if submitted in the form of BG) which shall be submitted manually by the bidder in a sealed envelope super-scribed with OIL's IFB No./E-Tender No., Bid Closing date and marked as "Original Bid Security" and addressed to CGM-Contracts, Contracts Department, Oil India Limited, Duliajan-786602, Assam (India), failing which the bid shall be rejected.

- iii) If the digital signature used for signing is not of "Class 3" with Organizations name, the bid will be rejected.
- iv) The Company reserves the right to reject any or all the tenders or accept any tender without assigning any reason.

- v) (a) No Bidder can withdraw his bid within the validity or extended validity of the bid. Withdrawal of any bid within validity period will lead to forfeiture of his / her / their Bid Security Deposit in full and debar from participation in future tenders, at the sole discretion of the company
  - (b) Once a bid is withdrawn, the offer will be treated as withdrawn and no further claim / correspondence will be entertained in this regard.
- vi) Conditional bids are liable to be rejected at the discretion of the Company.
- vii) The work may be split up amongst more than one contractor at the sole discretion of the Company.
- viii) The bidders are required to furnish the composition and status of ownership of the firm in whose name bid documents have been purchased / issued along with one or more of the following documentary evidences (which are applicable to the bidder) in support of the same and scanned copies of the same should be uploaded along with the Technical Bid.

  - d. In case of Co-Operative Societies, Copies of Telephone/Electricity/Mobile Bill, PAN card, latest Income Tax Return form indicating therein the name, residential address, E-mail and telephone numbers of all the Directors or persons who are at the helm of affairs, registration certificate from Registrar of Co-Operative Societies and copy of GST Registration Certificate.
  - e. In case of Societies registered under the Societies Registration Act, Copies of Telephone/Electricity/Mobile Bill, PAN card, latest Income Tax Return form indicating therein the name, residential address, E-mail and telephone numbers of all the Directors or persons who are at the helm of affairs, registration certificate from the Registrar of the state and copy of GST Registration Certificate.
  - f. In case of Joint Stock Companies registered under the Indian Companies Act, Copies of Telephone/Electricity/Mobile Bill, PAN card, latest Income Tax Return form indicating therein the name, residential address, E-mail and telephone numbers of all the Directors or persons who are at the helm of affairs, Certificate of Incorporation from the Registrar of Companies, Memorandum and Articles and copy of GST Registration Certificate.
  - g. In case of Trusts registered under the Indian Trust Act, Copies of Telephone/Electricity/Mobile Bill, PAN card, latest Income Tax Return form indicating therein the name, residential address, E-mail and telephone numbers of all the Trustee or persons who are at the helm of affairs, registration certificate from the Registrar of the state, Trust Deed and copy of GST Registration Certificate.
- ix) The selected bidder will be required to enter into a formal contract, which will be based on their bid and OIL's Standard Form of Contract.

- x) The Bid Security / Performance Security Money shall not earn any interest.
- xi) Time will be regarded as the essence of the Contract and the failure on the part of the Contractor to complete the work within the stipulated time shall entitle the Company to recover liquidate damages and / or penalty from the Contractor as per terms of the tender /contract.
- xii) The contractor will be required to allow OIL officials to inspect the work site and documents in respect of the workers' payment.
- xiii) **BACKING OUT BY BIDDER:** In case any bidder withdraws their bid within the bid validity period, Bid Security will be forfeited and the party will be put on Holiday as per the Banning Policy (available in OIL's website) of Company.
- xiv) **BACKING OUT BY L-1 BIDDER AFTER ISSUE OF LOA:** In case LOA issued is not accepted by the L1 bidder or the Performance Security is not submitted as per the terms of the contract within the time specified in the Bid Document, the Bid Security shall be forfeited and the bidder shall be dealt as per the Banning Policy (available in OIL's website) of Company.
- xv) **FURNISHING FRAUDULENT INFORMATION/DOCUMENT**: The information and documents furnish by the bidder/ contractor in respect of the subject tender/contract are accepted to be true and genuine. However, if it is detected during technical scrutiny or after award of the contract or after expiry of the contract, that the bidder had submitted any fake/fraudulent document or furnished false statement, the offer/contract shall be rejected/ cancelled, as the case may be and the bidder (if fake document/false statement pertains to such bidder) shall be dealt as per the Banning Policy (available in OIL's website) of Company.



  - g) Schedule of Company's Plants, Materials and Equipments (SCPME): **Part- IV** [Not applicable for this Tender]
  - h) Safety Measures (SM): Part-V
  - i) Integrity Pact: Part-VI
  - j) Price Bidding Format (Attached under "**Notes and Attachments**" tab in the main bidding engine of OIL's e-Tender portal).
  - k) Proformas
- **2.2** The bidder is expected to examine all instructions, forms, terms and specifications in the Bid document. Failure to furnish all information required in the Bidding Documents or submission of a bid not substantially responsive to the Bidding Documents in every respect will be at the Bidder's risk & responsibility and may result in the rejection of its bid without seeking any clarifications.

#### 3.0 TRANSFERABILITY OF BID DOCUMENTS:

- **3.1** Bid Documents are non-transferable. Bid can be submitted only in the name of the bidder in whose name the Bid Document has been issued.
- **3.2** Unsolicited offers will not be considered and will be rejected straightway.

#### 4.0 AMENDMENT OF BIDDING DOCUMENTS:

**4.1** At any time prior to the deadline for submission of bids, the company may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the Bidding Documents by issuance of an Addendum.

4.2 The Addendum will be uploaded in OIL's E-Tender Portal in the Tab "Technical RFx" and External Area – "Amendments" folder. The company may, at its discretion, extend the deadline for bid submission. Bidders are expected to take the Addendum into account in preparation and submission of their bid. Bidders are to check from time to time the E-Tender portal ["Technical RFx" Tab and under the folder "Amendments"] for any amendments to the bid documents before submission of their bids. No separate intimation shall be sent to the Bidders.

#### 5.0 PREPARATION OF BIDS

**5.1** LANGUAGE OF BIDS: The bid as well as all correspondence and documents relating to the bid exchanged between the Bidder and the Company shall be in English language, except that any printed literature may be in another language provided it is accompanied by an official and notarized English translated version, which shall govern for the purpose of bid interpretation.

#### 5.2 DOCUMENTS COMPRISING THE BID:

#### (A) UN-PRICED TECHNO-COMMERCIAL BID:

- (i) Bid Documents duly filled up as indicated.
- (ii) Complete technical details / specifications of the equipment with catalogue, etc. as per tender requirement.
- (iii) Documentary evidence established in accordance with BEC / BRC part.
- (iv) Statement of Non-Compliance (if any).
- (v) Bid Security (scanned copy). Hard copy of original Bid Security (Only in case of bidder(s) submitting bid security in the form of Bank Guarantee) should be sent separately to reach **on or before 12.45 p.m. (IST) on the bid closing date failing which the bid shall be rejected.** 
  - (Bidders can submit bid security on-line through OIL's electronic Payment Gateway)
- (vi) Any other document as per tender requirement (scanned copy). Hard copy(s) of the same, if called for in the tender, should be sent separately to reach on or before 12.45 p.m. (IST) on the bid closing date failing which the bid shall be rejected.
- (vii) Integrity Pact

Note: Please note that no price details should be uploaded in UN-PRICED TECHNO-COMMERCIAL BID under "Technical Attachment" Tab.

#### (B) PRICED BID:

The Priced Bid shall contain the rates / prices along with the currency and any other commercial information pertaining to the rates / prices. Bidder shall quote their rates / prices in the "PRICE BIDDING FORMAT" attached under "Notes and Attachments" tab in the main bidding engine of OIL's e-Tender portal. The bidder must quote their price as per the attached "PRICE BIDDING FORMAT" under "Notes and Attachments" tab. Any other format will not be considered for evaluation.

Bidder must include all liabilities except GST in their quoted rates and indicate the applicable GST percentage separately as per the "PRICE BIDDING FORMAT". The rates shall be fixed and firm for the entire tenure of the contract and shall be binding on both the parties. No changes in these rates shall be allowed under any

circumstances during the tenure of this service agreement except as mentioned in the Bid Document.

#### 6.0 PERIOD OF VALIDITY OF BIDS:

- **6.1** The Bid must be valid for **90** (Ninety) days from the date of opening of the tender.
- **6.2** In exceptional circumstances, OIL may solicit the Bidder's consent to an extension of the period of validity. The request and the response thereto shall be made in writing (or by Fax). A Bidder granting the request will neither be required nor permitted to modify their bid.

#### 7.0 FORMAT AND SIGNING OF BID:

**7.1** The original and all copies of the bid shall be typed or written in indelible inks and shall be signed digitally by the Bidder to bind the Bidder to the contract.

#### 8.0 SUBMISSION OF BIDS:

- 8.1 The tender is processed under Single-Stage Composite-Bid System. Bidder shall submit the Technical bid and Priced bid along with all the Annexures and Proformas (wherever applicable) and copies of documents in electronic form through OIL's e-procurement portal within the Bid Closing Date & Time stipulated in the e-tender. For submission of Bids online at OIL's E-Tender Portal, detailed instructions are available in "User Manual" available in OIL's E-Tender Portal. Guidelines for bid submission are also provided in the "Forwarding Letter". The Technical Bid is to be submitted as per Terms of Reference/Technical Specifications of the bid document and Priced Bid as per the Price Schedule. The Technical Bid should be uploaded in the "Technical Attachment" Tab only. Prices to be quoted as per Price Bid Format should be uploaded as attachment in the Attachment link under "Notes & Attachments" Tab under General Data in the e-portal. No price should be given in the "Technical Attachment", otherwise bid shall be rejected. The priced bid should not be submitted in physical form which shall not be considered.
- **8.2** Any person signing the Bid or any other document in respect of this Bid Document or other relevant documents on behalf of the Bidder without disclosing his authority to do so shall be deemed to have the authority to bind the Bidder. If it is discovered at any time that the person so signing has no authority to do so, the Company (OIL) may, without prejudice to any other right or remedy, cancel his Bid or Contract and hold the Bidder liable to the Company (OIL) for all costs and damages arising from the cancellation of the Bid or Contract including any loss which the Company (OIL) may sustain on account thereof.
- **8.3** Timely submission of the bids is the responsibility of the Bidder and Bids should be submitted before the bid closing date and time. Company shall not be responsible for any delay.
- **8.4** Physical Bid/ E-mail/ Fax /Telephonic offers will not be accepted.
- **8.5** Bidder shall submit the Bid, duly completed in terms of the Bid Document.
- **8.6** Before submission of Bids, Bidders are requested to make themselves fully conversant with all Conditions of the Bid Document and other relevant information related to the works to be executed under this contract.

#### 9.0 DEADLINE FOR SUBMISSION OF BIDS:

- **9.1** Bids should be submitted on-line up to **11.00 a.m. (IST) (Server Time) on the Bid Closing date** mentioned in the Forwarding Letter. Bidders will be permitted by System to make any changes in their bid after the bid has been uploaded by the bidder prior to the Bid Closing date and time as mentioned in the bid except in condition mentioned in clause 12.1 below. But no changes would be allowed by the system once the due date and time for submission of bids has been reached and bids are opened.
- **9.2** No bid can be submitted after the submission deadline is reached. The system time displayed on the e-procurement web page shall decide the submission deadline.
- **9.3** The documents in physical form must be received by Company at the address specified in the "Forwarding Letter" on or before **12:45 p.m. (IST) on the bid closing date**. Timely delivery of the same at the address mentioned in the Forwarding Letter is the responsibility of the Bidders.

#### 10.0 LATE BIDS:

**10.1** Bidders are advised in their own interest to ensure that their bids are uploaded in system before the closing date and time of the bid. Any Bid received by the Company after the Bid Closing Date & Time stipulated by the Company shall be rejected.

#### 11.0 MODIFICATION AND WITHDRAWAL OF BIDS:

- 11.1 Bidders will be permitted by System to withdraw their bid or make any changes in their bid after the bid has been uploaded by the bidder prior to the Bid Closing date and time as mentioned in the bid. But no changes or withdrawal would be allowed by the system once the due date and time for submission of bids has been reached and bids are opened.
- **11.2** No bid can be modified / withdrawn subsequent to the deadline for submission of bids.
- **11.3** No bid may be withdrawn in the interval between the deadline for submission of bids and the expiry of the period of bid validity. Withdrawal of any bid within validity period will lead to forfeiture of his / her / their Bid Security Deposit in full and debar from participation in future tenders, at the sole discretion of the company.

#### 12.0 EXTENSION OF BID SUBMISSION DATE:

**12.1** Normally no request for extension of Bid Closing Date & Time will be entertained. However, OIL at its discretion, may extend the Bid Closing Date and / or Time due to any reasons.

#### 13.0 BID OPENING AND EVALUATION:

13.1 Both Technical & Price bid will be opened on scheduled Bid opening date & time in the presence of any attending Bidder(s) or their Authorized Representative, if any. However, an authorized letter (format given in Proforma Section) from the Bidder must be produced by Bidder's representative at the time of opening of Tender, without which such representative won't be allowed to attend the opening of Tenders. Only one representative against each Bid will be allowed to attend the bid opening. Attending Bidder(s) & Authorized Representative(s) will have to sign a register evidencing their presence.

- **13.2** In case it happens to be a bundh / holiday, the tender will be opened on the next working day (except Saturday). Accordingly, Bid Closing Date / time will get extended up to the next working day and time (except Saturday).
- **13.3** Bids which have been withdrawn pursuant to Clause 11.0 will not be allowed to be opened by the system. OIL shall examine bids to determine whether they are complete, whether requisite Bid Securities have been furnished, whether documents have been properly signed and whether the bids are generally in order.
- **13.4** OIL shall prepare, for its own records, minutes of bid opening including the information disclosed to those present in accordance with the sub-clause 13.3.
- 13.5 To assist in the examination, evaluation and comparison of bids, normally no clarifications shall be sought from the Bidders. However, for assisting in the evaluation of the bids especially on the issues where the Bidder confirms compliance in the evaluation and contradiction exists on the same issues due to lack of required supporting documents in the Bid (i.e. document is deficient or missing), or due to some statement at other place of the Bid (i.e. reconfirmation of confirmation) or vice versa, clarifications may be sought by OIL at its discretion. The request for clarification and the response shall be in writing and no change in the price or substance of the bid shall be sought, offered or permitted.
- **13.6** Prior to the detailed evaluation, OIL will determine the substantial responsiveness of each bid to the requirement of the Bidding Documents. For purpose of these paragraphs, a substantially responsive bid is one, which conforms to all the terms and conditions of the Bidding Document without material deviations or reservation. A material deviation or reservation is one which affects in any substantial way the scope, quality, or performance of work, or which limits in any substantial way, in-consistent way with the bidding documents, the Company's right or the bidder's obligations under the contract, and the rectification of which deviation or reservation would affect unfairly the competitive position of other bidders presenting substantial responsive bids. OIL's determination of bid's responsiveness is to be based on the contents of the Bid itself without recourse to extrinsic evidence.
- **13.7** A Bid determined as not substantially responsive will be rejected by the Company and may not subsequently be made responsive by the Bidder by correction of the non-conformity.
- **13.8** The Company may waive minor informality or nonconformity or irregularity in a bid, which does not constitute a material deviation, provided such waiver, does not prejudice or affect the relative ranking of any Bidder.

#### 14.0 EVALUATION AND COMPARISON OF BIDS:

- **14.1** OIL will evaluate and compare the bids as per Bid Evaluation Criteria (BEC) of the bidding documents.
- **14.2** To ascertain the inter-se-ranking, the comparison of the responsive bids will be made on the basis of total amount quoted inclusive of all liabilities and GST for the items of Part-II (i.e. schedule of works, units, quantity, rates) of the tender.
- **14.3** DISCOUNTS / REBATES: Unconditional discounts / rebates, if any, given in the bid or along with the bid will be considered for evaluation.
- **14.4** Post bid or conditional discounts / rebates offered by any bidder shall not be considered for evaluation of bids. However, if the lowest bidder happens to be the final

acceptable bidder for award of contract, and if they have offered any discounts / rebates, the contract shall be awarded after taking into account such discounts / rebates.

#### 14.5 Conditional bids are liable to be rejected at the discretion of the Company.

#### 15.0 CONTACTING THE COMPANY:

- **15.1** Except as otherwise provided in Clause 14.0 above, no Bidder shall contact OIL on any matter relating to its bid, from the time of the bid opening to the time the Contract is awarded except as required by OIL vide sub-clause 13.5.
- **15.2** An effort by a Bidder to influence OIL in the bid evaluation, bid comparison or Contract award decisions may result in the rejection of their bid.

#### 16.0 AWARD CRITERIA:

**16.1** OIL will award the Contract to the successful Bidder whose bid has been determined to be substantially responsive and has been determined as the lowest evaluated bid, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.

#### 17.0 OIL'S RIGHT TO ACCEPT OR REJECT ANY BID:

**17.1** OIL reserves the right to accept or reject any or all bids and to annul the bidding process and reject all bids, at any time prior to award of contract, without thereby incurring any liability to the affected bidder, or bidders or any obligation to inform the affected bidder of the grounds for OIL's action.

#### **18.0 NOTIFICATION OF AWARD:**

**18.1** Prior to the expiry of the period of bid validity or extended validity, OIL will notify the successful Bidder in writing by registered letter or by cable or telex or fax or e-mail (to be confirmed in writing by registered / couriered letter) that its bid has been accepted.

#### 19.0 SIGNING OF CONTRACT:

- **19.1** The successful bidders(s) shall be notified by the Company of its intention to enter into an Agreement with him/her/them on the basis of his/her/their acceptance of the offer. Such notification shall be treated as a "Letter of Award (LOA)".
- **19.2** Within 02 Weeks from the date of issue of Letter of Award (LOA), the successful Bidder(s) will be required to pay an interest free Performance Security by way of Demand Draft / Banker's Cheque / Bank Guarantee (in specified format) favouring "OIL INDIA LIMITED" payable at "DULIAJAN" from any Nationalized Bank. Upon furnishing of the Performance Security, the successful Bidder(s) will be required to enter into a formal Service Agreement based on the instant tender on the OIL Standard forms of agreement.
- **19.3** The Performance Security for Phase-I must be valid for 27 (twenty-seven) months beyond completion of Phase-I and Performance Security for Phase-II must be valid for 03 (three) months beyond completion of Phase-II. In the event of contract being extended within the provisions of the contract agreement, the contractor will have to extend suitably the validity of the "Security Deposit" for the extended period.

#### **INSTRUCTION TO BIDDERS**

**19.4** The Performance Security for Phase-I shall be refunded to the contractor after submission of performance security for Phase-II. Performance Security for Phase-II shall be refunded 03 months after satisfactory completion of works under the contract (including extension, if any), but part or whole of which shall be used by the Company in realization of liquidated damages or claims, if any or for adjustment of compensation or loss due to the Company for any reason.

Note: In case the Company does not appoint the contractor for Phase-II then Performance Security for Phase-I shall be refunded 03 months after satisfactory completion of Phase-I.

**19.5** Failure of the successful bidders to comply with the conditions as specified in Para 19.2 above would render him liable for rejection and in turn forfeiture of Bid Security apart from any other actions the Company may take against him at its sole discretion. The bidder shall be dealt as per the Banning Policy (available in OIL's website) of Company.

#### 1.0 BID EVALUATION CRITERIA:

The bid shall conform to the specifications and terms and conditions given in the Bidding Documents. Bids will be rejected in case material and services offered do not conform to the required parameters stipulated in the technical specifications. Notwithstanding the general conformity of the bid to the stipulated specifications, the following requirements will have to be particularly met by the Bidders without which the same will be considered as non-responsive and will not be considered for evaluation. All the documents related to BEC shall be submitted along with the Technical Bid.

1.1 **Technical Criteria:** Bidder must have experience of successfully completing at least one **SIMILAR work** of value **Rs. 13,00,000.00 (Rupees Thirteen Lakh)** only in previous 07 (seven) years reckoned from the original bid closing date with PSUs / Central Government / State Government Organization / Public Limited Company.

#### Notes to BEC Clause No. 1.1:

- 1. **"SIMILAR work**" mentioned above means "Experience in successful completion of Designing of Sewage / Effluent Treatment Plant(s)."
- 2. If the prospective bidder is executing **SIMILAR work** which is still running and the contract value executed prior to original bid closing date is equal to or more than the minimum prescribed value in the BEC such experience will also be taken in to consideration provided that the bidder has submitted last certificate of payment showing gross value of work done along with Contract documents / work order of the running contract.
- 3. In case the start date of the requisite experience is prior to the prescribed 07 (seven) years reckoned from the original bid closing date but completion is within the prescribed 07 (seven) years reckoned from the original bid closing date then such experience will also be taken into consideration provided that the bidder has submitted a certificate issued by a practicing Chartered/Cost Accountant Firm (with Membership Number & Firm Registration Number) indicating the contract value executed under **SIMILAR work** within the prescribed period of 07 (seven) years reckoned from the original bid closing date.
- 4. If the prospective bidder has executed contract(s) in which **SIMILAR work** is a component, and value of **SIMILAR work** executed is equal to or more than the minimum prescribed value in the BEC, then such experience will also be taken into consideration provided that the bidder submits the breakup of value of work executed under such contract(s) clearly indicating the value of **SIMILAR work** and certified by the end user.
- 5. For proof of requisite experience of **SIMILAR work**, **self-attested** photocopies of following documents must be submitted along with the bid: Contract documents / Purchase Order / Work order showing details of works supported with Completion Certificate issued by PSUs / Govt. organisation / Public limited companies for the **SIMILAR work** mentioned above confirming the following:
  - a. Gross value of work done
  - b. Nature of Job done.
  - c. Contract period / Contract start and completion date.
- 6. **SIMILAR work** executed by a bidder for its own organization / subsidiary will not be considered as experience for the purpose of meeting BEC.

#### 1.2 Financial Criteria:

- (i) Annual Financial Turnover of the bidder in any of preceding 03 (three) financial / accounting years, reckoned from the original bid closing date should be at least Rs. 7,80,000.00 (Rupees Seven Lakh Eighty Thousand) only.
- (ii) Net worth of bidder must be positive for preceding financial / accounting year.

#### Notes to BEC Clause No. 1.2:

- **A.** For proof of Annual Turnover & Net worth any one of the following document must be submitted along with the bid:
  - (i) A certificate issued by a practicing Chartered /Cost Accountant\* (with Membership Number and Firm Registration Number), certifying the Annual turnover & Net worth as per format prescribed in **PROFORMA-I.**

OR

- (ii) Audited Balance Sheet along with Profit & Loss account.

  \*In case the bidder is a Central Govt. organization / PSU /State Govt. organization / Semi-State Govt. Organization or any other Central / State Govt. Undertaking, where the auditor is appointed only after the approval of Comptroller and Auditor General of India and the Central Government, their certificates may be accepted even though FRN is not available. However, bidder to provide documentary evidences for the same.
- **B.** Considering the time required for preparation of Financial Statements, if the last date of preceding financial / accounting year falls within the preceding six months reckoned from the original bid closing date and the Financial Statements of the preceding financial / accounting year are not available with the bidder, then the financial turnover of the previous three financial / accounting years excluding the preceding financial / accounting year will be considered. In such cases, the Net worth of the previous financial / accounting year excluding the preceding financial / accounting year will be considered. However, the bidder has to submit an affidavit/undertaking certifying that 'the balance sheet/Financial Statement for the financial year ....................... has actually not been audited so far'.
- 1.3 Both Technical & Price bid will be opened on scheduled Bid opening date & time. However, Price bids shall be evaluated of only the techno-commercially acceptable bidders, whose bids have been found to be substantially responsive. A substantially responsive bid one that meets the terms and conditions of the Tender and / or the acceptance of which bid will not result in indeterminate liability on OIL.
- **1.4** Bidders are required to quote for all the items as per Price Bid Format; otherwise the offer of the bidder will be straightway rejected.
- 1.5 If there is any discrepancy between the unit price and the total price, the unit price will prevail and the total price shall be corrected. Similarly, if there is any discrepancy between words and figure, the amounts in words shall prevail and will be adopted for evaluation.
- 1.6 The quantities shown against each item in the "Price Bid Format" shall be considered for the purpose of Bid Evaluation. It is, however, to be clearly understood that the assumptions made in respect of the quantities for various operations are only for the purpose of evaluation of the bid and the Contractor will be paid on the basis of the actual number of days/parameter, as the case may be.

1.7 Price Bids will be evaluated on overall lowest cost basis (L-1 offer) i.e. considering total price quoted against for all items of PHASE-I and PHASE-II of SOQ (Part-II of tender document) inclusive of all liabilities and GST as per Price Bid Format.

#### Note:

- i. In case the total amount quoted is same for more than one bidder, then the bidder quoting the lowest rate against PHASE-II of the Project shall be considered for award of the Contract.
- ii. In case the total amount quoted is same for more than one bidder and the quoted amount against PHASE-II of the Project is also the same, then the lowest bidder for award of the Contract shall be considered by draw of Lots amongst the bidders quoting the same lowest total amount.
- **1.8** Based on the evaluation of techno-commercially qualified bidders, the job will be awarded to L-1 bidder.
- **1.9** The bidders are advised not to offer any discount / rebate separately and to offer their prices in the Price Bid Format after considering discount/rebate, if any.
- **1.10** Conditional and unsolicited discount will not be considered in evaluation. However, if such bidder happens to be the lowest recommended bidder, unsolicited discount without any condition will be considered for computing the contract price.
- 1.11 PURCHASE PREFERENCE CLAUSE: Purchase Preference to Micro and Small Enterprises registered with District Industry Centres or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by Ministry of MSME:
  - (a) In case participating MSEs quote price within price band of L1+15%, such MSE shall be considered for award of contract by bringing down their price to L1 price in a situation where L1 price is from someone other than a MSE.
  - **(b)** In case of more than one such MSE qualifying for 15% purchase preference, the contract shall be awarded to lowest eligible MSE amongst the MSEs qualifying for 15% purchase preference.
  - **(c)** In case any part of the work is sub-contracted to a Micro or Small Enterprise as per contract conditions then the contractor shall provide complete details (i.e. name of the sub-contractor, value of sub-contacted work, copy of valid registration certificate etc.) of the sub-contractor to OIL.

#### (d) Documentation required to be submitted by MSEs:

Submit a copy of valid Registration Certificate, if bidder is a Micro or Small Enterprises (MSE) registered with District Industry Centres or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by Ministry of MSME. The Registration Certificate should clearly indicate the monetary limit, if any and the items for which bidder are registered with any of the aforesaid agencies. In case bidding MSE is owned by Schedule Caste or Schedule Tribe entrepreneur, valid documentary evidence issued by the agency who has registered the bidder as MSE owned by SC/ST entrepreneur should also be enclosed.

#### 2.0 BID REJECTION CRITERIA (BRC):

- **2.1** The bids are to be submitted in **Single-Stage Composite bid system** i.e. Un-priced Techno-Commercial Bid and Price Bid together. Only the Price Bid should contain the quoted price.
- **2.2** The price quoted by the successful bidder must be firm during the performance of the contract and not subject to variation on any account except as mentioned in the bid document. Any bid submitted with adjustable price quotation other than the above will be treated as non-responsive and rejected.
- **2.3** Bid security shall be furnished as a part of the Techno Commercial Un-priced Bid. The amount of bid security should be as specified in the forwarding letter. Any bid not accompanied by a proper bid security will be rejected.

<u>Note:</u> In case the Bidder submits Bid security in the form of Bank Guarantee (BG); the BG must be valid for minimum **120 days** from the date of Technical bid opening.

- **2.4** Bid Documents / User Id & Password for OIL's E-Tender portal are not transferable.
- **2.5** Any bid received in the form of Physical document/Telex/Cable/Fax/E-mail will not be accepted.
- **2.6** Bids shall be typed or written in indelible ink. The bidder or his authorized representative shall sign the bid digitally, failing which the bid will be rejected.
- **2.7** Bids shall contain no interlineations, erasures or overwriting except as necessary to correct errors made by bidder, in which case such corrections shall be initiated by the persons(s) signing (digitally) the bid. However, white fluid should not be used for making corrections. Any bid not meeting this requirement shall be rejected.
- **2.8** Any bid containing false statement will be rejected and action will be taken by Company as per Bid Document.
- 2.9 Bids are invited under **Single-Stage Composite Bid System**. Bidders must submit both "Technical" and "Price" Bids in electronic form through online OIL's e-Tender portal accordingly within the Bid Closing Date and time stipulated in the e-Tender. - (c) "**The Work**" means each and every activity required for the successful performance of the services described in Section II, the Terms of Reference.
- (d) "Company" or "OIL" means Oil India Limited;
- (e) "**Contractor**" means the Contractor performing the work under this Contract.
- (f) "**Contractor's Personnel**" means the personnel to be provided by the Contractor to provide services as per the contract.
- (g) "Company's Personnel" means the personnel to be provided by OIL or OIL's Contractor (other than the Contractor executing the Contract). The Company representatives of OIL are also included in the Company's personnel.
- (h) "Gross Negligence" means any act or failure to act (whether sole, joint or concurrent) by a person or entity which was intended to cause, or which was in reckless disregard of or wanton indifference to, avoidable and harmful consequences such person or entity knew, or should have known, would result from such act or failure to act. Notwithstanding the foregoing, Gross negligence shall not include any action taken in good faith for the safeguard of life or property.
- (i) "Wilful Misconduct" means intentional disregard of good and prudent standards of performance or proper conduct under the Contract with knowledge that it is likely to result in any injury to any person or persons or loss or damage of property.

#### WITNESSETH:

- **3.0** The Company's Engineer shall have power to:

- b) Order the Contractor to remove any inferior material from the site and to demolish or rectify any work of inferior workmanship, failing which the Company's Engineer may arrange for any such work to be demolished or rectified by any other means at the Contractor's expenses.
- c) Order the Contractor to remove or replace any workman who he (The Engineer) considers incompetent or unsuitable; the Engineer's opinion as to the competence and suitability of any workman engaged by the Contractor shall be final and binding on the Contractor.

- **5.0** The Company reserves the right to cancel this Contract at any time upon full payment of work done and the value of the materials collected by the contractor for permanent incorporation in the work under this contract particularly for execution of this contract up to the date of cancellation of the Contract. The valuation of the work done and the materials collected shall be estimated by the company's Engineer in presence of the contractor. The Contractor shall have no claim to any further payment whatsoever. The valuation would be carried out exparte if Contractor fails to turn up despite reasonable notice which will be binding on the Contractor.
- **6.0** The Contractor hereby undertakes to indemnify the Company against all claims which may arise under the under noted Acts:
  - The Mines Act.
  - ii) The Minimum Wages Act, 1948.
  - iii) The Workman's Compensation Act, 1923.
  - iv) The Payment of wages Act, 1936.
  - v) The Payment of Bonus Act, 1965.
  - vi) The Contract Labour (Regulation & Abolition) Act, 1970 and the rules framed there under.
  - vii) Employees' Pension Scheme, 1995.
  - viii) Inter-State Migrant (Regulation of Employment and Condition of Service) Act. 1979.
  - ix) The Employees Provident Fund and Miscellaneous Provisions Act, 1952.
  - x) GST Act.

or any other Acts or Statute not here in above specifically mentioned having bearing over engagement of workers directly or indirectly for execution of work. The Contractor shall not make the Company liable to reimburse the Contractor for the statutory increase in the wage rates of the Contract Labour appointed by the Contractor. Such Statutory increase in the wage rates of Contract Labour shall be borne by the contractor.

- **7.0** The Contractor shall clear away all rubbish and surplus material from the site on completion of work and shall leave the site clean and tidy.
- **8.0** The duration for PHASE-I 02 (two) years and 06 (six) months from the date of issue of 1st work order & PHASE-II From date of issue of 2nd work order till completion of construction phase of both STPs. **Note:** Supervisory services during Phase-II may / may not be availed at OIL's discretion which shall be firmed up during Phase-I of the Project prior to submission of final "Detailed Project Reports". Another Work Order shall be issued for commencement of supervisory services during Phase-II after submission of second Performance Security Deposit. There may be a gap between the two phases as detailed in Part-III SCC of tender document. The mobilization period is **02 (two) weeks** from the date of issue of 1st work order. The Contractor must complete the work as mentioned in PART III (SPECIAL CONDITIONS OF CONTRACT: SCC) within the contract period. In the event of there being undue delay in execution of the Contract, the Company reserves the right to cancel the Contract and/or levy such additional damages as it deems fit based on the

actual loss suffered by the company attributable to such delay. The company's decision in this regard shall be final.

**9.0** In order to promote, safeguard and facilitate the general operational economic in the interest of the Company during the continuance of this contract the Contractor hereby agrees and undertakes not to take any direct or indirect interest and or support, assist, maintain or help any person or persons engaged in antisocial activities, demonstration, riots, or in any agitation prejudicial to the Company's interest and any such even taking shape or form at any place of the Company's works or and its neighborhood.

Payment will be made, not often than monthly, up to **100%** of the value of work done. Final payment will be made only after satisfactory completion of the work. Such final payment shall be based on the work actually done allowing for deviations and any deductions and the measurement shall be checked and certified correct by the Company's Engineer before any such final payment is made.

- **11.0** The contractor employing **20 (twenty)** or more workmen on any day preceding 12 months shall be required to obtain requisite license at his cost from the appropriate Licensing Officer before undertaking any Contract work. The Contractor shall also observe the rules & regulations framed under the Contract Labour (Regulation & Abolition) Act.
- **12.0** The Contractor will not be allowed to construct any structure (for storage/housing purpose) with thatch, bamboo or any other inflammable materials within any company's fenced area.
- **13.0** The Contractor shall ensure that all men engaged by him/her are provided with appropriate protective clothing and safety wear in accordance with regulation 89(a) and 89(b) in the Oil Mines Regulations 1984. The Company's representative shall not allow/accept those men who are not provided with the same.
- **14.0** The Contractor shall deploy local persons in all works.
- **15.0** The Contractor shall not engage minor labour below 18 (eighteen) years of age under any circumstances.
- **16.0** The Contractor and his/her workmen shall strictly observe the rules and regulations as per Mines Act (Latest editions).

#### 17.0 GENERAL OBLIGATIONS OF COMPANY:

COMPANY shall, in accordance with and subject to the terms and conditions of this contract:

i) Pay the Contractors in accordance with terms and conditions of the contract.

ii) Allow access to Contractors and their personnel, subject to normal security and safety procedures, to all areas as required for orderly performance of the work.

#### 18.0 SPECIAL CONDITIONS:

- a) The amount of retention money shall be released after 6 (six) months from the date of issue of completion certificate from concerned department.
- b) The contractor will be required to allow OIL Officials to inspect the work site and documents in respect of the workers' payment.
- c) Contractor(s) whosoever is liable to be covered under the P.F. Act and contract cost is inclusive of P.F., must ensure strict compliance of provisions of Provident Fund and Miscellaneous Provisions Act, 1952 in addition to the various Acts mentioned elsewhere in this contract. Any contractor found violating these provisions will render themselves disqualified from any future tendering. As per terms of the contract, if applicable, the Contractor must deposit Provident Fund Contribution (covering Employee's & Employer's share) with the competent authority monthly under their direct code. The Contractor shall be required to submit documentary evidence of deposit of P.F. Contribution to the Company. In case of failure to provide such documentary evidence, the Company reserves the right to withhold the amount equivalent to applicable P.F. Contribution.

#### 19.0 ARBITRATION:

## 19.1 ARBITRATION (APPLICABLE FOR SUPPLIERS/CONTRACTORS OTHER THAN PSU)

Except as otherwise provided elsewhere in the contract, if any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, in connection with construction, meaning, operation, effect, interpretation of the contract or breach thereof which parties are unable to settle mutually, the same shall be referred to Arbitration as provided hereunder:

a) A party wishing to commence arbitration proceeding shall invoke Arbitration Clause by giving 30 days' notice to the other party. The notice invoking arbitration shall specify all the points of dispute with details of the amount claimed to be referred to arbitration at the time of invocation of arbitration and not thereafter. If the claim is in foreign currency, the claimant shall indicate its value in Indian Rupee for the purpose of constitution of the arbitral tribunal.

**b)** The number of arbitrators and the appointing authority will be as under:

- c) The parties agree that they shall appoint only those persons as arbitrators who accept the conditions of the arbitration clause. No person shall be appointed as Arbitrator or Presiding Arbitrator who does not accept the conditions of the arbitration clause.
- **d)** Parties agree that there will be no objection if the Arbitrator appointed holds equity shares of OIL and/or is a retired officer of OIL/any PSU. However, neither party shall appoint its serving employees as arbitrator.
- e) If any of the Arbitrators so appointed dies, resigns, becomes incapacitated or withdraws for any reason from the proceedings, it shall be lawful for the concerned party/arbitrators to appoint another person in his place in the same manner as aforesaid. Such person shall proceed with the reference from the stage where his predecessor had left if both parties consent for the same; otherwise, he shall proceed de novo.
- f) Parties agree that neither shall be entitled for any pre-reference or pendente-lite interest on its claims. Parties agree that any claim for such interest made by any party shall be void.
- **g)** The arbitral tribunal shall make and publish the award within time stipulated as under:

The above time limit can be extended by Arbitrator, for reasons to be recorded in writing, with the consent of the other parties.

- **h)** If after commencement of the arbitration proceedings, the parties agree to settle the dispute mutually or refer the dispute to conciliation, the arbitrators shall put the proceedings in abeyance until such period as requested by the parties.
- i) Each party shall be responsible to make arrangements for the travel and stay etc. of the arbitrator pointed by it. Claimant shall also be responsible for making arrangements for travel/stay arrangements of the Presiding Arbitrator and the expenses incurred shall be shared equally by the parties.
  - In case of sole arbitrator, OIL shall make all necessary arrangements for his travel, stay and the expenses incurred shall be shared equally by the parties.
- **j)** The Arbitration shall be held at **Duliajan, Assam**. However, parties to the contract can agree for a different place for the convenience of all concerned.
- **k)** The Arbitrator(s) shall give reasoned and speaking award and it shall be final and binding on the parties.

1) Subject to aforesaid, provisions of the Arbitration and Conciliation Act, 1996 and any statutory modifications or re-enactment thereof shall apply to the arbitration proceedings under this clause.

## 19.2 <u>ARBITRATION (APPLICABLE IN CASE OF CONTRACT AWARDED ON PUBLIC</u> SECTOR ENTERPRISE):

In the event of any dispute or difference relating to, arising from or connected with the Contract, such dispute or difference shall be referred by either party to the arbitration of one of the Arbitrators in the Department of Public Enterprises, to be nominated by the Secretary to the Government of India, In-Charge of the Bureau of Public Enterprises. The Arbitration and Conciliation Act 1996 shall not be applicable to the Arbitration under this clause. The award of the Arbitrator shall be binding upon the parties to the dispute, provided however, any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law Secretary, Deptt. of Legal Affairs, Ministry of Law and Justice, Government of India. Upon such reference, the dispute shall be decided by the Law Secretary or the Special Secretary/Additional Secretary, whose decision shall bind the parties finally and conclusively. The parties in the dispute will share equally the cost of the arbitration as intimated by the Arbitrator.

The venue of all arbitrations under both 19.1 & 19.2 will be **Duliajan, Assam**. The award made in pursuance thereof shall be binding on the parties.

#### 20.0 FORCE MAJEURE:

**20.1** In the event of either party being rendered unable by 'Force majeure' to perform any obligations required to be performed by them under the contract the relative obligations of the party affected by such 'Force Majeure' shall upon notification to the other party be suspended for the period during which force majeure event lasts. The cost and loss sustained by the either party shall be borne by the respective parties.

The term 'Force Majeure' as employed herein shall mean acts of God, earthquake, war (declared/undeclared) revolts, riots, fires, floods, rebellions, explosions, hurricane, sabotage, civil commotions, and acts and regulations of respective Govt. of the two parties, namely the Company and the contractor.

**20.2** Upon the occurrence of such cause(s) and upon its termination, the party alleging that it has been rendered unable as aforesaid thereby, shall notify the other party in writing immediately but not later than 72 (Seventy-two) hours of the alleged beginning and ending thereof giving full particulars and satisfactory evidence in support of its claim.

Time for performance of the relative obligations suspended by the force majeure shall then extended by the period for which such cause lasts.

**20.3** Should 'force majeure' condition as stated above occurs and should the same be notified within Seventy-Two (72) hours after its occurrence the 'force majeure' rate shall apply for the first fifteen days. Parties will have the right to terminate the Contract if such 'force majeure' conditions continue beyond fifteen (15) days with prior written notice. Should either party decide not to terminate the Contract even under such condition, no payment would apply after expiry of fifteen (15) days force majeure period unless otherwise agreed to.

#### 21.0 TERMINATION:

- **21.1 TERMINATION ON EXPIRY OF THE TERMS (DURATION):** The contract shall be deemed to have been automatically terminated on the expiry of duration of the Contract or the extension period, if exercised by Company under the provision of the Contract.
- **21.2 TERMINATION ON ACCOUNT OF FORCE MAJEURE:** Either party shall have the right to terminate this Contract on account of Force Majeure as set forth in Article 20.0 above.
- **21.3 TERMINATION ON ACCOUNT OF INSOLVENCY:** In the event that the Contractor or its collaborator at any time during the term of the Contract, becomes insolvent or makes a voluntary assignment of its assets for the benefit of creditors or is adjudged bankrupt, then the Company shall, by a notice in writing have the right to terminate the Contract and all the Contractor's rights and privileges hereunder, shall stand terminated forthwith.
- **21.4 TERMINATION FOR UNSATISFACTORY PERFORMANCE:** If the Company considers that, the performance of the Contractor is unsatisfactory, or not up to the expected standard, the Company shall notify the Contractor in writing and specify in details the cause of the dissatisfaction. The Company shall have the option to terminate the Contract by giving 15 days' notice in writing to the Contractor, if Contractor fails to comply with the requisitions contained in the said written notice issued by the Company.
- **21.5 TERMINATION DUE TO CHANGE OF OWNERSHIP & ASSIGNMENT:** In case the Contractor's rights and/or obligations under this Contract and/or the Contractor's rights, title and interest to the equipment/material, are transferred or assigned without the Company's consent, the Company may at its absolute discretion, terminate this Contract.
- **21.6** If at any time during the term of this Contract, breakdown of Contractor's equipment results in Contractors being unable to perform their obligations hereunder for a period of 15 successive days, Company at its option, may terminate this Contract in its entirely without any further right or obligation on the part of the Company, except for the payment of money then due. No notice shall be served by the Company under the condition stated above.
- **21.7** Notwithstanding any provisions herein to the contrary, the Contract may be terminated at any time by the Company on giving 30 (thirty) days written notice to the Contractor due to any other reason not covered under the above clause from 21.1 to 21.6 and in the event of such termination the Company shall not be liable to pay any cost or damage to the Contractor except for payment for services as per the Contract upto the date of termination including the De-mob cost, if any.
- **22.0 CONSEQUENCES OF TERMINATION:** In all cases of termination herein set forth, the relative obligations of the parties to the Contract shall be limited to the period up to the date of termination. Notwithstanding the termination of this Contract, the parties shall continue to be bound by the provisions of this Contract that reasonably require some action or forbearance after such termination.
- **22.1** Upon termination of this Contract, Contractor shall return to Company all of Company's items, which are at the time in Contractor's possession.

**22.2** In the event of termination of contract, Company will issue Notice of termination of the contract with date or event after which the contract will be terminated. The contract shall then stand terminated and the Contractor shall demobilize their personnel & materials.

#### 23.0 <u>I.B. VERIFICATION REPORT AND SECURITY REVIEW:</u>

Contractor will be required to submit the verification report to ascertain character and antecedents from the Civil Administration towards the persons engaged under this contract to the Head of the user Department before engagement.

**24.0** In case of any doubt or dispute as to the interpretation of any clause herein contained, the decision of the Company's Engineer shall be final and binding on the contractor.

#### 25.0 SET OFF CLAUSE:

"Any sum of money due and payable to the contractor (including Security Deposit refundable to them) under this or any other contract may be appropriated by Oil India Limited and set off against any claim of Oil India Limited (or such other person or persons contracting through Oil India Limited) for payment of a sum of money arising out of this contract or under any other contract made by the contractor with Oil India Limited (or such other person or persons contracting through Oil India Limited)."

#### 26.0 FURNISHING FRAUDULENT INFORMATION/DOCUMENT:

The information and documents furnished by the bidder/contractor in respect of the subject tender/contract are expected to be true and genuine. However, if it is detected during technical scrutiny or after award of the contract or after expiry of the contract, that the bidder had submitted any fake/fraudulent document or furnished false statement, the offer/contract shall be rejected/cancelled, as the case may be and the bidder (if fake document/false statement pertains to such bidder) shall be dealt as per the Banning Policy (available in OIL's website) of Company.

#### 27.0 PROVISION FOR ACTION IN CASE OF ERRING/DEFAULTING AGENCIES:

Action against erring and defaulting agencies like bidder, contractor, supplier, vendor, service provider will be as per OIL's Banning Policy dated 6<sup>th</sup> January, 2017 available in OIL's website <a href="https://www.oil-india.com">www.oil-india.com</a>.

## 28.0 <u>LIQUIDATED DAMAGES FOR DELAY IN MOBILIZATION/COMPLETION OF</u> WORKS AND SERVICES:

In the event of the Contractor's default in timely mobilization/completion within the stipulated period, the Contractor shall be liable to pay liquidated damages @ 0.5% of contract value, per week or part thereof of delay subject to maximum ceiling of 7.5% of contract value.

#### 29.0 SUBCONTRACTING:

CONTRACTORS shall not subcontract or assign, in whole or in part, their obligations to perform under this contract, except with COMPANY'S prior written consent.

#### **30.0 MISCELLANEOUS PROVISIONS:**

Contractors shall conform in all respects with the provisions of any Statute, Ordinance of Law and the regulations or bye-law of any local or other duly constituted authority which may be applicable to the services and with such rules and regulation public bodies and Companies as aforesaid and shall keep OIL indemnified against all penalties and liability of every kind for breach of any such Statute, Ordinance or Law, regulation or byelaw.

#### 31.0 LIABILITY:

- **31.1** Except as otherwise expressly provided, neither Company nor its servants, agents, nominees, Contractors, or sub-contractors shall have any liability or responsibility whatsoever to whomsoever for loss of or damage to the equipment and/or loss of or damage to the property of the Contractor and/or their Contractors or sub-contractors, irrespective of how such loss or damage is caused and even if caused by the negligence of Company and/or its servants, agent, nominees, assignees, contractors and sub-contractors. The Contractor shall protect, defend, indemnify and hold harmless Company from and against such loss or damage and any suit, claim or expense resulting there from.
- **31.2** Neither Company nor its servants, agents, nominees, assignees, Contractors, subcontractors shall have any liability or responsibility whatsoever for injury to, illness, or death of any employee of the Contractor and/or of its contractors or sub-contractor irrespective of how such injury, illness or death is caused and even if caused by the negligence of Company and/or its servants, agents nominees, assignees, Contractors and sub-contractors. Contractor shall protect, defend, indemnify and hold harmless Company from and against such liabilities and any suit, claim or expense resulting there from.
- **31.3** The Contractor hereby agrees to waive its right to recourse and further agrees to cause their underwriters to waive their right of subrogation against Company and/or its underwrites, servants, agents, nominees, assignees, Contractors and sub-contractors for loss or damage to the equipment of the Contractor and/or its sub-contractors when such loss or damage or liabilities arises out of or in connection with the performance of the contract.
- **31.4** The Contractor hereby further agrees to waive its right of recourse and agrees to cause its underwriters to waive their right of subrogation against Company and/or its underwriters, servants, agents, nominees, assignees, Contractors and sub-contractors for injury to, illness or death of any employee of the Contractor and of its contractors, sub-contractors and/or their employees when such injury, illness or death arises out of or in connection with the performance of the contract.
- **31.5** Except as otherwise expressly provided, neither Contractor nor its servants, agents, nominees, Contractors or sub-contractors shall have any liability or responsibility whatsoever to whomsoever for loss of or damage to the equipment and/or loss or damage to the property of the Company and/or their Contractors or sub-contractors, irrespective of how such loss or damage is caused and even if caused by the negligence of Contractor

and/or its servants, agents, nominees, assignees, Contractors and sub-contractors. The Company shall protect, defend, indemnify and hold harmless Contractor from and against such loss or damage and any suit, claim or expense resulting therefrom.

- **31.6** Neither Contractor nor its servants, agents, nominees, assignees, Contractors, subcontractors shall have any liability or responsibility whatsoever to whomsoever or injury or illness, or death of any employee of the Company and/or of its contractors or subcontractors irrespective of how such injury, illness or death is caused and even if caused by the negligence of Contractor and/or its servants, agents, nominees, assignees, contractors and sub-contractors. Company shall protect, defend indemnify and hold harmless Contractor from and against such liabilities and any suit, claim or expense resulting there from.
- **31.7** The Company agrees to waive its right of recourse and further agrees to cause its underwriters to waive their right of subrogation against Contractor and/or its underwriters, servants, agents, nominees, assignees, Contractors and sub-contractors for loss or damage to the equipment of Company and/or its contractors or sub-contractors when such loss or damage or liabilities arises out of or in connection with the performance of the contract.
- **31.8** The Company hereby further agrees to waive its right of recourse and agrees to cause it underwriters to waive their right of subrogation against Contractor and/or its underwriters, servants, agents, nominees, assignees, Contractors and sub-contractors for injury to, illness or death of any employee of the Company and of its Contractors, sub-contractors and/or their employees when such injury, illness or death arises out of or in connection with the performance of the Contract.

#### 31.9 <u>LIMITATION OF LIABILITY</u>

Notwithstanding any other provisions except only in cases of willful misconduct and/or criminal acts,

- (a) Neither the Contractor nor the Company (OIL) shall be liable to the other, whether in Contract, tort, or otherwise, for any consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs.
- **(b)** Notwithstanding any other provisions incorporated elsewhere in the contract, the aggregate liability of the Contractor in respect of this contract, whether under Contract, in tort or otherwise, shall not exceed 100% of the Contract price, provided however that this limitation shall not apply to the cost of repairing or replacing defective equipment by the Contractor, or to any obligation of the Contractor to indemnify the Company with respect to Intellectual Property Rights.

Company shall indemnify and keep indemnified Contractor harmless from and against any and all claims, costs, losses and liabilities in excess of the aggregate liability amount in terms of clause (b) above.

#### 32.0 CONSEQUENTIAL DAMAGE:

Except as otherwise expressly provided, neither party shall be liable to the other for special, indirect or consequential damages resulting from or arising out of the contract,

including but without limitation, to loss or profit or business interruptions, howsoever caused and regardless of whether such loss or damage was caused by the negligence (either sole or concurrent) of either party, its employees, agents or sub-contractors.

#### 33.0 INDEMNITY AGREEMENT:

- **33.1** Except as provided hereof Contractor agrees to protect, defend, indemnify and hold Company harmless from and against all claims, suits, demands and causes of action, liabilities, expenses, cost, liens and judgments of every kind and character, without limit, which may arise in favour of Contractor's employees, agents, Contractors and subcontractors or their employees on account of bodily injury or death, or damage to personnel/property as a result of the operations contemplated hereby, regardless of whether or not said claims, demands or causes of action arise out of the negligence or otherwise, in whole or in part or other faults.
- **33.2** Except as provided hereof Company agrees to protect, defend, indemnify and hold Contractor harmless from and against all claims, suits, demands and causes of action, liabilities, expenses, cost, liens and judgments of every kind and character, without limit, which may arise in favour of Company's employees, agents, Contractor and subcontractors or their employees on account of bodily injury or death, or damage to personnel/property as a result of the operations contemplated hereby, regardless of whether or not said claims, demands or causes of action arise out of the negligence or otherwise, in whole or in part or other faults.

#### 34.0 APPLICABLE LAW:

- **34.1** This Contract shall be deemed to be a Contract made under, governed by and construed in accordance with the laws of India for the time being in force and shall be subject to the exclusive jurisdiction of Courts situated at Dibrugarh in Assam.
- **34.2** The Bidders shall ensure full compliance of various Indian Laws and Statutory Regulations, to the extent applicable for performing under this Contract.

#### 35.0 TAXES:

**35.1** Tax levied as per the provisions of Indian Income Tax Act and any other enactment/rules on income derived/payments received under the contract will be on Contractor's account.

#### **36.0 SUBSEQUENTLY ENACTED LAWS:**

**36.1** In the event of introduction of any new legislation or any change or amendment or enforcement of any Act or Law, rules or regulations of Government of India or State Government(s) or Public Body which becomes effective after the date of submission of Price Bid or revised price bid, if any, for this CONTRACT and which results in increased/decreased cost of the works under the **CONTRACT** increased/decreased liability of taxes, (other than personnel and Corporate taxes), duties, the Parties shall agree to a revision in pricing to reflect such change subject to the production of documentary proof to the satisfaction of the COMPANY/CONTRACTOR as applicable to the extent which directly is attributable to such introduction of new legislation or change or amendment as mentioned above and adjudication by the

competent authority (applicable when disputed by COMPANY) & the courts wherever levy of such taxes/duties are disputed by COMPANY/CONTRACTOR.

- **36.2** Any increase in net amount of the duties and taxes (i.e. the amount of taxes/duties payable minus eligible credit of taxes/duties paid on input services/inputs) after the contractual completion/mobilization date during the extended period will be to the contractor's account, where delay in completion /mobilization period is attributable to the CONTRACTOR. However, any decrease in net amount of the duties and taxes (i.e. the amount of taxes/duties payable minus eligible credit of taxes / duties paid on input services/inputs) after the contractual completion/mobilization date will be to COMPANY's account.
- **36.3** The Contract Price and other prices given in the Schedule of Prices are based on the applicable tariff as indicated by the CONTRACTOR in the Schedule of Prices. In case this information subsequently proves to be wrong, incorrect or misleading, COMPANY will have no liability to reimburse/pay to the CONTRACTOR the excess duties, taxes, fees, if any finally levied/imposed by the concerned authorities. However, in such an event, COMPANY will have the right to recover the difference in case the rate of duty/tax finally assessed is on the lower side.
- **36.4** Notwithstanding the provision contained in clause 28.1 to 28.2 above, the COMPANY shall not bear any liability in respect of:
  - i. Personal taxes on the personnel deployed by CONTRACTOR, his sub-contractor / sub-sub-contractors and Agents etc.
  - ii. Corporate taxes and Fringe benefit tax in respect of contractor and all of their subcontractors, agents etc.
  - iii. Other taxes & duties including Customs Duty, Excise Duty and Service Tax in addition to new taxes etc. in respect of sub-contractors, vendors, agents etc. of the CONTRACTOR.
- **36.5** In order to ascertain the net impact of the revisions/enactment of various provisions of taxes / duties, the CONTRACTOR is liable to provide following disclosure to COMPANY:
  - i. Details of each of the input services used in relation to providing service to COMPANY including estimated monthly value of input service and service tax amount.
  - ii. Details of Inputs (material/consumable) used/required for providing service to Company including estimated monthly value of input and excise duty/CVD paid/payable on purchase of inputs.

#### 37.0 GOODS AND SERVICES TAX:

#### 37.1 GENERAL REMARKS ON TAXES & DUTIES:

In view of **GST** Implementation from 1st July 2017, all taxes and duties including Excise Duty, CST/VAT, Service tax, Entry Tax and other indirect taxes and duties have been submerged in **GST**. Accordingly reference of Excise Duty, Service Tax, VAT, Sales Tax, Entry Tax or any other form of indirect tax except of **GST** mentioned in the bidding document shall be ignored.

- **37.2** Bidders are required to submit copy of the GST Registration Certificate while submitting the bids wherever **GST** (CGST & SGST/UTGST or IGST) is applicable.
- **37.3** "**GST**" shall mean Goods and Services Tax charged on the supply of material(s) and services. The term "**GST**" shall be construed to include the Integrated Goods and Services Tax (hereinafter referred to as "IGST") or Central Goods and Services Tax (hereinafter referred to as "CGST") or State Goods and Services Tax (hereinafter referred to as "SGST") or Union Territory Goods and Services Tax (hereinafter referred to as "UTGST") depending upon the import / interstate or intrastate supplies, as the case may be. It shall also mean GST compensation Cess, if applicable.
- **37.4** Quoted price/rate(s) should be inclusive of all taxes and duties, except **GST** (i.e. **IGST or CGST and SGST/UTGST applicable in case of interstate supply or intra state supply respectively and cess on <b>GST if applicable) on the final service**. However, GST rate (including cess) to be provided in the respective places in the Price Bid. Please note that the responsibility of payment of GST (CGST & SGST or IGST or UTGST) lies with the Supplier of Goods / Services (Service Provider) only. Supplier of Goods / Services (Service Provider) providing taxable service shall issue an Invoice/ Bill, as the case may be as per rules/ regulation of **GST**. Further, returns and details required to be filled under GST laws & rules should be timely filed by Supplier of Goods / Services (Service Provider) with requisite details.
- **37.4.1** Bidder should also mention the **Harmonised System of Nomenclature** (HSN) and **Service Accounting Codes (SAC)** at the designated place in SOR.
- 37.5 Where the OIL is entitled to avail the input tax credit of GST:
- **37.5.1** OIL will reimburse the **GST** to the Supplier of Goods / Services (Service Provider) at actuals against submission of Invoices as per format specified in rules/ regulation of GST to enable OIL to claim input tax credit of **GST** paid. In case of any variation in the executed quantities, the amount on which the **GST** is applicable shall be modified in same proportion. Returns and details required to be filled under GST laws & rules should be timely filed by supplier with requisite details.
- **37.5.2** The input tax credit of **GST** quoted shall be considered for evaluation of bids, as per evaluation criteria of tender document.
- 37.6 Where the OIL is not entitled to avail/take the full Input Tax Credit of GST:
- **37.6.1** OIL will reimburse **GST** to the Supplier of Goods / Services (Service Provider) at actuals against submission of Invoices as per format specified in rules/ regulation of **GST** subject to the ceiling amount of **GST** as quoted by the bidder. In case of any variation in the executed quantities (If directed and/or certified by the In-Charge) the ceiling amount on which **GST** is applicable will be modified on pro-rata basis.
- **37.6.2** The bids will be evaluated based on total price including **GST**.
- **37.7** Payments to Service Provider for claiming **GST** amount will be made provided the above formalities are fulfilled. Further, OIL may seek copies of challan and certificate from Chartered Accountant for deposit of **GST** collected from OIL.

- **37.8** Contractor/vendor shall be required to issue tax invoice in accordance with GST Act and/or Rules so that input credit can be availed by OIL. In the event that the contractor / vendor fails to provide the invoice in the form and manner prescribed under the GST Act read with GST Invoicing Rules thereunder, OIL shall not be liable to make any payment on account of **GST** against such invoice.
- **37.9 GST** shall be paid against receipt of tax invoice and proof of payment of **GST** to government. In case of non-receipt of tax invoice or non-payment of **GST** by the contractor/vendor, OIL shall withhold the payment of **GST**.
- **37.10 GST** payable under reverse charge mechanism for specified services or goods under GST act or rules, if any, shall not be paid to the contractor/vendor but will be directly deposited to the government by OIL.
- **37.11** Where OIL has the obligation to discharge **GST** liability under reverse charge mechanism and OIL has paid or is /liable to pay **GST** to the Government on which interest or penalties becomes payable as per GST laws for any reason which is not attributable to OIL or ITC with respect to such payments is not available to OIL for any reason which is not attributable to OIL, then OIL shall be entitled to deduct/ setoff / recover such amounts against any amounts paid or payable by OIL to Contractor / Supplier.
- **37.12** Notwithstanding anything contained anywhere in the Agreement, in the event that the input tax credit of the **GST** charged by the Contractor / Vendor is denied by the tax authorities to OIL for reasons attributable to Contractor / Vendor, OIL shall be entitled to recover such amount from the Contractor / Vendor by way of adjustment from the next invoice. In addition to the amount of **GST**, OIL shall also be entitled to recover interest at the rate prescribed under GST Act and penalty, in case any penalty is imposed by the tax authorities on OIL.
- **37.13** TDS under GST, if applicable, shall be deducted from contractor's/vendor's bill at applicable rate and a certificate as per rules for tax so deducted shall be provided to the contractor/vendor.
- **37.14** The Contractor will be under obligation for charging correct rate of tax as prescribed under the respective tax laws. Further the Contractor shall avail and pass on benefits of all exemptions/concessions available under tax laws. Any error of interpretation of applicability of taxes/ duties by the contractor shall be to contractor's account.
- **37.15** It is the responsibility of the bidder to quote the correct GST rate. The classification of goods/services as per GST (Goods & Service Tax) Act should be correctly done by the contractor to ensure that input tax credit on GST (Goods & Service Tax) is not lost to the OIL on account of any error on the part of the contractor.
- **37.16** In case, the quoted information related to various taxes, duties & levies subsequently proves wrong, incorrect or misleading, OIL will have no liability to reimburse the difference in the duty/ tax, if the finally assessed amount is on the higher side and OIL will have to right to recover the difference and in case the rate of duty/ taxes finally assessed is on the lower side.

- **37.17** Notwithstanding anything mentioned elsewhere in the Bidding Document the aggregate liability of OIL towards Payment of GST shall be limited to the volume of GST declared by the bidder in its bid & nothing shall be payable extra except for the statutory variation in GST.
- **37.18** Further, it is the responsibility of the bidders to make all possible efforts to make their accounting / IT system GST compliant in order to ensure availability of Input Tax Credit (ITC) to Oil India Ltd.
- **37.19** GST liability, if any on account of supply of free samples against any tender shall be to bidder's account.
- **37.20** In case of statutory variation in **GST**, other than due to change in turnover, payable on the contract value during contract period, the Supplier of Goods / Services (Service Provider) shall submit a copy of the 'Government Notification' to substantiate the rate as applicable on the Bid due date and on the date of revision.

Beyond the contract period, in case OIL is not entitled for input tax credit of **GST**, then any increase in the rate of **GST** beyond the contractual delivery period shall be to Service provider's account whereas any decrease in the rate **GST** shall be passed on to the OIL. Beyond the contract period, in case OIL is entitled for input tax credit of **GST**, then statutory variation in applicable **GST** on supply and on incidental services, shall be to OIL's account.

Claim for payment of **GST**/ Statutory variation, should be raised within two [02] months from the date of issue of 'Government Notification' for payment of differential (in %) **GST**, otherwise claim in respect of above shall not be entertained for payment of arrears.

The base date for the purpose of applying statutory variation shall be the Bid Opening Date.

- **37.21** The contractor will be liable to ensure to have registered with the respective tax authorities, wherever applicable and to submit self-attested copy of such registration certificate(s) and the Contractor will be responsible for procurement of material in its own registration (GSTIN) and also to issue its own Road Permit/ E-way Bill, if applicable etc.
- **37.22** In case the bidder is covered under Composition Scheme under GST laws, then bidder should quote the price inclusive of the GST (CGST & SGST/UTGST or IGST). Further, such bidder should mention "Cover under composition system" in column for GST (CGST & SGST/UTGST or IGST) of price schedule.
- **37.23** OIL will prefer to deal with registered supplier of goods/ services under GST. Therefore, bidders are requested to get themselves registered under GST, if not registered yet. However, in case any unregistered bidder is submitting their bid, their prices will be loaded with applicable GST while evaluation of bid. Where OIL is entitled for input credit of GST, the same will be considered for evaluation of bid as per evaluation methodology of tender document.

**37.24** Procurement of Specific Goods: Earlier, there is no tax incidence in case of import of specified goods (i.e. the goods covered under List-34 of Customs Notification no. 12/2012-Cus dated. 17.03.2012 as amended). Customs duty is not payable as per the policy. However, under GST regime, IGST Plus GST compensation cess (if applicable) would be liveable on such imports. Bidders should quote GST as inclusive considering IGST component for the imported Materials portion while quoting their prices on destination basis. However, GST rate to be specified in the price bid format.

#### 37.25 Documentation requirement for GST:

The vendor will be under the obligation for invoicing correct tax rate of tax/duties as prescribed under the GST law to OIL, and pass on the benefits, if any, after availing input tax credit.

Any invoice issued shall contain the following particulars:

- a) Name, address and GSTIN of the supplier;
- b) Serial number of the invoice;
- c) Date of issue;
- d) Name, address and GSTIN or UIN, if registered of the recipient;
- e) Name and address of the recipient and the address of the delivery, along with the State and its code,
- f) HSN code of goods or Accounting Code of services[SAC];
- g) Description of goods or services;
- h) Quantity in case of goods and unit or Unique Quantity Code thereof;
- i) Total value of supply of goods or services or both;
- j) Taxable value of supply of goods or services or both taking into discount or abatement if any;
- k) Rate of tax (IGST, CGST, SGST/ UTGST, cess);
- Amount of tax charged in respect of taxable goods or services (IGST, CGST, SGST/UTGST, cess);
- m) Place of supply along with the name of State, in case of supply in the course of interstate trade or commerce;
- n) Address of the delivery where the same is different from the place of supply and
- o) Signature or digital signature of the supplier or his authorised representative. GST invoice shall be prepared in triplicate, in case of supply of goods, in the following manner
  - i) The original copy being marked as ORIGINAL FOR RECIPIENT;
  - ii) The duplicate copy being marked as DUPLICATE FOR TRANSPORTER and
  - iii) The triplicate copy being marked as TRIPLICATE FOR SUPPLIER.

In case of any advance given against any supplies contract, the supplier of the goods shall issue Receipt Voucher containing the details of details of advance taken along with particulars as mentioned in clause no. (a), (b), (c), (d), (g), (k), (l), (m) & (o) above.

#### 37.26 ANTI-PROFITEERING CLAUSE:

As per Clause 171 of GST Act it is mandatory to pass on the benefit due to reduction in rate of tax or from input tax credit to the consumer by way of commensurate reduction in prices. The Supplier of Goods / Services may note the above and quote their prices accordingly.

**37.26.1** In case the GST rating of vendor on the GST portal / Govt. official website is negative / black listed, then the bids may be rejected by OIL. Further, in case rating of bidder is negative / black listed after award of work for supply of goods / services, then OIL shall not be obligated or liable to pay or reimburse GST to such vendor and shall also be entitled to deduct / recover such GST along with all penalties / interest, if any, incurred by OIL.

## 38.0 WITHHOLDING:

Company may withhold or nullify the whole or any part of the amount due to Contractor, after informing the Contractor of the reasons in writing, on account of subsequently discovered evidence in order to protect Company from loss on account of:

- a) For non-completion of jobs.
- b) Contractor's indebtedness arising out of execution of this Contract.
- c) Defective work not remedied by Contractor.
- d) Claims by sub-Contractor of Contractor or others filed or on the basis of reasonable evidence indicating probable filing of such claims against Contractor.
- e) Failure of Contractor to pay or provide for the payment of salaries/ wages, contributions, unemployment compensation, taxes or enforced savings with-held from wages etc.
- f) Failure of Contractor to pay the cost of removal of unnecessary debris, materials, tools, or machinery.
- g) Damage to another Contractor of Company.
- h) All claims against Contractor for damages and injuries, and/or for non-payment of bills etc.
- i) Any failure by Contractor to fully reimburse Company under any of the indemnification provisions of this Contract. If, during the progress of the work Contractor shall allow any indebtedness to accrue for which Company, under any circumstances in the opinion of Company may be primarily or contingently liable or ultimately responsible and Contractor shall, within five days after demand is made by Company, fail to pay and discharge such indebtedness, then Company may during the period for which such indebtedness shall remain unpaid, with-hold from the amounts due to Contractor, a sum equal to the amount of such unpaid indebtedness.

Withholding will also be effected on account of the following:

- i) Order issued by a Court of Law in India.
- ii) Income-tax deductible at source according to law prevalent from time to time in the country.
- iii) Any obligation of Contractor which by any law prevalent from time to time to be discharged by Company in the event of Contractor's failure to adhere to such laws.
- iv) Any payment due from Contractor in respect of unauthorized imports.

When all the above grounds for withholding payments shall be removed, payment shall thereafter be made for amounts so with-hold.

## **PART-I GCC**

Notwithstanding the foregoing, the right of Company to withhold shall be limited to damages, claims and failure on the part of Contractor, which is directly/indirectly related to some negligent act or omission on the part of Contractor.

#### SPECIAL TERMS & CONDITIONS & SCOPE OF WORK

**DESCRIPTION OF WORK/ SERVICES:** Hiring services for designing of 02 (two) Nos. of Sewage Treatment Plants (STPs) for Duliajan Township along with supervisory services during construction phase of the STPs, if required.

#### 1.0 PREAMBLE:

- **1.1 General:** Duliajan is an industrial township located in Dibrugarh District in the upper north-east corner of India. The town is situated about 45 km east of Dibrugarh City. It is particularly known for its oil related industries; Oil India Limited (OIL), country's second largest oil and gas Navaratna PSU is headquartered in Duliajan and Assam Gas Company Limited, which carries out business related to natural gas in India, owned by the Government of Assam.
- **1.2 Geographical Location & Climate:** Situated in 27.3667° N, 95.3167° E, in Duliajan, the climate is moderate. In winter there is much less rainfall than in summer. The average annual temperature in Duliajan is 23.2 °C. The average annual rainfall is 2528 mm. The driest month is December with 21 mm. Most precipitation falls in July, with an average of 489 mm. The warmest month of the year is August with an average temperature of 27.8 °C. In January, the average temperature is 16.1 °C. It is the lowest average temperature of the whole year.

## 1.3 Brief About Drainage & Sewage at Duliajan:

- a. In Duliajan, domestic/household sewage mixed with Effluent coming out ETPs of OIL Hospital, oil traps of Industrial Area, effluent & sewage of AGCL are discharged through two leader drains. The Main Leader Drain (MLD) caters to sewage of OIL's residential area, Effluent of OIL Hospital, Effluent of Industrial Area, effluent & sewage of AGCL and almost all sewage of private residential areas of Duliajan. The sewage carried by MLD is discharged into the river Burhi Dihing at Tipling.
- b. The Bijulibari Leader Drain (BLD) originating from CT/BT area of OIL's housing area caters to the sewage of OIL's residential area along the drain and sewage of private residential/commercial areas of daily bazaar area. The sewage carried by BLD is discharged into the Hugrijan Nullah.
- **1.4** As per the preliminary studies carried out in the MLD & BLD, the types of sewage / effluent / waste discharged by these Drainage systems can be chiefly classified as below:
  - a. Greywater (from sinks, tubs, showers, and clothes washers)
  - b. Blackwater (the water used to flush toilets, combined with the human waste that it flushes away)
  - c. Soaps and Detergents
  - d. Hospital Effluent (discharged from OIL Hospital's ETP)
  - e. Market Solid Waste (disposed from various markets along the RoW of the MLD)
  - f. Industrial Effluent (discharged from oil traps of Industrial Area and the branch drain from AGCL)
  - g. Human excreta (discharged from numerous service latrines along the RoW of the MLD)
  - h. Surface run offs containing solid wastes during rains.

## 2.0 SEWAGE TREATMENT PLANTS FOR DULIAJAN TOWNSHIP:

Oil India Limited (OIL) intends to establish 02 (two) Sewage Treatment Plants (STP) for Waste Water Treatment generated from OIL's Duliajan Township. The present system of discharge of sewage and effluent into the two main leader drains only, viz: Main Leader Drain (MLD) and Bijulibari Leader Drain (BLD) presents an advantageous option as far as Sewage treatment is concerned. Since no other discharge / outlet points of sewage to surface waters (i.e. the river Burhi Dihing & Hugrijan Nullah) exists, setting up of Centralized STPs near the discharge points is envisaged as the easy solution for the Sewage Management of Duliajan. However, since it is observed that there is rampant disposal of Municipal Solid Waste (MSW) in to the MLD, management of collected MSW at the STP should also be taken in account while designing any STP.

#### 2.1 Land for STPs:

- a) A plot of land measuring approximately 37 Bighas had been procured for setting up of an STP at Tipling near Duliajan. The plot of land is strategically located very near to the discharge point of MLD to the river Burhi Dihing. The plot plant of this is enclosed. (OIL Drawing No: OIL 1655)
- b) However, there is no plot of land earmarked for setting up of STP for BLD. The plot for setting up the STP for BLD is to be selected/ identified.

# 2.2 "Plan of Action" for Setting up the Sewage Treatment Plant for Duliajan Township:

The Project is proposed to be undertaken in two distinct phases as below:

- a) <u>Phase-I</u>: To undertake a study including survey of the present Sewage discharge system of Duliajan Township for designing Sewage Treatment Plants for the town by engagement of a Project Management Consultant (PMC) through Open Tendering Process. On completion of the study, the infrastructure required for sustaining Sewage Treatment for the next 30 (Thirty) years shall be reviewed and designed accordingly.
- b) <u>Phase-II</u>: On completion of Phase-I of the Project, Execution (Construction) of the Infrastructure shall be taken up in Phase-II of the Project by engagement of independent LSTK Contractor(s) through open tendering process, based on the design input of the Consultant engaged in Phase-I.

As the Construction phase during Phase-II of the Project shall be as per the design input of the Consultant, therefore, OIL at its own discretion may engage the Consultant for Supervision during Phase-II of the Project as per the requirement of OIL (detailed under **Sub-head 3.2**).

#### NOTE:

- The supervision by the consultant during Phase-II of the Project shall be an "Optional Item" to be executed at the sole discretion of the Company.
- The Consultant engaged during Phase I of the Project shall not be eligible to bid for Phase II as Construction Contractor.

**2.3 Period of Phase-I:** The total duration of Phase-I shall be 02 (Two) Years and 06 (Six) Months. The study for designing the STPs is to be carried out over a period of 02 (two) consecutive years starting from date of issue of Work Order.

#### 3.0 BRIEF SCOPE OF WORK AND ROLE OF CONSULTANT:

The brief scope of work of the consultant is as follows:

#### 3.1 SCOPE OF WORK FOR PHASE-I:

## **3.1.1** Survey, Study and determination of Capacities of both the STPs:

The following steps are to be followed during the Survey and Study:

- a) Estimation for the Sewage Generation of the Township for a horizon of next thirty years: The quantity of sewage generation is to be estimated for the time horizon of next thirty years. The present sewage generation can be established by measuring the quantity of sewage being carried through the drainage system. For other data, field survey / questionnaire survey in the Duliajan Township may be required to be carried out. Other required data like population projections etc. are to be sourced by the Consultant. OIL is having expansion plan for its township and the nearby installations. The data pertaining to the expansion plan shall be made available to the Consultant by OIL.
- b) Chemical analysis of sewage samples: The sewage samples shall to be collected throughout two years at each of strategic locations as jointly identified by OIL and the consultant, at the interval of 15 days, following proper sampling procedure. The quality of sewage being discharged by the MLD & BLD drainage systems is to be measured / monitored at minimum 10 (Ten) Different locations along the MLD and Five (05) different Locations along the BLD. The collected samples shall to be analyzed in NABL / CPCB / PCBA accredited / approved laboratories for parameter specified by CPCB / PCBA.
- c) Selection of Land for Establishment of Sewage Treatment Plant of BLD: The Consultant shall have to identify / select suitable plots of lands along the BLD for establishment of a Sewage Treatment Plant. More than one plot of Land is to be identified for establishment of Sewage Treatment Plant for BLD. The Plot plans of the Lands selected/identified for establishment of the Sewage Treatment Plant is submitted to OIL in proper scaled Plot Plans in Both Digital and Hard form by the Consultant.
- d) Based on the results of Step (a) & (b) above, the capacity of STPs for both MLD and BLD to be finalized for a horizon of next thirty years. The same has to be done in consultation with OIL and the same to be approved by OIL.

#### **3.1.2** Designing of STP for MLD:

- 1. <u>Basic Engineering Design Package</u>: The basic engineering design for both the plants should include (but not limited to):
- a) Conceptual process studies (material balances, process flowsheets preliminary plot plan, etc.).
- b) The various treatment processes/sub-processes and units for production of biologically and chemically safe water for discharge as per the latest ISO Standard/CPCB Norms.

- c) Preliminary Piping and Instrument Design and Diagrams,
- d) Preliminary Electrical Design & Diagram for complete package of Electrical Power System
- e) Definition and sizing of main equipment resulting in process specifications, specification of effluents.
- f) Definition of control and safety devices etc.
- g) Regulations concerning environmental pollution (air, disposal, noise etc.)
- h) Other requirement such as General design information for the buildings, insulation, painting, fire proofing etc.
- i) Effluent summary tables: All gaseous, liquid effluents and solid waste showing quantities and qualities of impurities which are object of control (sulfur, phenol, oil, BOD, COD, etc.) shall be tabulated to facilitate determining the environmental impact of the project.
- j) Safety: The following requirements shall be included:
  - i) Specifications, fire rating and identification of areas for fire proofing.
  - ii) Recommendation for fire-fighting facilities required for process Unit(s) and storage areas including rate of water/foam required, cooling system, deluge valve requirements and identification of the areas which require it.
  - iii) Recommendation for firefighting facilities as well as provision of blast proof walls and/or roof for control room.
  - iv) Recommendations for handling/storage of various chemicals, catalysts, hazardous materials etc.
  - v) Number and location of safety showers, eye washes, fire hydrants, etc.
  - vi) Proposed methods of fire-fighting for different types of fires.
  - vii) The HSE management Plan is to be prepared in consultation with OIL and submitted to OIL by the Consultant.
  - viii) The HSE monitoring plan in the plant during its construction phase and thereafter is to be prepared in consultation with OIL and submitted to OIL.
  - ix) Any other specific safety requirement.
- k) Hazardous area classification: It shall indicate the sources of hazards and the extent of hazardous areas, providing area classifications for the selection of electrical equipment.
- l) Resins, chemicals, solvents and catalysts: The following information shall be prepared for each chemicals/resins/catalyst, solvents/inhibitors/packing and solid absorbent employed in the process:
  - i) Service
  - ii) Name or Designation
  - iii) Initial fill quantity
  - iv) Estimated annual consumption
  - v) Physical properties
  - vi) Loading, unloading and make up procedures
  - vii) Probable acceptable manufacturer/suppliers
  - viii) Volume required
  - ix) Density

- x) Pellet or grain size and shape
- xi) Design life/ shelf life (if any)
- xii) Regeneration characteristics
- xiii) Any specific warehousing requirement
- xiv) MSDS

Generally speaking, all the basic studies required supporting a Basic Engineering Design Package (BEDP) containing all data needed by a competent contractor to perform the Detail Engineering. The draft Basic Engineering design will have to be submitted to OIL for approval.

- 2. <u>Front End Engineering Design Package</u>: On completion and approval of the Basic Engineering Design of the Plants by OIL, the Consultant shall proceed with the Front End Design for both the Plants covering:
- a) Mechanical data sheets of the main equipment, starting from the process specifications issued during the BED and incorporating the specific requirements of codes and standards to be applied to the project in question.
- b) Preparation of tender packages for the main equipment.
- c) Development of process and utility Piping and including piping material, classification, lay-out, fittings, valves, etc.
- d) Instrument Diagrams released for detail engineering including Distributed Control System (DCS)/ PLC, and all instrumentation systems and equipment such as alarms and shut-down systems, analyzers, transmitters, differential pressure elements, thermometers, thermocouples, level gages, pressure gages, control valves, measuring devices, cables, computer, etc.
- e) Elaboration of the civil works layouts including specifications for concrete, paving, stairs, platforms, structures, buildings, site preparations, rough gradings, foundations, painting etc.
- f) Sufficient process design data such as heat and material balance tables, required calculations and mechanical design data shall be supplied so as to perform detail design and procurement of the items. Standard engineering specifications and drawings for the detailed design of the specific Unit shall be provided. The engineering standards/specifications shall have to be provided to define the basic requirements for design and engineering, vendor selection, procurement, manufacturing, inspection and installation of the equipment and materials.
- g) Details of Complete HSE package including fire protection system etc.

And, generally speaking, all the studies to be performed before ordering the main equipment.

#### NOTE:

The following are to be taken note by the Consultant during designing phase of the Sewage Treatment Plants:

- i) The design of the Sewage Treatment Plant including the augmentation phase is to be carried out in consultation with OIL. The design is to be based on modern and state of the art technology design inputs.
- ii) The plant designs developed should be based upon sound engineering principles and should be flexible to future conditions, emergency situations, operating personnel capabilities and future expansion.
- iii) Being an E&P Company, OIL comes under the purview of OISD Safety Standards. These safety standards should also be taken into account during designing of the new plant.
- iv) Available Drawing/Information of the existing Sewage Discharge System shall be made available to the Consultant on award of the Contract for guidance only. However, the Consultant shall be required to study the discharge system and on completion of the study shall be required to submit drawing of the system.
- v) The volume and quality of sewage being discharged by the drainage system is to be measured/ monitored at minimum 10 (Ten) Different locations along the MLD and minimum Five (05) different Locations along the BLD. The locations shall be jointly identified by the Consultant and OIL. The number of Locations as above is indicative only; the final number of locations may increase.
- vi) The design should include complete package of Electrical Power Supply system. The Electrical design package should include Power Supply from independent Captive Power Plant to be set up inside the premises of the Plants as well as Electrical Power Supply from the existing main source of OIL/ASEB. Necessary provision for Black Start DG set if required should also be incorporated. Details of OIL's Electrical Power Supply source(s) available near the Plant Sites shall be intimated by OIL during design phase.
- vii) All the relevant statutory & applicable clearances have to be obtained by the Consultant on behalf of OIL. The permission for water withdrawal from river (if required) or withdrawal of ground water (if required) to be used for operation of the Sewage Treatment Plants is also to be obtained by the Consultant on behalf of OIL. During Phase-I of the Project, the Consultant is to identify all the relevant & applicable clearance to be obtained and also identify the statutory/Govt. authority for the same.
- viii) As the execution (construction) of the shall be taken up in Phase-II of the Project, as per the "Detail Project Report" of the Consultant, therefore OIL at its own discretion may engage the consultant for supervision during Phase-II of the Project.

#### **3.1.3** Designing of STP for BLD:

The job involves selection of Preliminary, Primary, Secondary & Tertiary treatment Technology and also the identification and selection of Residue Management system based on the findings of the Item no A. as detailed above. The selection of technology should encompass techno economic feasibility study with emphasis on power requirement and the Statutory Norms for discharge of treated sewage into the Hugrijan Nullah. The consultant should design both:

- A. Basic Engineering Design Package and
- B. Front End Engineering Design Package

**NOTE:** The designing should include all activities starting from diversion of Sewage from Bijulibari Leader Drain (BLD) to the STP till final disposal onto the Hugrijan Nullah.

- 1. <u>Basic Engineering Design Package:</u> The basic engineering design for both the plants should include (but not limited to):
- a) Conceptual process studies (material balances, process flowsheets preliminary plot plan, etc.).
- b) The various treatment processes/sub-processes and units for production of biologically and chemically safe water for discharge as per the latest ISO Standard / CPCB Norms.
- c) Preliminary Piping and Instrument Design and Diagrams,
- d) Preliminary Electrical Design & Diagram for complete package of Electrical Power System
- e) Definition and sizing of main equipment resulting in process specifications, specification of effluents.
- f) Definition of control and safety devices etc.
- g) Regulations concerning environmental pollution (air, disposal, noise etc.)
- h) Other requirement such as General design information for the buildings, insulation, painting, fire proofing etc.
- i) Effluent summary tables: All gaseous, liquid effluents and solid waste showing quantities and qualities of impurities which are object of control (sulfur, phenol, oil, BOD, COD, etc.) shall be tabulated to facilitate determining the environmental impact of the project.
- j) Safety: The following requirements shall be included:
  - i. Specifications, fire rating and identification of areas for fire proofing.
  - ii. Recommendation for fire-fighting facilities required for process Unit(s) and storage areas including rate of water/foam required, cooling system, deluge valve requirements and identification of the areas which require it.

- 2. <u>Front End Engineering Design Package:</u> On completion and approval of the Basic Engineering Design of the Plants by OIL, the Consultant shall proceed with the Front End Design for both the Plants covering:
- a) Mechanical data sheets of the main equipment, starting from the process specifications issued during the BED and incorporating the specific requirements of codes and standards to be applied to the project in question.
- b) Preparation of tender packages for the main equipment.
- c) Development of process and utility Piping and including piping material, classification, lay-out, fittings, valves, etc.
- d) Instrument Diagrams released for detail engineering including Distributed Control System (DCS)/ PLC, and all instrumentation systems and equipment such as alarms and shut-down systems, analyzers, transmitters, differential pressure elements, thermometers, thermocouples, level gages, pressure gages, control valves, measuring devices, cables, computer, etc.
- e) Elaboration of the civil works layouts including specifications for concrete, paving, stairs, platforms, structures, buildings, site preparations, rough gradings, foundations, painting etc.

#### NOTE:

The following are to be taken note by the Consultant during designing phase of the Sewage Treatment Plants:

- i) The design of the Sewage Treatment Plant including the augmentation phase is to be carried out in consultation with OIL. The design is to be based on modern and state of the art technology design inputs.
- ii) The plant designs developed should be based upon sound engineering principles and should be flexible to future conditions, emergency situations, operating personnel capabilities and future expansion.
- iii) Being an E &P Company, OIL comes under the purview of OISD Safety Standards. These safety standards should also be taken into account during designing of the new plant.

- vi) The number of Locations as above is indicative only; the final number of locations may increase.
- vii) The design should include complete package of Electrical Power Supply system. The Electrical design package should include Power Supply from independent Captive Power Plant to be set up inside the premises of the Plants as well as Electrical Power Supply from the existing main source of OIL/ASEB. Necessary provision for Black Start DG set if required should also be incorporated. Details of OIL's Electrical Power Supply source(s) available near the Plant Sites shall be intimated by OIL during design phase.
- viii) All the relevant statutory & applicable clearances have to be obtained by the Consultant on behalf of OIL. The permission for water withdrawal from river (if required) or withdrawal of ground water (if required) to be used for operation of the Sewage Treatment Plants is also to be obtained by the Consultant on behalf of OIL. During Phase-I of the Project, the Consultant is to identify all the relevant & applicable clearance to be obtained and also identify the statutory/Govt. authority for the same.

ix) As the execution (construction) of the shall be taken up in Phase-II of the Project, as per the "Detail Project Report" of the Consultant, therefore OIL at its own discretion may engage the consultant for supervision during Phase II of the Project.

#### **3.1.4** Formulation and Finalization of Tender Document for Phase-II of both the STPs:

The job involves formulation and Finalization of Tender Documents (with inputs from OIL) for engagement of EPC Contractor for actual construction of the STPs during Phase -II of the Project. The EPC contractor should carry out detailed engineering, procurement and construction of the Sewage Treatment Plants (STP). Operation and Maintenance of the plant for 05 (five) years shall also be under the EPC contractors scope. The draft Tender Document for Phase - II of both the STPs shall have to be submitted to OIL for review and approval.

## **3.1.5** Submission of Detailed Project Report:

- **A.** On completion of first year's study the Consultant shall have to submit Draft Detailed Project Reports for both the STPs supported by a presentation to OIL. The cost estimation for Phase-II of the project is to be included in the Draft Project Reports (for Budgetary Approval Purpose). The findings of the Draft Project Reports are to be validated/authenticated by data/information collected during the study conducted during the second year. Upon completion of the 02 (two) yearlong study, the Consultant is to submit the final Detailed Project Reports (DPR) for both the STPs supported by a presentation to OIL for due approval. The Detailed Project Report (DPR) should consist of the following inputs:
  - a) The details, result & recommendation of the study.
  - b) Based on the study the fixed Capacity of both the STPs.
  - c) The Selected Technology for both the STPs.
  - d) Basic Engineering Design and Front End Engineering Design for both the Sewage Treatment Plants. The designs should also include phase wise augmentation plan of the Sewage Treatment Plants for time horizon of next thirty years.
  - e) Tender Document, Bill of materials and Cost estimate for Phase-II of the Project for execution of Phase-II of the Project.
  - f) Details of Statutory Clearance for Construction, ie: execution of Phase-II of the Project.
  - g) Execution & Monitoring Plan for Phase II.
- **B.** The Detailed Project Report should include an Execution & Monitoring Plan. The Consultant shall provide an execution & monitoring plan describing how the Project will be organized, managed, executed and monitored during Phase-II. The description shall cover all aspects of the Project from award of Contract, thorough and including aspects of the Basic Design and the Detailed Engineering, Procurement/Tendering, construction, completion, commissioning and hand over of the Project, including but not limited to:
  - Organization chart including but not limited to key personnel to be deployed by the Contractor their line of duties and reporting positions.
  - Work plans for Basic Design, Detailed Engineering, Equipment procurement, and Project management.

#### NOTE:

- 1. The Consultant shall be required to design Sewage Treatment Plants for both MLD & BLD. The DPR shall have to be made for both the Sewage Treatment Plants independently. The Detailed Project Reports shall be initially submitted in the draft form supported by a presentation to the Company. During the presentation, deliberations on the draft Project Report shall be taken up and suggestions on the draft may be put forward by OIL to be included in the final Project Report. On completion of the presentation to be followed with discussion, the final Detailed Project Reports are to be submitted to the Company. 06 (Six) Hard Copies each of the Final DPRs is to be submitted and 01 (One) Soft Copy.
- 2. To get the exact details of the schedule of works, progress of the works and the completion time of Phase-II of the project, the Consultant shall submit the entire activities of the Phase-II of the project in MS Project-2007/ PrimaVera or equivalent software (Shall include Start Date, Free Float and Total Float with start to finish relationship in Gantt chart format of each activities of the project).
- 3. Consultant shall provide Schedule of Work by first filling the key dates for various major activities detailed in the "Project Schedule" for each item. A minimum period of 2 months shall be allocated beyond mechanical completion for product commissioning activities including various station energizations.
- 4. The detailed Schedule of Work shall be in the form of bar chart schedule or schedules covering all aspects of the Work, from award of Contract through to completion of commissioning of the Project including but not limited to, those aspects set forth in the attached Project Schedule. Consultant is encouraged to make aggressive and comprehensive schedule in the form of PERT/CP network with slacks for start/end of non-critical activities should also be provided.
- 5. Consultant is also to provide a man-hour loading curve, which should be in sequence with the aforesaid Project Schedule.

#### **3.1.6** Statutory Clearance for Construction and Operation:

The Consultant on OIL's behalf should arrange to obtain the necessary clearance for the Construction and Operation of both the Sewage Treatment Plants (STP) from the Statutory Bodies.

On submission of Statutory & all necessary document/information/data to the Statutory Bodies / Concerned Authorities for obtaining Clearance for Construction and Operation of both the STPs, the Phase-I of the Project shall be considered to be completed. The consultant has to submit documentary evidence against submission of the above to the concerned authorities.

#### 3.2 ROLE OF CONSULTANT DURING PHASE - II:

- **A.** The role of the Consultant during Phase-II of the Project shall be in supervisory category. The followings are to be noted by the Consultant with respect to supervision of Phase II of the Project:
- i) OIL at its discretion reserves the right to engage the Consultant in Supervisory role during Phase-II of the Project.
- ii) The Cost of Supervision during Phase-II of the Project is to be quoted by the Consultant during the tendering stage of Phase-I itself. This shall be considered during evaluation of the bids.
- iii) If the Consultant is engaged in Supervisory role during Phase-II of the Project, payment for Supervision shall be made to the Consultant during execution of Phase-II only and shall form a part of Phase-II of the Project.
- iv) The necessary budgetary provisioning and related issues may take 02 (two) years after completion of Phase-I to start the Phase-II, i.e. the actual construction of Sewage Treatment Plant (STP) at Duliajan.
- v) The start of Phase-II of the Project shall be notified by OIL in writing to the Consultant.
- vi) The construction period i.e. Phase-II of the Project is likely to take two years. However, this period shall be firmed up during Phase-I of the Project prior to submission of final "Detailed Project Reports."
- **B.** The brief role of Consultant if engaged by OIL should broadly be:
- I. Review / approval of design / drawings / documents submitted by contractor(s) / supplier(s): The Consultant shall ensure expeditious submission of data / drawings / designs by the Contractor and review the same within 10 days of receipt at Consultant's office. Incompleteness of data submitted by Contractor shall be clearly indicated by the Consultant. The Consultant shall endeavor to approve the data/drawings/designs submitted by Contractor in the shortest possible time but not later than 20 days from the date of receipt of first submission. Any delay beyond 20 days in approval of submissions made by Contractor shall be brought to the notice of OIL, along with reasons for the same. The approval of data/drawings/ designs by the Contractor should be in consultation with OIL.

#### II. Monitoring & control of project progress:

- i. The Consultant should be responsible for overall project management of Phase II of the project.
- ii. The Consultant should ensure compliance of all statutory requirements for Construction of Both the STPs.
- iii. Organize, plan, supervise and manage the construction activities as a whole. Overall project management services through project planning and control with responsibility for integrating all blocks, progress measurement and reporting of each Contract.

- iv. Interpretation of technical requirements set forth in the various contracts and issuance of such interpretation for the guidance of the contractors on behalf of owner and in response to communications from various contractors involved in the project.
- v. Responsibility for reviewing various documents for establishing contract procedures appropriate to the project and for ensuring contractors' compliance with those procedures in all respects while awarding subcontracts by maximizing Indian content whenever feasible.
- vi. To implement a structured & auditable Safety Management Plan at the Construction site and preventive measures against unsafe act / procedures.
- vii. Responsibility towards acceptance of job of each contractor.
- viii. Receiving and reviewing invoices, certifying payment to all contractors involved in the project and recommending to owner for payment.
- ix. Administration, on behalf of owner (if required), of all agreements/contracts executed towards implementation of the project.
- x. Adherence to health and safety factors as well as environmental protection measures as stipulated from time to time by Ministry of Environment & Forest, State Pollution Control Board and any other statutory body, during construction and commissioning.
- xi. The Consultant to ensure that the EPC Contractor obtains all necessary Statutory approvals for operation of construction related equipment (e.g., for movement of heavy equipment on roads and across railway crossings).

## III. Inspection and expediting:

The proper control of purchased materials includes both expediting and inspection of materials throughout the manufacturing cycle. Consultant shall perform (or assign to agreed third party) inspection and expediting of materials supplied from Indian / foreign sources.

OIL reserve the right to inspect the equipments at Manufacturer's work at its own cost.

#### IV. Construction supervision including certification of contractor's bills:

- i) Consultant shall manage and supervise other contractors' activities at site and coordinate with contractors, such that the construction of the Project is carried out by the contractors according to the procedures and quality assurance program agreed between Owner, Consultant and the Contractors.
- ii) Consultant shall be deemed to have full knowledge of the applicable codes and standards, laws and regulations, safety rules and regulations, conditions of labour, local conditions and environmental aspects in Assam and India, and shall comply with the requirements thereof where applicable.
- iii) Consultant shall assign construction specialists at site to ensure that the Project is built according to the time schedule and to approved codes and standards, specifications and drawings. These activities shall include, but not be limited to, the following:
  - Review and recommend to Owner on the adequacy of contractors' supervisory personnel, and craftsmen in terms of qualifications and numbers.

- Coordinate the activities of contractors and these respective subcontractors/vendors to ensure that their work plans are such that the subcontractors/vendors avoid interference with one another.
- Consultant shall review the approved construction plan on monthly basis. If any time lag is observed in the progress, consultant to analyze & advise party for additional steps to be taken to boost the job progress and make recommendations to owner on any action to be taken to maintain schedule.
- Review and recommend regularly on contractors' allocation of manpower and construction equipment.
- Review and approve, on Owner's behalf, contractors' work methods, with special emphasis on safety and quality.
- Review and approve the procedures proposed by contractors for the inspection by Consultant of each item of construction work and the witnessing by Consultant of each construction activity in so far as inspection and witnessing are required.
- Supervise, inspect and certify that quality of the contractors' work to ensure that all work is adequate for the purpose intended, is in accordance with good engineering and construction standards and practices, drawings and specification, and is in accordance with the quality assurance program and conforms with the contract provisions.
- Ensure that adequate records are maintained, so that expediting for rectification is made easy and systematic.
- Review and certify the contractors' claims. Certify and recommend to Owner on the progressive payments of the work according to the work completed.
- On behalf of Owner supervise and agree with contractors on a phased completion program, to facilitate a logical, mechanical completion program.
- Closing the all open purchase orders / work orders / contract to close project sites
- Review contractors' detailed proposals for the startup and the conduct of the performance tests, and advise Owner and the contractor accordingly to ensure that all the activities will be carried out in a safe and efficient manner.
- Supervise close-out of contractors' work and certify and make recommendations to Owner on the acceptance of construction completion certificates, mechanical completion certificates, provisional acceptance certificates and final acceptance certificates for the Project, by plant system unit and block as relevant.
- Report immediately about any use of materials not in accordance with the drawings, specification and contract, and supervise its removal from job site.
- Supervise all works required for modifications requested or approval by Owner in accordance with the Project procedures.
- Carry out HAZOP studies and ensure that actions have been taken based on asbuilt documentation.
- Review and recommend safety and labour relations procedures prepared by other contractors in line with all applicable codes, regulations and Owner requirements. Monitor safety and labour relations and take action on behalf of Owner on all problems, violations and inquiries.
- Inspect and record site activities and oversee that documentation is kept up-todate and in first rate condition in preparation for completion of the Project. Consultant shall ensure that all as- built drawings for the Project are recorded correctly and compiled and submitted by the contractors as stated in the contract. Consultant shall submit the same to Owner after approval.

### V. Safety, Health & Environment Management:

- i) It is Owner's objective policy to ensure that potential health and safety factors and environmental effects are assessed for all products, projects and activities and acquisitions. For projects, this is implemented by staged audits of health, safety and environmental aspects from concept stage to post commissioning in order to determine any shortcomings or noncompliance.
- ii) Consultant shall prepare the HSE Management Plan for Phase-II in consultation with OIL and submitted to OIL by the Consultant.
- iii) Consultant shall prepare The HSE Monitoring Plan for Phase- II in consultation with OIL and submitted to OIL.
- iv) Consultant shall monitor, report and ensure that the above requirements are fully adhered to.
- v) Site Safety Organization: Consultant is to appoint a Safety Officer with appropriate staff support whose responsibility is to monitor all safety activities on the job site and report his findings to Consultant. The safety officer shall make periodic safety inspections of the job site on a schedule that will provide ongoing coverage. The inspections should be made jointly with the superintendents of the contractors responsible for ongoing work in the areas to be inspected. Any infractions or poor safety practices uncovered by these inspections shall be promptly corrected. Safety requirements shall be enforced on the entire supervisory organization of the contractor and subcontractors. Each location shall require enforcement of approved safety rules and procedures by contractors and subcontractors.

Consultant shall ensure contractor, subcontractors carry out their activities in accordance with the safety plan throughout the course of the construction of the project to inculcate and maintain safety awareness among their employees.

Each employee, prior to beginning work, shall be given a safety orientation course. Consultant shall be responsible for arranging and providing such and ensuring consistency of knowledge and understanding across all and work groups. All personnel must be fully knowledgeable of the potential hazards involved in the work they supervise and the safe practices to be followed in their work.

vi) Consultant has to prepare a detailed Safety Bridging Document to clarify role and responsibilities of Owner (OIL) and EPC contractor.

## VI. Quality assurance & Quality control as per specified Standards / Procedures:

- i) Overall responsibilities for quality management throughout the project by reviewing the quality management systems proposed by Contractor and ensure these are appropriate to project requirements and objectives. Also, PMC shall prepare an integrated Quality Assurance Program (QAP) for the whole project, duly approved by owner satisfying recognized International standards specified e.g. IS, BIS, ISO, BS, ASME, OISD, ASTM, API etc.
- ii) Consultant shall have an established quality management organization which shall be responsible for monitoring and auditing compliance with the QAP throughout the whole Project. The organization shall comprise sufficient numbers of suitably trained and qualified staff to ensure that all requirements of the QAP are satisfactorily implemented by the Contractors.

- iii) The QAP shall cover, but shall not be limited to:
  - a) Verification and approval of methods used and documentation produced during engineering and construction work.
  - b) Inspection, handling and identification of equipment and materials, and proper documentation.
  - c) Planning, agreement of methods, and techniques, supervision, inspection, acceptance and proper verification and acceptance of documentation during construction work.
  - d) Field inspection and testing procedures.
  - e) Consultant to assist in filling insurance claim, if any. Consultant shall provide services for ascertaining repair cost and consultant to carry out inspection for repair of material or replacement.
  - f) Operating, maintenance and training manuals.
- iv) Consultant shall prepare for Owner's approval and execute a program of quality audits for its own, and contractors' activities. Such program shall be submitted as part of the QAP for Owner's approval. Owner shall have the option to provide representatives to participate in any quality audits carried out on the Project.

**NB:** OIL reserves the right, with due notice, to carry out audits of Consultant's activities for compliance with QAP. Such audits shall include (but not limited to):

- a) Inspection of stage wise construction activities of Contractor.
- b) Monitoring, appraising and reporting to owner on the quality and safety aspects of engineering design and construction by all agencies involved in the project.
- c) Provide stage wise QA/Inspection/testing during manufacturing of material/goods at vendors' work.
- d) Providing inspection of materials/goods before dispatch from vendors' works and issuance of Inspection release notes.
- VII. <u>Pre-Commissioning & Commissioning upon mechanical completion</u>: The Consultant in Consultation with OIL and the EPC Contractor to formulate a detailed plan for Pre -Commissioning & Commissioning upon mechanical completion. The plan should be formulated taking into consideration all safety and technical aspects. The plan to be approved by OIL before carrying out any Pre Commissioning & Commissioning activities. The Consultant shall be responsible for ensuring that all the Pre Commissioning & Commissioning activities are carried out safely adhering to all the technical requirements.

### VIII. Assistance in Arbitration / Court Cases with the vendors / contractors:

- i. The Consultant shall ensure that the issues related to various contracts are settled amicably with the contractors/suppliers. Consultant shall provide necessary assistance to OIL and prepare suitable replies to address the claims / grievances / disputes of the contractors / suppliers, as and when they arise.
- ii. Despite the above, if any contractor/supplier imposes Arbitration proceedings on OIL, the consultant shall be responsible for providing necessary assistance to OIL in

connection with these proceedings from the date of award of EPC contract up to a period of 3 years from the date of completion of the project. The rates quoted by the consultant shall be all inclusive and such cost of providing assistance for the arbitration proceedings to be borne by the consultant.

## IX. <u>Closing of contracts</u>:

- a) Consultant shall be responsible for closing the all open purchase orders / work orders / contract to close project sites.
- b) Consultant shall ensure all documentation and engineering data are delivered in a timely manner. The quality and technical integrity of this information shall be monitored to ensure compliance with the Quality Assurance Program. The delivery mechanism shall be the responsibility of Consultant i.e. The electronic media use, indexes, sizes and number of copies of soft copy and hardcopy, etc.
- c) Consultant shall also be responsible for modifying the documentation and data requirements to reflect any existing and new statutory requirements from both government and certifying authority sources.
- d) Consultant to handovers the required number of soft/hard copies of following, but not limited to, design basis, process package, tenders (MR &PR), drawing, layouts, operating manual, single line diagram, P & IDs, HAZOP study etc. to OIL.
- e) Consultant shall be responsible for production of the operating manual(s). This will include scheduling for the preparation of the materials making up the operating manuals. It shall also include the review of drafts of the material in conjunction with Owner. Regular progress meetings shall be held at the appropriate time to ensure completion, commissioning and operation.

#### 4.0 CONSULTANT'S PERSONNEL:

- **4.1** Consultant should warrant that they will provide competent, qualified and sufficiently experienced personnel to perform the work correctly and efficiently and shall ensure that such personnel observe all applicable statutory norms and safety requirement of the Company. Upon the Company's written request, the Consultant, entirely at their own expense, shall remove immediately, from assignment to the work, any personnel of the Consultant determined by the Company to be unsuitable and shall promptly replace such personnel with alternative personnel acceptable to the Company without affecting Company's work.
- **4.2** The Consultant shall be solely responsible throughout the period of the contract for providing all requirements of their personnel, including but not limited to insurance, housing, medical services, messing, their transportation to & fro from field site (both air and land transportation), enroute expenses, vacation, salaries and all amenities, termination payment and taxes, if any, payable at no charge to the Company & Company shall have no responsibility or liability in this regard.
- **5.0 PAYMENT TERMS:** Followings are the payment Terms during Phase-I and Phase-II of the Project:

#### **5.1** During Phase-I of the Project:

- i) Payment is to be made to the Consultant after completion of each activity, duly certified by the Company Representative.
- ii) 10% of the cost against each activity shall be retained and shall only be released to the Consultant after submission of the Detailed Project Report and OIL's approval.

- iii) The Cost of Supervision during Phase-II of the Project should be quoted by the Consultant during the tendering stage of Phase-I itself as per the schedule of rates shown. This shall be considered during evaluation of the bids. However, payment shall be made to the Consultant during execution of Phase-II only and shall form a part of Phase-II of the Project. Consultant to note that OIL at its own discretion reserve the right to engage the Consultant during Phase-II of the Project.
- iv) At any time during execution of Phase-I or Phase-II of the Project, Company may decide to terminate the Contract giving 15 days' prior notice to the Consultant. During such termination, the Consultant shall be paid the cost of each activity completed till the time of termination.

## **5.2** <u>During Phase-II of the Project:</u>

Payment during Phase-II of the project shall not be made earlier than monthly. The payment shall be made as per the actual progress of work during Phase-II of the Project.

The progress of work shall be as certified by OIL in accordance with the Schedule of Work to be identified activity-wise by the Consultant during Phase-I of the Project.

**6.0** The activities listed under Phase-I of the Project are to be completed during two consecutive years and six months from the date of issue of Work Order.

The Consultant shall submit the Detailed Project Report of Phase-I of the Project within three (03) months of completion of the studies listed under Phase-I of the Project. On acceptance of the final Detailed Project Report by OIL & on submission of Statutory & all necessary document/information/data to the Statutory Bodies / Concerned Authorities for obtaining Clearance for Construction and Operation of both the STPs, the Phase-I of the Project shall be considered to be completed. The consultant has to submit documentary evidence against submission of the above to the concerned authorities. Completion of Phase-I of the Project shall to be informed to the Consultant by OIL in writing.

#### 7.0 GENERAL HSE POINTS TO BE FOLLOWED IN THE CONTRACT:

- **7.1** It will be solely the Consultant's responsibility to fulfill all the legal formalities with respect to the Health, Safety and Environmental aspects of the entire job (namely; the person employed by him, the equipment, the environment, etc.) under the jurisdiction of the district of that state where it is operating. Ensure that all sub-Consultants hired by him comply with the same requirement as the Consultant himself and shall be liable for ensuring compliance all HSE laws by the sub or sub-sub Consultants.
- **7.2** Every person deployed by the Consultant in a mine must wear safety gadgets to be provided by the Consultant. The Consultant shall provide proper Personnel Protective Equipment as per the hazard identified and risk assessed for the job and conforming to statutory requirement and company PPE schedule. Safety appliances like protective footwear, Safety Helmet and Full Body harness has to be DGMS approved. Necessary supportive document shall have to be submitted as proof. If the Consultant fails to provide the safety items as mentioned above to the working personnel, the Consultant may apply to the Company (OIL) for providing the same. OIL will provide the safety items, if available. But in turn, OIL will recover the actual cost of the items by deducting from Consultant's Bill. However, it will be the Consultant's sole responsibility to ensure that the persons engaged by him in the mines use the proper PPE while at work.

- **7.3** All the safety gears mentioned above are to be provided to the working personnel before commencement of the work.
- **7.4** The Consultant shall prepare written Safe Operating Procedure (SOP) for the work to be carried out, including an assessment of risk, wherever possible and safe methods to deal with it/them. The SOP should clearly state the risk arising to men, machineries & material from the mining operation / operations to be done by the Consultant and how it is to be managed.
- **7.5** The Consultant shall provide a copy of the SOP to the person designated by the mine owner of OIL who shall be supervising the Consultant's work.
- **7.6** Keep an up to date SOP and provide a copy of changes to a person designated by the Mine Owner/Agent/Manager of OIL.
- **7.7** Consultant has to ensure that all work is carried out in accordance with the Statute and SOP and for the purpose he may deploy adequate qualified and competent personnel for the purpose of carrying out the job in a safe manner. For work of a specified scope/nature, he should develop and provide to the mine owner a site specific code of practice in line.
- **7.8** All persons deployed by the Consultant for working in a mine must undergo Mines Vocational Training, initial medical examination, PME. They should be issued cards stating the name of the Consultant and the work and its validity period, indicating status of MVT, IME & PME.
- **7.9** Consultant to note that being an E &P Company, Oil India Limited comes under the preview of DGMs/OISD. There are certain laid down rules /procedures which are to be followed by the Consultant while carrying out the work under this Contract. The applicable rules/regulation/procedures shall be made available to the Consultant prior to starting of the work.
- **7.10** The Consultant shall submit to DGMS returns indicating Name of his firm, Registration number, Name and address of person heading the firm, Nature of work, type of deployment of work persons, Number of work persons deployed, how many work persons hold VT Certificate, how many work persons undergone IME and type of medical coverage given to the work persons.
- **7.11** The return shall be submitted quarterly (by 10th of April, July, October & January) for contracts of more than one year. However, for contracts of less than one year, returns shall be submitted monthly.
- **7.12** It will be entirely the responsibility of the Consultant/his Supervisor/representative to ensure strict adherence to all HSE measures and statutory rules during operation in OIL's installations and safety of workers engaged by him. The crew members will not refuse to follow any instruction given by company's Installation Manager / Safety Officer / Engineer / Official / Supervisor/Junior Engineer for safe operation.
- **7.13** Any compensation arising out of the job carried out by the Consultant whether related to pollution, Safety or Health will be paid by the Consultant only.
- **7.14** Any compensation arising due to accident of the Consultant's personnel while carrying out the job, will be payable by the Consultant.

- **7.15** The Consultant shall have to report all incidents including near miss to Installation Manager / departmental representative of the concerned department of OIL.
- **7.16** The Consultant has to keep a register of the persons employed by him/her. The Consultant's supervisor shall take and maintain attendance of his men every day for the work, punctually.
- **7.17** If the company arranges any safety class / training for the working personnel at site (company employee, Consultant worker, etc) the Consultant will not have any objection to any such training.
- **7.18** The health checkup of Consultant's personnel is to be done by the Consultant in authorized Health Centers as per OIL's requirement & proof of such test(s) is to be submitted to OIL. The frequency of periodic medical examinations should be every five years for the employees below 45 years of age and every three years for employees of 45 years of age and above.
- **7.19** To arrange daily tool box meeting and regular site safety meetings and maintain records.
- **7.20** Records of daily attendance, accident report etc. are to be maintained in Form B, E, J (as per Mines Rules 1955) by the Consultant.
- **7.21** A Consultant employee must, while at work, take reasonable care for the health and safety of people who are at the employee's place of work and who may be affected by the employee's act or omissions at work.
- **7.22** A Consultant employee must, while at work, cooperate with his or her employer or other persons so far as is necessary to enable compliance with any requirement under the act or the regulations that is imposed in the interest of health, safety and welfare of the employee or any other person.
- **7.23** Consultant's arrangements for health and safety management shall be consistent with those for the mine owner.
- **7.24** In case Consultant is found non-compliant of HSE laws as required company will have the right for directing the Consultant to take action to comply with the requirements, and for further non-compliance, the Consultant will be penalized prevailing relevant Acts/Rules/Regulations.
- **7.25** When there is a significant risk to health, environment or safety of a person or place arising because of a non-compliance of HSE measures company will have the right to direct the Consultant to cease work until the non-compliance is corrected.
- **7.26** The Consultant should prevent the frequent change of his contractual employees as far as practicable.
- **7.27** The Consultant should frame a mutually agreed bridging document between OIL & the Consultant with roles and responsibilities clearly defined.
- **7.28** For any HSE matters not specified in the contract document, the Consultant will abide the relevant and prevailing Acts/rules/regulations/ pertaining to Health, Safety and Environment.

- **7.29** Competency Criteria shall be formulated & documented, for all kinds of Consultant employees being engaged by the company.
- **7.30** Vehicles to be used by the Consultant should have audio alarm while reversing.
- **7.31** While carrying out the survey inside the river all statutory precaution to be adopted by the Consultant / Consultant 's personnel.
- **7.32** If applicable, the permission to survey the river is to be obtained by the Consultant from the competent Govt./Statutory bodies prior to starting of the work.

## 8.0 SPECIAL CONDITIONS OF THE CONTRACT:

- **8.1** The Consultant engaged for Phase- I of the Project shall not be eligible to participate in the tender for Phase- II of the Project.
- **8.2** The Consultant shall bring their own manpower and equipment required for execution of all the activities listed under Phase-I of the Project. A detailed list of all the manpower and equipments to be brought by the Consultant should be submitted on signing of the Contract. Any permission/fees required for mobilizing the resources to Duliajan shall be on Consultant's account.
- **8.3** The boarding, lodging and travel arrangement of the manpower to be deployed by the Consultant should be arranged by the Consultant on its own account. The Consultant shall also be responsible for security and medical arrangement of their manpower.
- **8.4** The Consultant may set up a site office at its own cost if required as deemed by the Consultant. However, in any case, it should be ensured that the job progress is as per the defined time line and should not hamper the overall progress of the Project.

- a) Only experienced and competent persons shall be engaged by us for carrying out work under the said contract.
- b) The names of the authorized persons who would be supervising the jobs on day to day basis from our end are the following:

The above personnel are fully familiar with the nature of jobs assigned and safety precautions required.

- c) Due notice would be given for any change of personnel under item(b) above.
- d) We hereby accept the responsibility for the safety of all the personnel engaged by us and for the safety of the Company's personnel and property involved during the course of our working under this contract. We would ensure that all the provisions under the Oil Mines Regulations, 1984 and other safety rules related to execution of our work would be strictly followed by our personnel. Any violation pointed out by the Company's Engineers would be rectified forthwith or the work suspended till such time the rectification is completed by us and all expenditure towards this would be on our account.
- e) We confirm that all persons engaged by us would be provided with the necessary Safety Gears at our cost.
- f) All losses caused due to inadequate safety measures or lack of supervision on our part would be fully compensated by us and the Company will not be responsible for any lapses on our part in this regard.
  - g) We shall abide by the following HSE (Health, Safety & Environmental) POINTS:

## GENERAL HEALTH, SAFETY & ENVIRONMENT (HSE) POINTS:

1. It will be solely the Contractor's responsibility to fulfill all the legal formalities with respect to the Health, Safety and Environmental aspects of the entire job (namely; the person employed by him, the equipment, the environment, etc.) under the jurisdiction of the district of that state where it is operating. Ensure that all sub-contractors hired by him comply with the same requirement as the contractor himself and shall be liable for ensuring compliance all HSE laws by the sub or sub-sub-contractors.

- 2. Every person deployed by the contractor in a mine must wear safety gadgets to be provided by the contractor. The Contractor shall provide proper Personnel Protective Equipment as per the hazard identified and risk assessed for the job and conforming to statutory requirement and company PPE schedule. Safety appliances like protective footwear, Safety Helmet and Full Body harness has to be DGMS approved. Necessary supportive document shall have to be submitted as proof. If the Contractor fails to provide the safety items as mentioned above to the working personnel, the Contractor may apply to the Company (OIL) for providing the same. OIL will provide the safety items, if available. But in turn, OIL will recover the actual cost of the items by deducting from Contractor's Bill. However, it will be the Contractor's sole responsibility to ensure that the persons engaged by him in the mines use the proper PPE while at work. All the safety gears mentioned above are to be provided to the working personnel before commencement of the work.
- 3. The Contractor shall prepare written Safe Operating Procedure (SOP) for the work to be carried out, including an assessment of risk, wherever possible and safe methods to deal with it/them. The SOP should clearly state the risk arising to men, machineries & material from the mining operation / operations to be done by the contractor and how it is to be managed.
- 4. The contractor shall provide a copy of the SOP to the person designated by the mine owner who shall be supervising the contractor's work.
- 5. Keep an up to date SOP and provide a copy of changes to a person designated by the Mine Owner /Agent /Manager.
- 6. Contractor has to ensure that all work is carried out in accordance with the Statute and SOP and for the purpose he may deploy adequate qualified and competent personnel for the purpose of carrying out the job in a safe manner. For work of a specified scope/nature, he should develop and provide to the mine owner a site specific code of practice in line.
- 7. All persons deployed by the contractor for working in a mine must undergo Mines Vocational Training, initial medical examination, PME. They should be issued cards stating the name of the contractor and the work and its validity period, indicating status of MVT, IME & PME.
- 8. The contractor shall submit to DGMS returns indicating Name of his firm, Registration number, Name and address of person heading the firm, Nature of work, type of deployment of work persons, Number of work persons deployed, how many work persons hold VT Certificate, how many work persons undergone IME and type of medical coverage given to the work persons.
- 9. The return shall be submitted quarterly (by 10th of April, July, October & January) for contracts of more than one year. However, for contracts of less than one year, returns shall be submitted monthly.
- 10. It will be entirely the responsibility of the Contractor/his Supervisor/representative to ensure strict adherence to all HSE measures and statutory rules during operation in OIL's installations and safety of workers engaged by him. The crew members will not refuse to follow any instruction given by company's Installation Manager / Safety Officer / Engineer / Official / Supervisor/Junior Engineer for safe operation.
- 11. Any compensation arising out of the job carried out by the Contractor whether related to pollution, Safety or Health will be paid by the contractor only.
- 12. Any compensation arising due to accident of the Contractor's personnel while carrying out the job, will be payable by the contractor.

#### PART-V SAFETY MEASURE (SM)

- 13. The contractor shall have to report all incidents including near miss to Installation Manager / departmental representative of the concerned department of OIL.
- 14. The contractor has to keep a register of the persons employed by him/her. The contractor's supervisor shall take and maintain attendance of his men every day for the work, punctually.
- 15. If the company arranges any safety class / training for the working personnel at site (company employee, contractor worker, etc) the contractor will not have any objection to any such training.
- 16. The health check up of contractor's personnel is to be done by the contractor in authorized Health Centers as per OIL's requirement & proof of such test(s) is to be submitted to OIL. The frequency of periodic medical examinations should be every five years for the employees below 45 years of age and every three years for employees of 45 years of age and above.
- 17. To arrange daily tool box meeting and regular site safety meetings and maintain records.
- 18. Records of daily attendance, accident report etc. are to be maintained in Form B, E, J (as per Mines Rules 1955) by the contractor.
- 19. A contractor employee must, while at work, take reasonable care for the health and safety of people who are at the employee's place of work and who may be affected by the employee's act or omissions at work.
- 20. A contractor employee must, while at work, cooperate with his or her employer or other persons so far as is necessary to enable compliance with any requirement under the act or the regulations that is imposed in the interest of health, safety and welfare of the employee or any other person.
- 21. Contractor's arrangements for health and safety management shall be consistent with those for the mine owner.
- 22. In case Contractor is found non-compliant of HSE laws as required company will have the right for directing the contractor to take action to comply with the requirements, and for further non-compliance, the contractor will be penalized prevailing relevant Acts/Rules/Regulations.
- 23. When there is a significant risk to health, environment or safety of a person or place arising because of a non-compliance of HSE Measures Company will have the right to direct the contractor to cease work until the non-compliance is corrected.
- 24. The contractor should prevent the frequent change of his contractual employees as far as practicable.
- 25. The contractor should frame a mutually agreed bridging document between OIL & the contractor with roles and responsibilities clearly defined.
- 26. For any HSE matters not specified in the contract document, the contractor will abide the relevant and prevailing Acts/rules/regulations/ pertaining to Health, Safety and Environment.

#### **INTEGRITY PACT**

#### Between

Oil India Limited (OIL) hereinafter referred to as "The Principal"

And

#### Preamble:

The Principal intends to award, under laid down organizational procedures, contract/s for "Hiring services for designing of 02 (two) Nos. of Sewage Treatment Plants (STPs) for Duliajan Township along with supervisory services during construction phase of the STPs, if required."

#### (IFB No. CDI9869P19)

The Principal values full compliance with all relevant laws and regulations, and the principles of economic use of resources, and of fairness and transparency in its relations with its Bidder/s and Contractor/s.

In order to achieve these goals, the Principal cooperates with the renowned international Non-Governmental Organization "Transparency International" (TI). Following TI's national and international experience, the Principal will appoint an external independent Monitor who will monitor the tender process and the execution of the contract for compliance with the principles mentioned above.

#### Section: 1 - Commitments of the Principal

- (1) The Principal commits itself to take all measures necessary to prevent corruption and to observe the following principles:
  - 1. No employee of the Principal, personally or through family members, will in connection with the tender for, or the execution of a contract, demand, take a promise for or accept, for him/herself or third person, any material or immaterial benefit which he/she is not legally entitled to.
  - 2. The Principal will, during the tender process treat all Bidders with equity and reason. The Principal will in particular, before and during the tender process, provide to all Bidders the same information and will not provide to any Bidder confidential/additional information through which the Bidder could obtain an advantage in relation to the tender process or the contract execution.
  - 3. The Principal will exclude from the process all known prejudiced persons.
- (2) If the Principal obtains information on the conduct of any of its employees which is a criminal offence under the relevant Anti-Corruption Laws of India, or if there be a

Page 2 of 6 substantive suspicion in this regard, the Principal will inform its Vigilance Office and in addition can initiate disciplinary actions.

## Section: 2 - Commitments of the Bidder/Contractor

- (1) The Bidder/Contractor commits itself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the tender process and during the contract execution.
  - 1. The Bidder/Contractor will not, directly or through any other person or firm, offer, promise or give to any of the Principal's employees involved in the tender process or the execution of the contract or to any third person any material or immaterial benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.
  - 2. The Bidder/Contractor will not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, Subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
  - 3. The Bidder/Contractor will not commit any offence under the relevant Anticorruption Laws of India; further the Bidder/Contractor will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
  - 4. The Bidder/Contractor will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- **(2)** The Bidder/Contractor will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- (3) The Bidder/Contractor signing Integrity Pact shall not approach the Courts while representing the matters to IEMs and he/she will await their decision in the matter.

# Section 3 - Disqualification from tender process and exclusion from future Contracts

If the Bidder, before contract award has committed a transgression through a violation of Section 2 or in any other form such as to put his reliability or risibility as Bidder into question, the Principal is entitled to disqualify the Bidder from the tender process or to terminate the contract, if already signed, for such reason.

1. If the Bidder/Contractor has committed a transgression through a violation of Section 2 such as to put his reliability or credibility into question, the Principal is entitled also to exclude the Bidder/Contractor from future contract

award processes. The imposition and duration of the exclusion will be determined by the severity of the transgression. The severity will be determined by the circumstances of the case, in particular the number of transgressions, the position of the transgressions within the company hierarchy of the Bidder and the amount of the damage. The exclusion will be imposed for a minimum of 6 months and maximum of 3 years.

- 2. The Bidder accepts and undertakes to respect and uphold the Principal's Absolute right to resort to and impose such exclusion and further accepts and undertakes not to challenge or question such exclusion on any ground, including the lack of any hearing before the decision to resort to such exclusion is taken. This undertaking is given freely and after obtaining independent legal advice.
- 3. If the Bidder/Contractor can prove that he has restored/recouped the Damage caused by him and has installed a suitable corruption prevention system, the Principal may revoke the exclusion prematurely.
- 4. A transgression is considered to have occurred if in light of available evidence no reasonable doubt is possible.
- 5. Integrity Pact, in respect of a particular contract, shall be operative from the date Integrity Pact is signed by both the parties till the final completion of the contract **or as mentioned in Section 9 Pact Duration whichever is later**. Any violation of the same would entail disqualification of the bidders and exclusion from future business dealings.

#### **Section 4 - Compensation for Damages**

- (1) If the Principal has disqualified the Bidder from the tender process prior to the award according to Section 3, the Principal is entitled to demand and recover from the Bidder liquidated damages equivalent to Earnest Money Deposit / Bid Security.
- (2) If the Principal has terminated the contract according to Section 3, or if the Principal is entitled to terminate the contract according to Section 3, the principal shall be entitled to demand and recover from the Contractor liquidated damages equivalent to Security Deposit / Performance Bank Guarantee.
- (3) The bidder agrees and undertakes to pay the said amounts without protest or demur subject only to condition that if the Bidder/Contractor can prove and establish that the exclusion of the Bidder from the tender process or the termination of the contract after the contract award has caused no damage or less damage than the amount or the liquidated damages, the Bidder/Contractor shall compensate the Principal only to the extent of the damage in the amount proved.

#### **Section 5 - Previous transgression**

- (1) The Bidder declares that no previous transgression occurred in the last 3 years with any other Company in any country conforming to the TI approach or with any other Public Sector Enterprise in India that could justify his exclusion from the tender process.
- (2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason.

## Section: 6 - Equal treatment of all Bidders/Contractor/Subcontractors

- (1) The Principal will enter into Pacts on identical terms with all bidders and contractors.
- (2) The Bidder / Contractor undertake(s) to procure from all subcontractors a commitment in conformity with this Integrity Pact. The Bidder/Contractor shall be responsible for any violation(s) of the provisions laid down in this agreement/Pact by any of its sub-contractors/sub-vendors.
- **(3)** The Principal will disqualify from the tender process all bidders who do not sign this Pact or violate its provisions.

## Section: 7 - Criminal charges against violating Bidders/Contractors/ Subcontractors

If the Principal obtains knowledge of conduct of a Bidder, Contractor or Subcontractor, or of an employee or a representative or an associate of a Bidder, Contractor or Subcontractor, which constitutes corruption, or if the Principal has substantive suspicion in this regard, the Principal will inform the Vigilance Office.

#### Section: 8 - External Independent Monitor/Monitors

- (1) The Principal appoints competent and credible external independent Monitor for this Pact. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.
- **(2)** The Monitor is not subject to instructions by the representatives of the parties and performs his functions neutrally and independently. He reports to the Chairperson of the Board of the Principal.
- (3) The Contractor accepts that the Monitor has the right to access without restriction to all Project documentation of the Principal including that provided by the Contractor. The Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor is under contractual obligation to treat the information and documents of the Bidder/Contractor/Subcontractor with confidentiality.

- **(4)** The Principal will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the Principal and the Contractor. The parties offer to the Monitor the option to participate in such meetings.
- (5) As soon as the Monitor notices, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or heal the violation, or to take other relevant action. The monitor can in this regard submit non-binding recommendations. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action. However, the Independent External Monitor shall give an opportunity to the bidder / contractor to present its case before making its recommendations to the Principal.
- **(6)** The Monitor will submit a written report to the Chairperson of the Board of the Principal within 8 to 10 weeks from the date of reference or intimation to him by the 'Principal' and, should the occasion arise, submit proposals for correcting problematic situations.
- (7) If the Monitor has reported to the Chairperson of the Board a Substantiated suspicion of an offence under relevant Anti-Corruption Laws of India, and the Chairperson has not, within reasonable time, taken visible action to proceed against such offence or reported it to the Vigilance Office, the Monitor may also transmit this information directly to the Central Vigilance Commissioner, Government of India.
- (8) The word 'Monitor' would include both singular and plural.

#### **Section: 9 - Pact Duration**

This Pact begins when both parties have legally signed it. It expires for the Contractor 12 months after the last payment under the respective contract, and for all other Bidders 6 months after the contract has been awarded.

If any claim is made/ lodged during this time, the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged/determined by Chairperson of the Principal.

#### Section: 10 - Other provisions

- (1) This agreement is subject to Indian Law. Place of performance and jurisdiction is the Registered Office of the Principal, i.e. New Delhi. The Arbitration clause provided in the main tender document / contract shall not be applicable for any issue / dispute arising under Integrity Pact.
- (2) Changes and supplements as well as termination notices need to be made in writing. Side agreements have not been made.
- (3) If the Contractor is a partnership or a consortium, this agreement must be, signed by all partners or consortium members.
