3.0 GUIDELINES FOR PARTICIPATING IN OIL'S E-PROCUREMENT

3.1 Bids are to be submitted online through OIL's E-Procurement Portal with digital signature. To participate in OIL's E-Procurement tender, bidders should have a legally valid digital certificate of Class 3 with Organizations Name and Encryption Certificate as per Indian IT Act from the licensed Certifying Authorities operating under the Root Certifying Authority of India (RCAI), Controller of Certifying Authorities (CCA) of India (http://www.cca.gov.in). Digital Signature Certificates having "Organization Name" field other than **Bidder's Name** are not acceptable. However, aforesaid Digital Signature Certificates having Bidder's Name in the "Organization Name" field are acceptable.

Encryption certificate is mandatorily required for submission of bid. In case bidder creates response with one certificate (using encryption key) and then the bidder changes his Digital Signature Certificate, then the old certificate (used for encryption) is required in order to decrypt his encrypted response for getting the edit mode of the response. Once decryption is done, bidder may use new DSC certificate for uploading and submission of their offer. It is the sole responsibility of the bidder to keep their DSC certificate properly. In case of loss of the certificate, OIL INDIA LTD. is not responsible.

The authenticity of above digital signature shall be verified through authorized CA after bid opening and in case the digital signature used for signing is not of "Class 3 with Organizations Name and Encryption Certificate", the bid will be rejected.

Bidder is responsible for ensuring the validity of digital signature and its proper usage by their employee.

The bid including all uploaded documents shall be digitally signed by duly authorized representative of the bidding company.

The bid including all uploaded documents shall be digitally signed by duly authorized representative of the Bidder/Bidding company to bind the Bidder/Bidding company to the contract.

In the event of late registration/incomplete registration by Bidder, OIL INDIA LIMITED shall not be responsible for late allotment of User ID & Password and request for bid closing date extension on that plea shall not be entertained by Company.

- **4.0 EXEMPTION FROM BID SECURITY PAYEMENT:** In case any bidder is exempted from paying the Bid security, they should request OIL with supporting documents. The detailed guidelines for exemption of the Bid security are given below.
 - a) MSEs Units (manufacturers/Service Providers only and not their dealers/ distributors) who are already registered with District Industry Centres or Khadi & Village Industries Commission or Khadi & Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts & Handloom or Udyog Aadhaar Memorandum or any other body specified by Ministry of MSME are exempted from payment of Bid Security (EMD) irrespective of monetary limit mentioned in their registration.

- **6.0** The rates shall be quoted per unit as specified in the **"PRICE BIDDING FORMAT"** attached under **"Notes and Attachments"** tab. Bidder should note that no pricing information is furnished in the **"Technical Attachment"** (Un-priced Techno-Commercial Bid) otherwise the bid will be rejected.
- 7.0 The tender is invited under OPEN E-TENDER COMPOSITE BID SYSTEM. The bidder has to submit both the "TECHNICAL" and "PRICED" bid through electronic form in the OIL's E-Tender portal within the Bid Closing Date and Time stipulated in the E-Tender. For submission of Bids online at OIL's E-Tender Portal, detailed instructions are available in "User Manual" available in OIL's E-Tender Portal. The Technical Bid should be submitted as per Scope of Work & Technical Specifications along with all technical documents related to the tender and uploaded under "Technical Attachment" Tab only. Bidders to note that no price details should be uploaded in "Technical Attachment" Tab Page. The Price Bid rates shall be quoted per unit as specified in the "PRICE BIDDING FORMAT" attached under "Notes and Attachments" tab in the main bidding engine of OIL's E-Tender portal. The price quoted in the "PRICE BIDDING FORMAT" will only be considered for evaluation.
- **8.0** The Company reserves the right to reject any or all the tenders or accept any tender without assigning any reason.
- **9.0** (a) No Bidder can withdraw his bid within the validity or extended validity of the bid. Withdrawal of any bid within validity period will lead to forfeiture of his/her/their Bid Security Deposit in full and debar from participation in future tenders, at the sole discretion of the company.
- (b) Once a withdrawal letter is received from any bidder, the offer will be treated as withdrawn and no further claim/correspondence will be entertained in this regard.
- **10.0** Conditional bids are liable to be rejected at the discretion of the Company.

The Proforma has to be returned by the bidder (along with the Unpriced Techno-Commercial Bid) duly signed (digitally) by the same signatory who signed the bid, i.e., who is duly authorized to sign the bid. Uploading the Integrity Pact with digital signature will be construed that all pages of the Integrity Pact has been signed by the bidder's authorized signatory who sign the Bid.

14.0 PREPARATION OF BIDS:

14.1 LANGUAGE OF BIDS: The bid as well as all correspondence and documents relating to the bid exchanged between the Bidder and the Company shall be in English language,

except that any printed literature may be in another language provided it is accompanied by an official and notarized English translated version, which shall govern for the purpose of bid interpretation.

18.0 AMENDMENT OF BIDDING DOCUMENTS:


18.1 At any time prior to the deadline for submission of bids, the company may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the Bidding Documents by issuance of an Addendum.

18.2 The Addendum will be uploaded in OIL's E-Tender Portal in the Tab "Technical RFx" and External Area – "Amendments" folder. The company may, at its discretion, extend the deadline for bid submission. Bidders are expected to take the Addendum into account in preparation and submission of their bid. Bidders are to check from time to time the E-Tender Portal ["Technical RFx" Tab and under the folder "Amendments"] for any amendments to the bid documents before submission of their bids. No separate intimation shall be sent to the Bidders.

19.0 SUBMISSION OF BIDS:

- **19.1** The bid including all uploaded documents shall be digitally signed by duly authorized representative of the bidder to bind the Bidder to the contract.
- 19.2 Any person signing the Bid or any other document in respect of this Bid Document or other relevant documents on behalf of the Bidder without disclosing his authority to do so shall be deemed to have the authority to bind the Bidder. If it is discovered at any time that the person so signing has no authority to do so, the Company (OIL) may, without prejudice to any other right or remedy, cancel his Bid or Contract and hold the Bidder liable to the Company (OIL) for all costs and damages arising from the cancellation of the Bid or Contract including any loss which the Company (OIL) may sustain on account thereof.
- **19.3** Timely submission of the bids is the responsibility of the Bidder and Bids should be submitted before the bid closing date and time. Company shall not be responsible for any delay.
- **19.4** Bidder shall submit the Bid, duly completed in terms of the Bid Document.
- **19.5** Before submission of Bids, Bidders are requested to make themselves fully conversant with all Conditions of the Bid Document and other relevant information related to the works to be executed under this contract.



- ** The "**Priced bid**" must contain the price schedule and the bidder's commercial terms and conditions, if any. For uploading Priced Bid, first click on Add Attachment, a browser window will open, select the file from the PC and name the file under Description, Assigned to General Data and click on OK to digitally sign and upload the File. Please click on Save Button of the Response to Save the uploaded files.
- 21.0 <u>Maintenance of Total bid value in the Response:</u> For convenience of the Bidders and to improve transparency, the rates/costs quoted by bidders against the E-tender shall be available for online viewing after price bid opening to those bidders whose price bids have been opened in the system. For tenders where **Detailed Price Information under RFx Information Tab is "No price"**, the Price Bid is invited through attachment form under "Notes & Attachment". As per the existing process, Bidders must upload their pricing as per the "Price Bidding Format" under "Notes & Attachment". Additionally the bidders must fill up the <u>on-line field "Total Bid Value"</u> under Tab Page "RFx Information" with the Total Cost (Including the GST component) as per the amount of the Price Bid in attachment form.



The "Total Bid Value" as entered by the Bidder in the on-line response shall be displayed in the e-tender portal amongst the Techno-Commercially qualified bidders and Company will not take any responsibility whatsoever towards incorrect information furnished by the bidders in the "Total Bid Value" field.

It is to be noted that Amount mentioned in the "Total Bid Value" field will not be considered for bid evaluation and evaluation will be purely based on the "Price bidding Format".

22.0 DEADLINE FOR SUBMISSION OF BIDS:

22.1 Bids should be submitted on-line up to **11.00 a.m. (IST) (Server Time) on the Bid Closing date** mentioned in the Forwarding Letter. Bidders will be permitted by System to make any changes in their bid after the bid has been uploaded by the bidder prior to the Bid

Closing date and time as mentioned in the bid except in condition mentioned in clause 25.0 below. But no changes would be allowed by the system once the due date and time for submission of bids has been reached and bids are opened.

- **22.2** No bid can be submitted after the submission deadline is reached. The system time displayed on the e-procurement web page shall decide the submission deadline.
- **22.3** The documents in physical form must be received by Company at the address specified in the "Forwarding Letter" on or before **12:45 p.m. (IST) on the bid closing date**. Timely delivery of the same at the address mentioned in the Forwarding Letter is the responsibility of the Bidders.
- **23.0 LATE BIDS:** Bidders are advised in their own interest to ensure that their bids are uploaded in system before the closing date and time of the bid. Any Bid received by the Company after the Bid Closing Date & Time stipulated by the Company shall be rejected.

24.0 MODIFICATION AND WITHDRAWAL OF BIDS:

- **24.1** Bidders will be permitted by System to withdraw their bid or make any changes in their bid after the bid has been uploaded by the bidder prior to the Bid Closing date and time as mentioned in the bid. But no changes or withdrawal would be allowed by the system once the due date and time for submission of bids has been reached and bids are opened.
- **24.2** No bid can be modified/withdrawn subsequent to the deadline for submission of bids.
- **24.3** No bid may be withdrawn in the interval between the deadline for submission of bids and the expiry of the period of bid validity. Withdrawal of any bid within validity period will lead to forfeiture of his/her/their Bid Security Deposit in full and debar from participation in future tenders, at the sole discretion of the company.
- **25.0 EXTENSION OF BID SUBMISSION DATE:** Normally no request for extension of Bid Closing Date & Time will be entertained. However, OIL at its discretion, may extend the Bid Closing Date and/or Time due to any reasons.

26.0 BID OPENING AND EVALUATION:

- **26.1.1** The bid will be opened on scheduled Bid opening date & time in the presence of any attending Bidder(s) or their Authorized Representative, if any. However, an authorized letter (format given in Proforma Section) from the Bidder must be produced by Bidder's representative at the time of opening of Tender, without which such representative won't be allowed to attend the opening of Tenders. Only one representative against each Bid will be allowed to attend the bid opening. Attending Bidder(s) & Authorized Representative(s) will have to sign a register evidencing their presence.
- **26.1.2** In case of two bid system, after the evaluation of the Technical Bids, the Price Bids of only the techno-commercially acceptable Bidders will be opened. The opening Date and Time will be intimated to the techno-commercially qualified Bidders in due course. Price bids will be opened in the same procedure as mentioned in Para 26.1.1 above.
- **26.2** In case it happens to be a bandh/holiday, the tender will be opened on the next working day (except Saturday). Accordingly, Bid Closing Date/time will get extended up to the next working day and time (except Saturday).
- **26.3** Bids which have been withdrawn pursuant to Clause 24.0 will not be allowed to be opened by the system. OIL shall examine bids to determine whether they are complete,

whether requisite Bid Securities have been furnished, whether documents have been properly signed and whether the bids are generally in order.

- **26.4** OIL shall prepare, for its own records, minutes of bid opening including the information disclosed to those present in accordance with the sub-clause 26.3.
- **26.5** To assist in the examination, evaluation and comparison of bids, normally no clarifications shall be sought from the Bidders. However, for assisting in the evaluation of the bids especially on the issues where the Bidder confirms compliance in the evaluation and contradiction exists on the same issues due to lack of required supporting documents in the Bid (i.e. document is deficient or missing), or due to some statement at other place of the Bid (i.e. reconfirmation of confirmation) or vice versa, clarifications may be sought by OIL at its discretion. The request for clarification and the response shall be in writing and no change in the price or substance of the bid shall be sought, offered or permitted.
- **26.6** Prior to the detailed evaluation, OIL will determine the substantial responsiveness of each bid to the requirement of the Bidding Documents. For purpose of these paragraphs, a substantially responsive bid is one, which conforms to all the terms and conditions of the Bidding Document without material deviations or reservation. A material deviation or reservation is one which affects in any substantial way the scope, quality, or performance of work, or which limits in any substantial way, in-consistent way with the bidding documents, the Company's right or the bidder's obligations under the contract, and the rectification of which deviation or reservation would affect unfairly the competitive position of other bidders presenting substantial responsive bids. OIL's determination of bid's responsiveness is to be based on the contents of the Bid itself without recourse to extrinsic evidence.
- **26.7** A Bid determined as not substantially responsive will be rejected by the Company and may not subsequently be made responsive by the Bidder by correction of the non-conformity.
- **26.8** The Company may waive minor informality or nonconformity or irregularity in a bid, which does not constitute a material deviation, provided such waiver, does not prejudice or affect the relative ranking of any Bidder.

27.0 EVALUATION AND COMPARISON OF BIDS:

- **27.1** OIL will evaluate and compare the bids as per Bid Evaluation Criteria (BEC) of the bidding documents.
- **27.2** To ascertain the inter-se-ranking, the comparison of the responsive bids will be made on the basis of total amount quoted inclusive of all liabilities and GST for the items of part-II (i.e. schedule of works, units, quantity, rates) of the tender.
- **27.3** DISCOUNTS/REBATES: Unconditional discounts/rebates, if any, given in the bid or along with the bid will be considered for evaluation.
- **27.4** Post bid or conditional discounts/rebates offered by any bidder shall not be considered for evaluation of bids. However, if the lowest bidder happens to be the final acceptable bidder for award of contract, and if they have offered any discounts/rebates, the contract shall be awarded after taking into account such discounts/rebates.
- **27.5** Conditional bids are liable to be rejected at the discretion of the Company.
- **28.0 BACKING OUT BY BIDDER:** In case any bidder withdraws their bid within the bid validity period, Bid Security will be forfeited and the party will be put on Holiday as per the Banning Policy (available in OIL's website) of Company.

29.0 CONTACTING THE COMPANY:

- **29.1** Except as otherwise provided in Clause 27.0 above, no Bidder shall contact OIL on any matter relating to its bid, from the time of the bid opening to the time the Contract is awarded except as required by OIL vide sub-clause 26.5.
- **29.2** An effort by a Bidder to influence OIL in the bid evaluation, bid comparison or Contract award decisions may result in the rejection of their bid.
- **30.0 AWARD CRITERIA:** OIL will award the Contract to the successful Bidder whose bid has been determined to be substantially responsive and has been determined as the lowest evaluated bid, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
- **31.0 <u>OIL'S RIGHT TO ACCEPT OR REJECT ANY BID:</u>** OIL reserves the right to accept or reject any or all bids and to annul the bidding process and reject all bids, at any time prior to award of contract, without thereby incurring any liability to the affected bidder, or bidders or any obligation to inform the affected bidder of the grounds for OIL's action.
- **32.0 NOTIFICATION OF AWARD:** Prior to the expiry of the period of bid validity or extended validity, OIL will notify the successful Bidder in writing by registered letter or by cable or telex or fax or e-mail (to be confirmed in writing by registered/couriered letter) that its bid has been accepted.
- **33.0** The selected bidder will be required to enter into a formal contract, which will be based on their bid and OIL's Standard Form of Contract.
- **34.0** The successful bidder shall furnish a Performance Security Deposit in the form of Bank Guarantee as specified above before signing the formal contract. The Performance Security Deposit will be refunded to the Contractor after satisfactory completion of the work, but a part or whole of which shall be used by the Company in realization of liquidated damages or claims, if any or for adjustment of compensation or loss due to the Company for any reason. This Security Money shall not earn any interest.
- **35.0 BACKING OUT BY L1 BIDDER AFTER ISSUE OF LOA:** In case LOA issued is not accepted by the L1 bidder or the Performance Security is not submitted as per the terms of the contract within the time specified in the Bid Document, the Bid Security shall be forfeited and the bidder shall be dealt as per the Banning Policy (available in OIL's website) of Company.
- **36.0 FURNISHING FRAUDULENT INFORMATION/DOCUMENT:** The information and documents furnish by the bidder/contractor in respect of the subject tender/contract are accepted to be true and genuine. However, if it is detected during technical scrutiny or after award of the contract or after expiry of the contract, that the bidder had submitted any fake/fraudulent document or furnished false statement, the offer/contract shall be rejected/cancelled, as the case may be and the bidder (if fake document/false statement pertains to such bidder) shall be dealt as per the Banning Policy (available in OIL's website) of Company. The bidder has to submit an undertaking in this regard as per attached **Proforma-J.**
- **37.0 PROVISION FOR ACTION IN CASE OF ERRING/DEFAULTING AGENCIES:** Erring and defaulting agencies like bidder, contractor, supplier, vendor, service provider will be dealt as per OIL's Banning Policy dated 6th January, 2017 available in OIL's website: www.oilindia.com.

38.0 SIGNING OF CONTRACT:

- **38.1** The successful bidders(s) shall be notified by the Company of its intention to enter into an Agreement with him/her/them on the basis of his/her/their acceptance of the offer. Such notification shall be treated as a "Letter of Award (LOA)".
- **38.2** Within 02 Weeks from the date of issue of Letter of Award (LOA), the successful Bidder(s) will be required to pay an interest free Performance Security by way of Bank Guarantee (in specified format) or in the form of Demand Draft favouring "OIL INDIA LIMITED" payable at "DULIAJAN" from any Nationalized Bank. Upon furnishing of the Performance Security, the successful Bidder(s) will be required to enter into a formal Service Agreement based on the instant tender on the OIL Standard forms of agreement.
- **38.3** This Performance Security must be valid for 90 (Ninety) days after the date of expiry of the tenure of the contract. In the event of contract being extended within the provisions of the contract agreement, the contractor will have to extend suitably the validity of the "Security Deposit" for the extended period.
- **38.4** The "Performance Security" will be refunded to the contractor after 90 (Ninety) days of satisfactory completion of works/defect liability period (if any) under the contract (including extension, if any), but part or whole of which shall be used by the Company in realization of liquidated damages or claims, if any or for adjustment of compensation or loss due to the Company for any reason.
- **39.0** Time will be regarded as the essence of the Contract and the failure on the part of the Contractor to complete the work within the stipulated time shall entitle the Company to recover liquidated damages and/or penalty from the Contractor as per terms of the tender/contract.
- **40.0** The contractor will be required to allow OIL officials to inspect the work site and documents in respect of the workers' payment.
- **41.0** Failure of the successful bidders to comply with the conditions as specified in Para 38.2 above would render him liable for rejection and in turn forfeiture of Bid Security apart from any other actions the Company may take against him at its sole discretion. The bidder shall be dealt as per the Banning Policy (available in OIL's website) of Company.
- **42.0** OIL now looks forward to your active participation in the IFB.

BID EVALUATION CRITERIA (BEC)/BID REJECTION CRITERIA (BRC)

1.0 BID EVALUATION CRITERIA (BEC)

The bid shall conform generally to the specifications and terms and conditions given in the Tender Documents. Bids will be rejected in case services offered do not conform to the required parameters stipulated in the technical specifications. Not-withstanding the general conformity of the bid to the stipulated specifications, the following mandatory requirements will have to be particularly met by the Bidders without which the same will be considered as non-responsive and rejected. All the documents related to BEC must be submitted along with the Techno-Commercial Bid.

1.1 FINANCIAL CRITERIA

- 1.1.1 Annual Financial Turnover of the bidder during any of preceding 03 (Three) financial/accounting years from the original bid closing date should be at least Rs. 4,65,600.00 (Rupees Four Lakh Sixty Five Thousand Six Hundred only).
- **1.1.2** Net worth of the bidder must be Positive for the preceding financial/accounting year.

<u>Note:</u> The Net worth to be considered against Clause 1.1.2 above, should be read in conjunction with the definition of Net worth as mentioned in Section 2 (57) of the Companies Act, 2013.

Notes to BEC Clause 1.1 above:

- **a.** For proof of Annual Turnover & Net worth, any one of the following documents/photocopies must be submitted along with the bid:
 - (i) Audited Balance Sheet along with Profit & Loss account.

 OR

(ii) A certificate issued by a practicing Chartered/Cost Accountant (with Membership Number and Firm Registration Number), as per format prescribed in **Annexure-X**.

- **b.** Considering the time required for preparation of Financial Statements, if the last date of preceding financial/accounting year falls within the preceding six months reckoned from the original bid closing date and the Financial Statements of the preceding financial/accounting year are not available with the bidder, then the financial turnover of the previous three financial /accounting years excluding the preceding financial/accounting year will be considered. In such cases, the Net worth of the previous financial/accounting year excluding the preceding financial/accounting year will be considered. However, the bidder has to submit an affidavit/undertaking certifying that 'the balance sheet/Financial Statements for the financial year ______ have actually not been audited as on the Original Bid Closing date'.
- **c.** In case the bidder is a Central Govt. Organization/PSU/State Govt. Organization/Semi-State Govt. Organization or any other Central/State Govt. Undertaking, where the auditor is appointed only after the approval of Comptroller and Auditor General of India and the Central Government, their

certificates may be accepted even though FRN is not available. However, bidder to provide documentary evidence for the same.

- **d.** In case the bidder is a Government Department, they are exempted from submission of document mentioned under para **a.** and **b.** above.
- **e.** Bid will be rejected if not accompanied with adequate documentary proof in support of Annual turnover & Net worth as mentioned in Para 1.1.1 & 1.1.2.

1.2 TECHNICAL CRITERIA

i. Bidder must have experience of providing services of Heavy Transport Vehicles (viz. Tankers/Bowsers/Buses/Trucks/Tractor-Trailers/Cranes) to Central Govt./State Govt./Public Sector Undertaking/State Govt. Enterprise/any E&P Company of minimum Rs. 7,75,900.00 (Rupees Seven Lakh Seventy Five Thousand Nine Hundred only) only under single contract in previous 7(seven) years reckoned from the original bid closing date.

OR

ii. Bidder must have experience of providing services of Tankers/Bowsers to Central Govt./State Govt./Public Sector Undertaking/State Govt. Enterprise/any E&P Company continuously for a minimum period of 02 (Two) complete years under single contract in previous 07 (seven) years reckoned from the original bid closing date.

OR

iii. Bidder must have experience of providing services of attached Bowsers(s)/ Tanker(s) to Oil India Limited (i.e. experience of providing attached Tanker(s)/Bowser(s) to the contractor(s) engaged by OIL) continuously for a minimum period of 02 (Two) complete years under single contract in previous 07 (Seven) years reckoned from the original bid closing date.

Notes to BEC Clause 1.2 above:

- A. The bidder must have requisite experience under single contract for any length of time during the last 07 (Seven) years reckoned from the original bid closing date i.e. for any length of time within the period 07 (Seven) years from the original bid closing date (both days inclusive). During this period of 07 (seven) years, bidder must have the requisite experience under single contract of minimum requisite value (for bidders participating as per the experience mentioned in 1.2 (i) above)/period (for bidders participating as per the experience mentioned in 1.2 (ii)/1.2 (iii) above). - b. For bidders participating as per the experience mentioned in 1.2 (iii) above:
 - i. Contract no. against which the vehicle was deployed for OIL's operation.
 - ii. Vehicle no.
 - iii. Period for which the vehicle was deployed under the contract.
- II. In case requisite experience is not against OIL's Contract: For bidders participating as per the experience mentioned in **1.2 (i)/1.2 (ii)** above:
 - a. Copy of Contract document/Work order showing details of work.
 - b. Job Completion Certificate/Payment Certificate showing:
 - i. Gross Value of job done within the stipulated period.
 - ii. Nature of job done and Contract/work order no.
 - iii. Contract Period and Date of completion.
- **C.** Only Letter of Intent (LOI)/Letter of Award (LOA) or Work Order(s) are not acceptable as evidence.
- **D.** Mere award of contract(s) will not be counted towards experience. Successful completion of the awarded contract(s) to the extent of volume & value, as stipulated respectively under Clause No. 1.2 will only be treated as acceptable experience.
- **E.** Following work experience will also be taken into consideration:
 - i. If the prospective bidder has executed contract in which requisite work (as mentioned under Clause No. 1.2 above) is also a component of the contract.
 - ii. In case the start date of the requisite experience is beyond the prescribed 07(seven) years reckoned from the original bid closing date but completion is within the prescribed 07(seven) years reckoned from the original bid closing date.
 - iii. If the prospective bidder is executing requisite work (as mentioned under Clause No. 1.2 above) which is still running and the contract value/quantity executed prior to original bid closing date is equal to or more than the minimum prescribed value/period in the BEC.

Proof of work experience against Para **E.** above, to satisfy **a.** requisite work (as mentioned under Clause No. 1.2 above) **b.** Minimum prescribed Value (for Bidders participating as per Clause **1.2** (i) above) / period (for Bidders

participating as per Clause **1.2** (ii)/1.2 (iii) above) **c.** Prescribed period of 07 years, to be submitted as below:

- I. In case requisite experience is against OIL's Contract:
 - a. For bidders participating as per the experience mentioned in 1.2 (i) / 1.2 (ii) above:
 - i. Letter of Award (LOA)/Work order.
 - ii. SAP generated (i.e. system generated) Service Entry Sheet (SES) showing the requisite value within the stipulated period.
 - b. For bidders participating as per the experience mentioned in 1.2 (iii) above:
 - i. Contract number against which the vehicle is being deployed for OIL's operation.
 - ii. Vehicle no.
 - iii. Period for which the vehicle is being deployed under the contract.
- II. In case requisite experience is not against OIL's Contract:
 - a. For bidders participating as per the experience mentioned in **1.2 (i)** above:
 - i. Copy of Contract document/Work order showing details of work.
 - ii. Service execution certificate showing at least the following amongst others:
 - A. Gross Value of job done within the stipulated period.
 - B. Nature of job done and Contract/work order no.
 - C. Contract Start Date and Scheduled Date of completion.
 - b. For bidders participating as per the experience mentioned in 1.2 (ii) above:
 - i. Copy of Contract document/Work order showing details of work.
 - ii. Service execution certificate showing at least the following amongst others:
 - A. Nature of job done and Contract/work order no.
 - B. Contract Start Date and Scheduled Date of completion.
- **F.** SIMILAR work executed by a bidder for its own organization/subsidiary cannot be considered as experience for the purpose of meeting BEC.
- **G.** Bids submitted for part of the work will be rejected. Bid will be rejected if not accompanied with adequate documentary proof in support of Work experience as mentioned in Para 1.2.
- **1.3** Bidder(s) must offer 1(one) No. tanker conforming to the following technical specifications:
- I. Brand new rubber-lined acid tanker of 7.0 KL capacity built on a truck chassis with following specifications for handling various acid solutions up to 30% concentration.

- a. Brand new truck chassis procured & registered after issuance of LOA.
- b. Make/Model: TATA LPT 1613 or Ashok Leyland Comet 1613 or any other equivalent Make/ Model.
- c. GVW: Approx. 16000 Kg
- d. Drive: 4×2
- e. Cowl: Full Forward Control
- f. Wheelbase: Approx. 4200 mm
- g. Engine Output: Approx. 130 HP (at approx. 2400 rpm)
- h. Engine Emission: As per prevailing norms in INDIA
- i. Steering: Power Assisted
- j. Driver's Cabin: Sleeper type all steel construction original factory built by the chassis manufacturer.
- II. Overall length and overall width approx. 7750 mm and 2100 mm respectively.
- III. All metal construction leak proof tank (shell) with acid resistant rubber lining both on the inside and outside of the tank.
- IV. Acid resistant dip system for measuring the tank level in every 0.5 KL intervals.
- V. Acid resistant pump for loading and unloading the tanker and to handle hydraulic acid of up to 30% concentration. The pump shall also have provision to use it for loading & unloading of acid solutions kept in separate tanks, pumper unit, etc.
- VI. Discharge Volume capacity of 6-10 cubic meter per hour.
- VII. Suction Head of minimum 5 (five) meters and Total Head of minimum 10 (ten) meters.
- VIII. Bidder must give an undertaking as per prescribed format (Annexure-II) declaring the following that if awarded with the contract by OIL:

- **1.4** Bidder shall submit filled-up Annexure-I along with their Technical Bid. Non-receipt of duly filled up Annexure-I will make their bid liable for rejection.
- **1.5** Bidder shall place their offered vehicle for the entire period of the proposed contract agreement including the extension period, if any, except otherwise as provided under Clause-9.0 of the SCC. The bidder should execute an undertaking in favour of

OIL to the extent that offered Acid tanker shall be placed for the entire period of the proposed contract agreement including the extension period.

- **1.6** The bidder must declare (as per Annexure-III) to mobilize within maximum 04 (Four) months from the date of issue of Letter of Award (LOA) otherwise their bid will be summarily rejected.
- **1.7** A substantially responsive bid is one that meets the terms and conditions of the Tender and/or the acceptance of which bid will not result in indeterminate liability on OIL.
- **1.8** Bidders are required to quote for all the items as per Price Bid Format; otherwise the offer of the bidder will be straightway rejected.
- **1.9** If there is any discrepancy between the unit price and the total price, the unit price will prevail and the total price shall be corrected. Similarly, if there is any discrepancy between words and figure, the amounts in words shall prevail and will be adopted for evaluation.
- **1.10** The quantities shown against each item in the "Price Bid Format" shall be considered for the purpose of Bid Evaluation. It is, however, to be clearly understood that the assumptions made in respect of the quantities for various operations are only for the purpose of evaluation of the bid and the Contractor will be paid on the basis of the actual number of days/parameter, as the case may be.
- **1.11** The bidders are advised not to offer any discount/rebate separately and to offer their prices in the Price Bid Format after considering discount/rebate, if any.
- **1.12** Conditional and unsolicited discount will not be considered in evaluation. However, if such bidder happens to be the lowest recommended bidder, unsolicited discount without any condition will be considered for computing the contract price.
- **1.13** In case of identical overall lowest offered rate by more than 1 (one) bidder, the selection will be made by draw of lot between the parties offering the same overall lowest price.
- **1.14 PURCHASE PREFERENCE CLAUSE:** Purchase Preference to Micro and Small Enterprises registered with District Industry Centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by Ministry of MSME:
- **1.14.1** In case participating MSEs Quote price within price band of L1+15%, such MSE shall be considered for award of contract by bringing down their price to L1 price in a situation where L1 price is from someone other than a MSE.
- **1.14.2** In case of more than one such MSE qualifying for 15% purchase preference, the contract shall be awarded to lowest eligible MSE amongst the MSEs qualifying for 15% purchase preference.

- 1.14.3 <u>Documentation required to be submitted by MSEs:</u> Copy of valid Registration Certificate, if bidder is a Micro or Small Enterprises (MSE) registered with District Industry Centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or Udyog Aadhaar Memorandum any other body specified by Ministry of MSME. The Registration Certificate should clearly indicate the monetary limit, if any and the items for which bidder are registered with any of the aforesaid agencies. In case bidding MSE is owned by Schedule Caste or Schedule Tribe entrepreneur, valid documentary evidence issued by the agency who has registered the bidder as MSE owned by SC/ST entrepreneur should also be enclosed.
- **1.15** Price Bids shall be evaluated on overall lowest cost to OIL (L-1 offer) basis i.e. considering total quoted price for all services including applicable GST(CGST & SGST/UTGST or IGST).
- **1.16** OIL will prefer to deal with registered bidder under GST. Therefore, bidders are requested to get themselves registered under GST, if not registered yet.

However, in case any unregistered bidder is submitting their bid, their prices will be loaded with applicable GST while evaluation of bid. Where OIL is entitled for input credit of GST, the same will be considered for evaluation of bid as per evaluation methodology of tender document.

1.17 Price Bid uploaded without giving any of the details of the taxes (Including rates and amounts) will be considered as inclusive of all taxes including GST.

When a bidder mentions taxes as extra without specifying the rates & amount, the offer will be loaded with maximum value towards taxes received against the tender for comparison purposes. If the bidder emerges as lowest bidder after such loading, in the event of order on that bidder, taxes mentioned by OIL on the Purchase Order/Contracts will be binding on the bidder.

- **1.18** Input Tax Credit on GST (Goods & Service Tax) for this service is NOT available to OIL & the bids will be evaluated based on total price including GST.
- **1.19** Based on the evaluation of techno-commercially qualified bidders, the job will be awarded to L-1 bidder.

2.0 BID REJECTION CRITERIA (BRC):

- **2.1** The bids are to be submitted under Single Stage Composite Bid system i.e. Unpriced Techno-Commercial Bid and Price Bid together. Only the Price Bid should contain the quoted price.
- **2.2** The price quoted by the successful bidder must be firm during the performance of the contract and not subject to variation on any account except as mentioned in the bid document. - **2.6** Bids shall be typed or written in indelible ink. The bidder or his authorized representative shall sign the bid digitally, failing which the bid will be rejected.
- **2.7** Bids shall contain no interlineations, erasures or overwriting except as necessary to correct errors made by bidder, in which case such corrections shall be initiated by the persons(s) signing (digitally) the bid. However, white fluid should not be used for making corrections. Any bid not meeting this requirement shall be rejected.
- **2.8** Any bid containing false statement will be rejected and action will be taken by Company as per Bid Document.
- **2.9** Bidders must quote clearly and strictly in accordance with the price schedule outlined in Price Bidding Format attached under "Notes and Attachments" tab in the main bidding engine of OIL's E-Tender portal; otherwise the bid will be rejected. All other techno-commercial documents other than price details to be submitted with Unpriced Techno-Commercial Bid as per tender requirement under "Technical Attachment" Tab Page only.
- **2.10** Bidder must accept and comply with the following provisions as given in the Tender Document in toto, failing which offer will be rejected:
 - (i) Firm price
 - (ii) EMD/Bid Bond
 - (iii) Period of validity of Bid
 - (iv) Price Schedule
 - (v) Performance Bank Guarantee/Security deposit
 - (vi) Delivery/Completion Schedule
 - (vii) Scope of work
 - (viii) Guarantee of material/work
 - (ix) Liquidated Damages clause
 - (x) Tax liabilities
 - (xi) Arbitration/Resolution of Dispute Clause
 - (xii) Force Majeure
 - (xiii) Applicable Laws
 - (xiv) Specifications
 - (xv) Integrity Pact
- **2.11** There should not be any indication of price in the Un-priced Techno-Commercial Bid. A bid will be straightway rejected if this is given in the Un-priced Techno Commercial Bid.
- **2.12** Bid received with validity of offer less than 90 (Ninety) days from the date of Technical Bid opening will be rejected.

2.13 The Integrity Pact is applicable against this tender. OIL shall be entering into an Integrity Pact with the bidders as per format enclosed vide "Part-VI/Integrity Pact" of the tender document. This Integrity Pact proforma has been duly signed digitally by OIL's competent signatory. The proforma has to be returned by the bidder (along with the Un-priced Techno-Commercial Bid) duly signed (digitally) by the same signatory who signed the bid, i.e., who is duly authorized to sign the bid. Uploading the Integrity Pact with digital signature will be construed that all pages of the Integrity Pact has been signed by the bidder's authorized signatory who sign the Bid.

3.0 GENERAL:

- **3.1** In case bidder takes exception to any clause of bidding document not covered under BEC/BRC, then the Company has the discretion to load or reject the offer on account of such exception if the bidder does not withdraw/modify the deviation when/as advised by company. The loading so done by the company will be final and binding on the bidders. No deviation will however be accepted in the clauses covered under BEC/BRC.
- **3.2** To ascertain the substantial responsiveness of the bid the Company reserves the right to ask the bidder for clarification in respect of clauses covered under BEC/BRC also and such clarifications fulfilling the BEC/BRC clauses in toto must be received on or before the deadline given by the company, failing which the offer will be will be evaluated based on the submission. However, mere submission of such clarification shall not make the offer responsive, unless company is satisfied with the substantial responsiveness of the offer.
- **3.3** If any of the clauses in the BEC/BRC contradict with other clauses of bidding document elsewhere, the clauses in the BEC/BRC shall prevail.

Brand new Rubber-Lined Acid Tanker of 7.0 KL capacity built on a 16 MT GVW capacity 4x2 brand new truck chassis and complete with acid resistant loading & unloading pump and dip system for transportation of various acid solutions up to 30% concentration in OIL's operational areas in Assam & Arunachal Pradesh for a period of 04 (four) years.

A. **DEFINITIONS:**

In the contract, the following terms shall be interpreted as indicated:

- (a) "**The Contract**" means agreement entered into between Company and Contractor, as recorded in the contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein;
- (b) "**The Contract Price**" means the price payable to Contractor under the contract for the full and proper performance of its contractual obligations;
- (c) "**The Work**" means each and every activity required for the successful performance of the services described in Section II, the Terms of Reference.
- (d) "Company" or "OIL" means Oil India Limited;
- (e) "**Contractor**" means the Contractor performing the work under this Contract.
- (f) "**Contractor's Personnel**" means the personnel to be provided by the Contractor to provide services as per the contract.
- (g) "Company's Personnel" means the personnel to be provided by OIL or OIL's Contractor (other than the Contractor executing the Contract). The Company representatives of OIL are also included in the Company's personnel.
- (h) "Gross Negligence" means any act or failure to act (whether sole, joint or concurrent) by a person or entity which was intended to cause, or which was in reckless disregard of or wanton indifference to, avoidable and harmful consequences such person or entity knew, or should have known, would result from such act or failure to act. Notwithstanding the foregoing, Gross negligence shall not include any action taken in good faith for the safeguard of life or property.
- (i) **"Willful Misconduct"** means intentional disregard of good and prudent standards of performance or proper conduct under the Contract with knowledge that it is likely to result in any injury to any person or persons or loss or damage of property.

WITNESSETH:

1.0 a) The contractor hereby agrees to carry out the work set down in the Schedule of work which forms part-II of this Contract in accordance with the 1968 General Conditions

of Contract of Oil India Limited and General Specifications read in conjunction with any drawings and Particular Specifications & instructions which forms Part-III of the contract utilizing any materials/services as offered by the Company as per Part-IV of the contract in **OIL's operational areas in Assam & Arunachal Pradesh.**

- b) In this Contract all words and expressions shall have the same meaning as are respectively assigned to them in the 1968 General Conditions of Contract of Oil India Limited which the Contractor has perused and is fully conversant with before entering into this Contract.
- c) The clauses of this contract and of the specifications set out hereunder shall be paramount and in the event of anything herein contained being inconsistent with any term or terms of the 1968 General Conditions of Contract of Oil India Limited, the said term or terms of the 1968 General conditions of Contract to the extent of such inconsistency, and no further, shall not be binding on the parties hereto.
- **2.0** The contractor shall provide all labour, supervision and transport and such specified materials described in part-II of the Contract including tools and plants as necessary for the work and shall be responsible for all royalties and other levies and his rates shall include for these. The work executed and materials supplied shall be to the satisfaction of the Company's Engineer and Contractor's rates shall include for all incidental and contingent work which although not specifically mentioned in this contract are necessary for its completion in a sound and workman like manner.
- **3.0** The Company's Engineer shall have power to:
- a) Reduce the rates at which payments shall be made if the quality of work although acceptable is not up to the required standard set forth in the OIL Standard Specifications which have been perused and fully understood by the Contractor.
- b) Order the Contractor to remove any inferior material from the site and to demolish or rectify any work of inferior workmanship, failing which the Company's Engineer may arrange for any such work to be demolished or rectified by any other means at the Contractor's expenses.
- c) Order the Contractor to remove or replace any workman who he (The Engineer) considers incompetent or unsuitable; the Engineer's opinion as to the competence and suitability of any workman engaged by the Contractor shall be final and binding on the Contractor.
- d) Issue to the Contractor from time to time during the progress of the work such further drawings and instructions as shall be necessary for the purpose of proper and adequate execution and maintenance of the works and the Contractor shall carry out and be bound by the same.
- e) Order deviations in Part II and III of this Contract. All such deviation orders shall be in writing and shall show the financial effect, if any, of such deviation and whether any extra time is to be allowed.
- **4.0** The Contractor shall have no claim against the company in respect of any work which may be withdrawn but only for work actually completed under this contract. The contractor shall have no objection to carry out work in excess of the quantities stipulated in Part-II if so ordered by the company at the same rates, terms and conditions.
- **5.0** The Company reserves the right to cancel this Contract at any time upon full payment of work done and the value of the materials collected by the contractor for

permanent incorporation in the work under this contract particularly for execution of this contract up to the date of cancellation of the Contract. The valuation of the work done and the materials collected shall be estimated by the company's Engineer in presence of the contractor. The Contractor shall have no claim to any further payment whatsoever. The valuation would be carried out exparte if Contractor fails to turn up despite reasonable notice which will be binding on the Contractor.

- **6.0** The Contractor hereby undertakes to indemnify the Company against all claims which may arise under the under noted Acts:
 - i) The Mines Act.
 - ii) The Minimum Wages Act, 1948.
 - iii) The Workman's Compensation Act, 1923.
 - iv) The Payment of wages Act, 1936.
 - v) The Payment of Bonus Act, 1965.
 - vi) The Contract Labour (Regulation & Abolition) Act, 1970 and the rules framed there under.
 - vii) Employees' Pension Scheme, 1995.
 - viii) Inter-State Migrant (Regulation of Employment and Condition of Service) Act. 1979.
 - ix) The Employees Provident Fund and Miscellaneous Provisions Act, 1952.
 - x) GST Act.

or any other Acts or Statute not here in above specifically mentioned having bearing over engagement of workers directly or indirectly for execution of work. The Contractor shall not make the Company liable to reimburse the Contractor for the statutory increase in the wage rates of the Contract Labour appointed by the Contractor. Such Statutory increase in the wage rates of Contract Labour shall be borne by the contractor.

- **7.0** The Contractor shall clear away all rubbish and surplus material from the site on completion of work and shall leave the site clean and tidy.
- **8.0** The duration of the contract shall be initially for a period of **04 (Four) Years** from the commencement of the same i.e. after completion of mobilization as per Company's requirement. The Contractor must complete the work as mentioned in PART III (SPECIAL CONDITIONS OF CONTRACT: SCC) within the contract period. In the event of there being undue delay in execution of the Contract, the Company reserves the right to cancel the Contract and/or levy such additional damages as it deems fit based on the actual loss suffered by the company attributable to such delay. The company's decision in this regard shall be final.
- **9.0** In order to promote, safeguard and facilitate the general operational economic in the interest of the Company during the continuance of this contract the Contractor hereby agrees and undertakes not to take any direct or indirect interest and or support, assist, maintain or help any person or persons engaged in antisocial activities, demonstration, riots, or in any agitation prejudicial to the Company's interest and any such even taking shape or form at any place of the Company's works or and its neighborhood.

- **11.0** The contractor employing **20 (twenty)** or more workmen on any day preceding 12 months shall be required to obtain requisite license at his cost from the appropriate Licensing Officer before undertaking any Contract work. The Contractor shall also observe the rules & regulations framed under the Contract Labour (Regulation & Abolition) Act.
- **12.0** The Contractor will not be allowed to construct any structure (for storage/housing purpose) with thatch, bamboo or any other inflammable materials within any company's fenced area.
- **13.0** The Contractor shall ensure that all men engaged by him/her are provided with appropriate protective clothing and safety wear in accordance with regulation 89(a) and 89(b) in the Oil Mines Regulations 1984. The Company's representative shall not allow/accept those men who are not provided with the same.
- **14.0** The Contractor shall deploy local persons in all works.
- **15.0** The Contractor shall not engage minor labour below 18 (eighteen) years of age under any circumstances.
- **16.0** The Contractor and his/her workmen shall strictly observe the rules and regulations as per Mines Act (Latest editions).

17.0 GENERAL OBLIGATIONS OF COMPANY:

COMPANY shall, in accordance with and subject to the terms and conditions of this contract:

- i) Pay the Contractors in accordance with terms and conditions of the contract.
- ii) Allow access to Contractors and their personnel, subject to normal security and safety procedures, to all areas as required for orderly performance of the work.

18.0 SPECIAL CONDITIONS:

- a) The amount of retention money shall be released after 6 (six) months from the date of issue of completion certificate from concerned department.
- b) The contractor will be required to allow OIL Officials to inspect the work site and documents in respect of the workers' payment.

c) Contractor(s) whosoever is liable to be covered under the P.F. Act and contract cost is inclusive of P.F., must ensure strict compliance of provisions of Provident Fund and Miscellaneous Provisions Act, 1952 in addition to the various Acts mentioned elsewhere in this contract. Any contractor found violating these provisions will render themselves disqualified from any future tendering. As per terms of the contract, if applicable, the Contractor must deposit Provident Fund Contribution (covering Employee's & Employer's share) with the competent authority monthly under their direct code. The Contractor shall be required to submit documentary evidence of deposit of P.F. Contribution to the Company. In case of failure to provide such documentary evidence, the Company reserves the right to withhold the amount equivalent to applicable P.F. Contribution.

19.0 ARBITRATION:

19.1 ARBITRATION (APPLICABLE FOR SUPPLIERS/CONTRACTORS OTHER THAN PSU)

Except as otherwise provided elsewhere in the contract, if any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, in connection with construction, meaning, operation, effect, interpretation of the contract or breach thereof which parties are unable to settle mutually, the same shall be referred to Arbitration as provided hereunder:

- a) A party wishing to commence arbitration proceeding shall invoke Arbitration Clause by giving 30 days' notice to the other party. The notice invoking arbitration shall specify all the points of dispute with details of the amount claimed to be referred to arbitration at the time of invocation of arbitration and not thereafter. If the claim is in foreign currency, the claimant shall indicate its value in Indian Rupee for the purpose of constitution of the arbitral tribunal.
- **b)** The number of arbitrators and the appointing authority will be as under:

- **c)** The parties agree that they shall appoint only those persons as arbitrators who accept the conditions of the arbitration clause. No person shall be appointed as Arbitrator or Presiding Arbitrator who does not accept the conditions of the arbitration clause.
- **d)** Parties agree that there will be no objection if the Arbitrator appointed holds equity shares of OIL and/or is a retired officer of OIL/any PSU. However, neither party shall appoint its serving employees as arbitrator.

- e) If any of the Arbitrators so appointed dies, resigns, becomes incapacitated or withdraws for any reason from the proceedings, it shall be lawful for the concerned party/arbitrators to appoint another person in his place in the same manner as aforesaid. Such person shall proceed with the reference from the stage where his predecessor had left if both parties consent for the same; otherwise, he shall proceed de novo.
- f) Parties agree that neither shall be entitled for any pre-reference or pendente-lite interest on its claims. Parties agree that any claim for such interest made by any party shall be void.
- **g)** The arbitral tribunal shall make and publish the award within time stipulated as under:

The above time limit can be extended by Arbitrator, for reasons to be recorded in writing, with the consent of the other parties.

- **h)** If after commencement of the arbitration proceedings, the parties agree to settle the dispute mutually or refer the dispute to conciliation, the arbitrators shall put the proceedings in abeyance until such period as requested by the parties.
- i) Each party shall be responsible to make arrangements for the travel and stay etc. of the arbitrator pointed by it. Claimant shall also be responsible for making arrangements for travel/stay arrangements of the Presiding Arbitrator and the expenses incurred shall be shared equally by the parties.
 - In case of sole arbitrator, OIL shall make all necessary arrangements for his travel, stay and the expenses incurred shall be shared equally by the parties.
- **j)** The Arbitration shall be held at **Duliajan, Assam**. However, parties to the contract can agree for a different place for the convenience of all concerned.
- **k)** The Arbitrator(s) shall give reasoned and speaking award and it shall be final and binding on the parties.
- 1) Subject to aforesaid, provisions of the Arbitration and Conciliation Act, 1996 and any statutory modifications or re-enactment thereof shall apply to the arbitration proceedings under this clause.

19.2 <u>ARBITRATION (APPLICABLE IN CASE OF CONTRACT AWARDED ON PUBLIC</u> SECTOR ENTERPRISE):

In the event of any dispute or difference relating to, arising from or connected with the Contract, such dispute or difference shall be referred by either party to the arbitration of one of the Arbitrators in the Department of Public Enterprises, to be nominated by the Secretary to the Government of India, In-Charge of the Bureau of Public Enterprises. The

Arbitration and Conciliation Act 1996 shall not be applicable to the Arbitration under this clause. The award of the Arbitrator shall be binding upon the parties to the dispute, provided however, any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law Secretary, Deptt. of Legal Affairs, Ministry of Law and Justice, Government of India. Upon such reference, the dispute shall be decided by the Law Secretary or the Special Secretary/Additional Secretary, whose decision shall bind the parties finally and conclusively. The parties in the dispute will share equally the cost of the arbitration as intimated by the Arbitrator.

The venue of all arbitrations under both 19.1 & 19.2 will be **Duliajan, Assam**. The award made in pursuance thereof shall be binding on the parties.

20.0 FORCE MAJEURE:

20.1 In the event of either party being rendered unable by 'Force majeure' to perform any obligations required to be performed by them under the contract the relative obligations of the party affected by such 'Force Majeure' shall upon notification to the other party be suspended for the period during which force majeure event lasts. The cost and loss sustained by the either party shall be borne by the respective parties.

The term 'Force Majeure' as employed herein shall mean acts of God, earthquake, war (declared/undeclared) revolts, riots, fires, floods, rebellions, explosions, hurricane, sabotage, civil commotions, and acts and regulations of respective Govt. of the two parties, namely the Company and the contractor.

20.2 Upon the occurrence of such cause(s) and upon its termination, the party alleging that it has been rendered unable as aforesaid thereby, shall notify the other party in writing immediately but not later than 72 (Seventy-two) hours of the alleged beginning and ending thereof giving full particulars and satisfactory evidence in support of its claim.

Time for performance of the relative obligations suspended by the force majeure shall then extended by the period for which such cause lasts.

20.3 Should 'force majeure' condition as stated above occurs and should the same be notified within Seventy-Two (72) hours after its occurrence the 'force majeure' rate shall apply for the first fifteen days. Parties will have the right to terminate the Contract if such 'force majeure' conditions continue beyond fifteen (15) days with prior written notice. Should either party decide not to terminate the Contract even under such condition, no payment would apply after expiry of fifteen (15) days force majeure period unless otherwise agreed to.

21.0 TERMINATION:

- **21.1 TERMINATION ON EXPIRY OF THE TERMS (DURATION):** The contract shall be deemed to have been automatically terminated on the expiry of duration of the Contract or the extension period, if exercised by Company under the provision of the Contract.
- **21.2 TERMINATION ON ACCOUNT OF FORCE MAJEURE:** Either party shall have the right to terminate this Contract on account of Force Majeure as set forth in Article 20.0 above.
- **21.3 TERMINATION ON ACCOUNT OF INSOLVENCY:** In the event that the Contractor or its collaborator at any time during the term of the Contract, becomes insolvent or

makes a voluntary assignment of its assets for the benefit of creditors or is adjudged bankrupt, then the Company shall, by a notice in writing have the right to terminate the Contract and all the Contractor's rights and privileges hereunder, shall stand terminated forthwith.

- **21.4 TERMINATION FOR UNSATISFACTORY PERFORMANCE:** If the Company considers that, the performance of the Contractor is unsatisfactory, or not up to the expected standard, the Company shall notify the Contractor in writing and specify in details the cause of the dissatisfaction. The Company shall have the option to terminate the Contract by giving 15 days' notice in writing to the Contractor, if Contractor fails to comply with the requisitions contained in the said written notice issued by the Company.
- **21.5 TERMINATION DUE TO CHANGE OF OWNERSHIP & ASSIGNMENT:** In case the Contractor's rights and/or obligations under this Contract and/or the Contractor's rights, title and interest to the equipment/material, are transferred or assigned without the Company's consent, the Company may at its absolute discretion, terminate this Contract.
- **21.6** If at any time during the term of this Contract, breakdown of Contractor's equipment results in Contractors being unable to perform their obligations hereunder for a period of 15 successive days, Company at its option, may terminate this Contract in its entirely without any further right or obligation on the part of the Company, except for the payment of money then due. No notice shall be served by the Company under the condition stated above.
- **21.7** Notwithstanding any provisions herein to the contrary, the Contract may be terminated at any time by the Company on giving 30 (thirty) days written notice to the Contractor due to any other reason not covered under the above clause from 21.1 to 21.6 and in the event of such termination the Company shall not be liable to pay any cost or damage to the Contractor except for payment for services as per the Contract upto the date of termination including the De-mob cost, if any.
- **22.0 CONSEQUENCES OF TERMINATION:** In all cases of termination herein set forth, the relative obligations of the parties to the Contract shall be limited to the period up to the date of termination. Notwithstanding the termination of this Contract, the parties shall continue to be bound by the provisions of this Contract that reasonably require some action or forbearance after such termination.
- **22.1** Upon termination of this Contract, Contractor shall return to Company all of Company's items, which are at the time in Contractor's possession.
- **22.2** In the event of termination of contract, Company will issue Notice of termination of the contract with date or event after which the contract will be terminated. The contract shall then stand terminated and the Contractor shall demobilize their personnel & materials.
- **23.0 I.B. VERIFICATION REPORT AND SECURITY REVIEW:** Contractor will be required to submit the verification report to ascertain character and antecedents from the Civil Administration towards the persons engaged under this contract to the Head of the user Department before engagement.

- **24.0** In case of any doubt or dispute as to the interpretation of any clause herein contained, the decision of the Company's Engineer shall be final and binding on the contractor.
- **25.0 SET OFF CLAUSE:** "Any sum of money due and payable to the contractor (including Security Deposit refundable to them) under this or any other contract may be appropriated by Oil India Limited and set off against any claim of Oil India Limited (or such other person or persons contracting through Oil India Limited) for payment of a sum of money arising out of this contract or under any other contract made by the contractor with Oil India Limited (or such other person or persons contracting through Oil India Limited)."
- **26.0 FURNISHING FRAUDULENT INFORMATION/DOCUMENT:** The information and documents furnished by the bidder/contractor in respect of the subject tender/contract are expected to be true and genuine. However, if it is detected during technical scrutiny or after award of the contract or after expiry of the contract, that the bidder had submitted any fake/fraudulent document or furnished false statement, the offer/contract shall be rejected/cancelled, as the case may be and the bidder (if fake document/false statement pertains to such bidder) shall be dealt as per the Banning Policy (available in OIL's website) of Company.
- **27.0 PROVISION FOR ACTION IN CASE OF ERRING/DEFAULTING AGENCIES:** Action against erring and defaulting agencies like bidder, contractor, supplier, vendor, service provider will be as per OIL's Banning Policy dated 6th January, 2017 available in OIL's website www.oil-india.com.
- **28.0 LIQUIDATED DAMAGES FOR DELAY IN MOBILIZATION/COMPLETION OF WORKS AND SERVICES:** In the event of the Contractor's default in timely mobilization/completion within the stipulated period, the Contractor shall be liable to pay liquidated damages @ 0.5% of contract value, per week or part thereof of delay subject to maximum ceiling of 7.5% of contract value.
- **29.0 SUBCONTRACTING:** CONTRACTORS shall not subcontract or assign, in whole or in part, their obligations to perform under this contract, except with COMPANY'S prior written consent.
- **30.0 MISCELLANEOUS PROVISIONS:** Contractors shall conform in all respects with the provisions of any Statute, Ordinance of Law and the regulations or bye-law of any local or other duly constituted authority which may be applicable to the services and with such rules and regulation public bodies and Companies as aforesaid and shall keep OIL indemnified against all penalties and liability of every kind for breach of any such Statute, Ordinance or Law, regulation or byelaw.

31.0 LIABILITY:

31.1 Except as otherwise expressly provided, neither Company nor its servants, agents, nominees, Contractors, or sub-contractors shall have any liability or responsibility whatsoever to whomsoever for loss of or damage to the equipment and/or loss of or damage to the property of the Contractor and/or their Contractors or sub-contractors, irrespective of how such loss or damage is caused and even if caused by the negligence of Company and/or its servants, agent, nominees, assignees, contractors and sub-

contractors. The Contractor shall protect, defend, indemnify and hold harmless Company from and against such loss or damage and any suit, claim or expense resulting there from.

- **31.2** Neither Company nor its servants, agents, nominees, assignees, Contractors, subcontractors shall have any liability or responsibility whatsoever for injury to, illness, or death of any employee of the Contractor and/or of its contractors or sub-contractor irrespective of how such injury, illness or death is caused and even if caused by the negligence of Company and/or its servants, agents nominees, assignees, Contractors and sub-contractors. Contractor shall protect, defend, indemnify and hold harmless Company from and against such liabilities and any suit, claim or expense resulting there from.
- **31.3** The Contractor hereby agrees to waive its right to recourse and further agrees to cause their underwriters to waive their right of subrogation against Company and/or its underwrites, servants, agents, nominees, assignees, Contractors and sub-contractors for loss or damage to the equipment of the Contractor and/or its sub-contractors when such loss or damage or liabilities arises out of or in connection with the performance of the contract.
- **31.4** The Contractor hereby further agrees to waive its right of recourse and agrees to cause its underwriters to waive their right of subrogation against Company and/or its underwriters, servants, agents, nominees, assignees, Contractors and sub-contractors for injury to, illness or death of any employee of the Contractor and of its contractors, sub-contractors and/or their employees when such injury, illness or death arises out of or in connection with the performance of the contract.
- **31.5** Except as otherwise expressly provided, neither Contractor nor its servants, agents, nominees, Contractors or sub-contractors shall have any liability or responsibility whatsoever to whomsoever for loss of or damage to the equipment and/or loss or damage to the property of the Company and/or their Contractors or sub-contractors, irrespective of how such loss or damage is caused and even if caused by the negligence of Contractor and/or its servants, agents, nominees, assignees, Contractors and sub-contractors. The Company shall protect, defend, indemnify and hold harmless Contractor from and against such loss or damage and any suit, claim or expense resulting therefrom.
- **31.6** Neither Contractor nor its servants, agents, nominees, assignees, Contractors, subcontractors shall have any liability or responsibility whatsoever to whomsoever or injury or illness, or death of any employee of the Company and/or of its contractors or subcontractors irrespective of how such injury, illness or death is caused and even if caused by the negligence of Contractor and/or its servants, agents, nominees, assignees, contractors and sub-contractors. Company shall protect, defend indemnify and hold harmless Contractor from and against such liabilities and any suit, claim or expense resulting there from.
- **31.7** The Company agrees to waive its right of recourse and further agrees to cause its underwriters to waive their right of subrogation against Contractor and/or its underwriters, servants, agents, nominees, assignees, Contractors and sub-contractors for loss or damage to the equipment of Company and/or its contractors or sub-contractors when such loss or damage or liabilities arises out of or in connection with the performance of the contract.
- **31.8** The Company hereby further agrees to waive its right of recourse and agrees to cause it underwriters to waive their right of subrogation against Contractor and/or its

underwriters, servants, agents, nominees, assignees, Contractors and sub-contractors for injury to, illness or death of any employee of the Company and of its Contractors, sub-contractors and/or their employees when such injury, illness or death arises out of or in connection with the performance of the Contract.

- **31.9 LIMITATION OF LIABILITY:** Notwithstanding any other provisions except only in cases of willful misconduct and/or criminal acts,
- (a) Neither the Contractor nor the Company (OIL) shall be liable to the other, whether in Contract, tort, or otherwise, for any consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs.
- **(b)** Notwithstanding any other provisions incorporated elsewhere in the contract, the aggregate liability of the Contractor in respect of this contract, whether under Contract, in tort or otherwise, shall not exceed 100% of the Contract price, provided however that this limitation shall not apply to the cost of repairing or replacing defective equipment by the Contractor, or to any obligation of the Contractor to indemnify the Company with respect to Intellectual Property Rights.

Company shall indemnify and keep indemnified Contractor harmless from and against any and all claims, costs, losses and liabilities in excess of the aggregate liability amount in terms of clause (b) above.

32.0 CONSEQUENTIAL DAMAGE: Except as otherwise expressly provided, neither party shall be liable to the other for special, indirect or consequential damages resulting from or arising out of the contract, including but without limitation, to loss or profit or business interruptions, howsoever caused and regardless of whether such loss or damage was caused by the negligence (either sole or concurrent) of either party, its employees, agents or sub-contractors.

33.0 INDEMNITY AGREEMENT:

- **33.1** Except as provided hereof Contractor agrees to protect, defend, indemnify and hold Company harmless from and against all claims, suits, demands and causes of action, liabilities, expenses, cost, liens and judgments of every kind and character, without limit, which may arise in favour of Contractor's employees, agents, Contractors and subcontractors or their employees on account of bodily injury or death, or damage to personnel/property as a result of the operations contemplated hereby, regardless of whether or not said claims, demands or causes of action arise out of the negligence or otherwise, in whole or in part or other faults.
- **33.2** Except as provided hereof Company agrees to protect, defend, indemnify and hold Contractor harmless from and against all claims, suits, demands and causes of action, liabilities, expenses, cost, liens and judgments of every kind and character, without limit, which may arise in favour of Company's employees, agents, Contractor and subcontractors or their employees on account of bodily injury or death, or damage to personnel/property as a result of the operations contemplated hereby, regardless of whether or not said claims, demands or causes of action arise out of the negligence or otherwise, in whole or in part or other faults.

34.0 APPLICABLE LAW:

- **34.1** This Contract shall be deemed to be a Contract made under, governed by and construed in accordance with the laws of India for the time being in force and shall be subject to the exclusive jurisdiction of Courts situated at Dibrugarh in Assam.
- **34.2** The Bidders shall ensure full compliance of various Indian Laws and Statutory Regulations, to the extent applicable for performing under this Contract.
- **35.0** <u>TAXES</u>: Tax levied as per the provisions of Indian Income Tax Act and any other enactment/rules on income derived/payments received under the contract will be on Contractor's account.

36.0 SUBSEQUENTLY ENACTED LAWS:

- **36.1** In the event of introduction of any new legislation or any change or amendment or enforcement of any Act or Law, rules or regulations of Government of India or State Government(s) or Public Body which becomes effective after the date of submission of Price Bid or revised price bid, if any, for this CONTRACT and which results in increased/decreased cost of the works under the CONTRACT increased/decreased liability of taxes, (other than personnel and Corporate taxes), duties, the Parties shall agree to a revision in pricing to reflect such change subject to the production of documentary proof to the satisfaction of the COMPANY/CONTRACTOR as applicable to the extent which directly is attributable to such introduction of new legislation or change or amendment as mentioned above and adjudication by the competent authority (applicable when disputed by COMPANY) & the courts wherever levy of such taxes/duties are disputed by COMPANY/CONTRACTOR.
- **36.2** Any increase in net amount of the duties and taxes (i.e. the amount of taxes/duties payable minus eligible credit of taxes/duties paid on input services/inputs) after the contractual completion/mobilization date during the extended period will be to the contractor's account, where delay in completion/mobilization period is attributable to the CONTRACTOR. However, any decrease in net amount of the duties and taxes (i.e. the amount of taxes/duties payable minus eligible credit of taxes/duties paid on input services/inputs) after the contractual completion/mobilization date will be to COMPANY's account.
- **36.3** The Contract Price and other prices given in the Schedule of Prices are based on the applicable tariff as indicated by the CONTRACTOR in the Schedule of Prices. In case this information subsequently proves to be wrong, incorrect or misleading, COMPANY will have no liability to reimburse/pay to the CONTRACTOR the excess duties, taxes, fees, if any finally levied/imposed by the concerned authorities. However, in such an event, COMPANY will have the right to recover the difference in case the rate of duty/tax finally assessed is on the lower side.
- **36.4** Notwithstanding the provision contained in clause 28.1 to 28.2 above, the COMPANY shall not bear any liability in respect of:
 - i. Personal taxes on the personnel deployed by CONTRACTOR, his sub-contractor/sub-sub-contractors and Agents etc.

- ii. Corporate taxes and Fringe benefit tax in respect of contractor and all of their subcontractors, agents etc.
- iii. Other taxes & duties including Customs Duty, Excise Duty and Service Tax in addition to new taxes etc. in respect of sub-contractors, vendors, agents etc. of the CONTRACTOR.
- **36.5** In order to ascertain the net impact of the revisions/enactment of various provisions of taxes/duties, the CONTRACTOR is liable to provide following disclosure to COMPANY:
 - i. Details of each of the input services used in relation to providing service to COMPANY including estimated monthly value of input service and service tax amount.
 - ii. Details of Inputs (material/consumable) used/required for providing service to Company including estimated monthly value of input and excise duty/CVD paid/payable on purchase of inputs.

37.0 GOODS AND SERVICES TAX:

37.1 GENERAL REMARKS ON TAXES & DUTIES:

In view of **GST** Implementation from 1st July 2017, all taxes and duties including Excise Duty, CST/VAT, Service tax, Entry Tax and other indirect taxes and duties have been submerged in **GST**. Accordingly reference of Excise Duty, Service Tax, VAT, Sales Tax, Entry Tax or any other form of indirect tax except of **GST** mentioned in the bidding document shall be ignored.

- **37.2** Bidders are required to submit copy of the GST Registration Certificate while submitting the bids wherever **GST** (CGST & SGST/UTGST or IGST) is applicable.
- **37.3** "**GST**" shall mean Goods and Services Tax charged on the supply of material(s) and services. The term "**GST**" shall be construed to include the Integrated Goods and Services Tax (hereinafter referred to as "IGST") or Central Goods and Services Tax (hereinafter referred to as "CGST") or State Goods and Services Tax (hereinafter referred to as "SGST") or Union Territory Goods and Services Tax (hereinafter referred to as "UTGST") depending upon the import/interstate or intrastate supplies, as the case may be. It shall also mean GST compensation Cess, if applicable.
- 37.4 Quoted price/rate(s) should be inclusive of all taxes and duties, except GST (i.e. IGST or CGST and SGST/UTGST applicable in case of interstate supply or intra state supply respectively and cess on GST if applicable) on the final service. However, GST rate (including cess) to be provided in the respective places in the Price Bid. Please note that the responsibility of payment of GST (CGST & SGST or IGST or UTGST) lies with the Supplier of Goods/Services (Service Provider) only. Supplier of Goods/Services (Service Provider) providing taxable service shall issue an Invoice/Bill, as the case may be as per rules/regulation of GST. Further, returns and details required to be filled under GST laws & rules should be timely filed by Supplier of Goods/Services (Service Provider) with requisite details.
- **37.4.1** Bidder should also mention the **Harmonized System of Nomenclature** (HSN) and **Service Accounting Codes (SAC)** at the designated place in SOR.

37.5 Where the OIL is entitled to avail the input tax credit of GST:

- **37.5.1** OIL will reimburse the **GST** to the Supplier of Goods/Services (Service Provider) at actuals against submission of Invoices as per format specified in rules/regulation of GST to enable OIL to claim input tax credit of **GST** paid. In case of any variation in the executed quantities, the amount on which the **GST** is applicable shall be modified in same proportion. Returns and details required to be filled under GST laws & rules should be timely filed by supplier with requisite details.
- **37.5.2** The input tax credit of **GST** quoted shall be considered for evaluation of bids, as per evaluation criteria of tender document.

37.6 Where the OIL is not entitled to avail/take the full Input Tax Credit of GST:

- **37.6.1** OIL will reimburse **GST** to the Supplier of Goods/Services (Service Provider) at actuals against submission of Invoices as per format specified in rules/regulation of **GST** subject to the ceiling amount of **GST** as quoted by the bidder. In case of any variation in the executed quantities (If directed and/or certified by the In-Charge) the ceiling amount on which **GST** is applicable will be modified on pro-rata basis.
- **37.6.2** The bids will be evaluated based on total price including **GST**.
- **37.7** Payments to Service Provider for claiming **GST** amount will be made provided the above formalities are fulfilled. Further, OIL may seek copies of challan and certificate from Chartered Accountant for deposit of **GST** collected from OIL.
- **37.8** Contractor/vendor shall be required to issue tax invoice in accordance with GST Act and/or Rules so that input credit can be availed by OIL. In the event that the contractor/vendor fails to provide the invoice in the form and manner prescribed under the GST Act read with GST Invoicing Rules thereunder, OIL shall not be liable to make any payment on account of **GST** against such invoice.
- **37.9 GST** shall be paid against receipt of tax invoice and proof of payment of **GST** to government. In case of non-receipt of tax invoice or non-payment of **GST** by the contractor/vendor, OIL shall withhold the payment of **GST**.
- **37.10 GST** payable under reverse charge mechanism for specified services or goods under GST act or rules, if any, shall not be paid to the contractor/vendor but will be directly deposited to the government by OIL.
- **37.11** Where OIL has the obligation to discharge **GST** liability under reverse charge mechanism and OIL has paid or is/liable to pay **GST** to the Government on which interest or penalties becomes payable as per GST laws for any reason which is not attributable to OIL or ITC with respect to such payments is not available to OIL for any reason which is not attributable to OIL, then OIL shall be entitled to deduct/setoff/recover such amounts against any amounts paid or payable by OIL to Contractor/Supplier.
- **37.12** Notwithstanding anything contained anywhere in the Agreement, in the event that the input tax credit of the **GST** charged by the Contractor/Vendor is denied by the tax authorities to OIL for reasons attributable to Contractor/Vendor, OIL shall be entitled to recover such amount from the Contractor/Vendor by way of adjustment from the next

invoice. In addition to the amount of **GST**, OIL shall also be entitled to recover interest at the rate prescribed under GST Act and penalty, in case any penalty is imposed by the tax authorities on OIL.

- **37.13** TDS under GST, if applicable, shall be deducted from contractor's/vendor's bill at applicable rate and a certificate as per rules for tax so deducted shall be provided to the contractor/vendor.
- **37.14** The Contractor will be under obligation for charging correct rate of tax as prescribed under the respective tax laws. Further the Contractor shall avail and pass on benefits of all exemptions/concessions available under tax laws. Any error of interpretation of applicability of taxes/duties by the contractor shall be to contractor's account.
- **37.15** It is the responsibility of the bidder to quote the correct GST rate. The classification of goods/services as per GST (Goods & Service Tax) Act should be correctly done by the contractor to ensure that input tax credit on GST (Goods & Service Tax) is not lost to the OIL on account of any error on the part of the contractor.
- **37.16** In case, the quoted information related to various taxes, duties & levies subsequently proves wrong, incorrect or misleading, OIL will have no liability to reimburse the difference in the duty/tax, if the finally assessed amount is on the higher side and OIL will have to right to recover the difference and in case the rate of duty/taxes finally assessed is on the lower side.
- **37.17** Notwithstanding anything mentioned elsewhere in the Bidding Document the aggregate liability of OIL towards Payment of GST shall be limited to the volume of GST declared by the bidder in its bid & nothing shall be payable extra except for the statutory variation in GST.
- **37.18** Further, it is the responsibility of the bidders to make all possible efforts to make their accounting/IT system GST compliant in order to ensure availability of Input Tax Credit (ITC) to Oil India Ltd.
- **37.19** GST liability, if any on account of supply of free samples against any tender shall be to bidder's account.
- **37.20** In case of statutory variation in **GST**, other than due to change in turnover, payable on the contract value during contract period, the Supplier of Goods/Services (Service Provider) shall submit a copy of the 'Government Notification' to substantiate the rate as applicable on the Bid due date and on the date of revision.

Beyond the contract period, in case OIL is not entitled for input tax credit of **GST**, then any increase in the rate of **GST** beyond the contractual delivery period shall be to Service provider's account whereas any decrease in the rate **GST** shall be passed on to the OIL.

Beyond the contract period, in case OIL is entitled for input tax credit of **GST**, then statutory variation in applicable **GST** on supply and on incidental services, shall be to OIL's account.

Claim for payment of **GST**/Statutory variation, should be raised within two [02] months from the date of issue of 'Government Notification' for payment of differential (in %) **GST**, otherwise claim in respect of above shall not be entertained for payment of arrears.

The base date for the purpose of applying statutory variation shall be the Bid Opening Date.

- **37.21** The contractor will be liable to ensure to have registered with the respective tax authorities, wherever applicable and to submit self-attested copy of such registration certificate(s) and the Contractor will be responsible for procurement of material in its own registration (GSTIN) and also to issue its own Road Permit/E-way Bill, if applicable etc.
- **37.22** In case the bidder is covered under Composition Scheme under GST laws, then bidder should quote the price inclusive of the GST (CGST & SGST/UTGST or IGST). Further, such bidder should mention "Cover under composition system" in column for GST (CGST & SGST/UTGST or IGST) of price schedule.
- **37.23** OIL will prefer to deal with registered supplier of goods/services under GST. Therefore, bidders are requested to get themselves registered under GST, if not registered yet. However, in case any unregistered bidder is submitting their bid, their prices will be loaded with applicable GST while evaluation of bid. Where OIL is entitled for input credit of GST, the same will be considered for evaluation of bid as per evaluation methodology of tender document.
- **37.24** Procurement of Specific Goods: Earlier, there is no tax incidence in case of import of specified goods (i.e. the goods covered under List-34 of Customs Notification no. 12/2012-Cus dated. 17.03.2012 as amended). Customs duty is not payable as per the policy. However, under GST regime, IGST Plus GST compensation cess (if applicable) would be liveable on such imports. Bidders should quote GST as inclusive considering IGST component for the imported Materials portion while quoting their prices on destination basis. However, GST rate to be specified in the price bid format.

37.25 Documentation requirement for GST:

The vendor will be under the obligation for invoicing correct tax rate of tax/duties as prescribed under the GST law to OIL, and pass on the benefits, if any, after availing input tax credit.

Any invoice issued shall contain the following particulars:

- a) Name, address and GSTIN of the supplier;
- b) Serial number of the invoice;
- c) Date of issue;
- d) Name, address and GSTIN or UIN, if registered of the recipient;

Note: OIL GSTIN numbers are as follows:

Arunachal Pradesh: 12AAACO2352C1Z8

- e) Name and address of the recipient and the address of the delivery, along with the State and its code,
- f) HSN code of goods or Accounting Code of services[SAC];
- g) Description of goods or services;
- h) Quantity in case of goods and unit or Unique Quantity Code thereof;
- i) Total value of supply of goods or services or both;
- j) Taxable value of supply of goods or services or both taking into discount or abatement if any;
- k) Rate of tax (IGST, CGST, SGST/UTGST, cess);

- Amount of tax charged in respect of taxable goods or services (IGST, CGST, SGST/UTGST, cess);
- m) Place of supply along with the name of State, in case of supply in the course of interstate trade or commerce;
- n) Address of the delivery where the same is different from the place of supply and
- o) Signature or digital signature of the supplier or his authorized representative. GST invoice shall be prepared in triplicate, in case of supply of goods, in the following manner
- a) The original copy being marked as ORIGINAL FOR RECIPIENT;
- b) The duplicate copy being marked as DUPLICATE FOR TRANSPORTER and
- c) The triplicate copy being marked as TRIPLICATE FOR SUPPLIER.

In case of any advance given against any supplies contract, the supplier of the goods shall issue Receipt Voucher containing the details of details of advance taken along with particulars as mentioned in clause no. (a), (b), (c), (d), (g), (k), (l), (m) & (o) above.

37.26 ANTI-PROFITEERING CLAUSE:

As per Clause 171 of GST Act it is mandatory to pass on the benefit due to reduction in rate of tax or from input tax credit to the consumer by way of commensurate reduction in prices. The Supplier of Goods/Services may note the above and quote their prices accordingly.

37.26.1 In case the GST rating of vendor on the GST portal/Govt. official website is negative/black listed, then the bids may be rejected by OIL. Further, in case rating of bidder is negative/black listed after award of work for supply of goods/services, then OIL shall not be obligated or liable to pay or reimburse GST to such vendor and shall also be entitled to deduct/recover such GST along with all penalties/interest, if any, incurred by OIL.

38.0 WITHHOLDING:

Company may withhold or nullify the whole or any part of the amount due to Contractor, after informing the Contractor of the reasons in writing, on account of subsequently discovered evidence in order to protect Company from loss on account of:

- a) For non-completion of jobs.
- b) Contractor's indebtedness arising out of execution of this Contract.
- c) Defective work not remedied by Contractor.
- d) Claims by sub-Contractor of Contractor or others filed or on the basis of reasonable evidence indicating probable filing of such claims against Contractor.
- e) Failure of Contractor to pay or provide for the payment of salaries/wages, contributions, unemployment compensation, taxes or enforced savings with-held from wages etc.
- f) Failure of Contractor to pay the cost of removal of unnecessary debris, materials, tools, or machinery.
- g) Damage to another Contractor of Company.
- h) All claims against Contractor for damages and injuries, and/or for non-payment of bills etc.
- i) Any failure by Contractor to fully reimburse Company under any of the indemnification provisions of this Contract. If, during the progress of the work Contractor shall allow any indebtedness to accrue for which Company, under any

circumstances in the opinion of Company may be primarily or contingently liable or ultimately responsible and Contractor shall, within five days after demand is made by Company, fail to pay and discharge such indebtedness, then Company may during the period for which such indebtedness shall remain unpaid, with-hold from the amounts due to Contractor, a sum equal to the amount of such unpaid indebtedness.

Withholding will also be effected on account of the following:

- i) Order issued by a Court of Law in India.
- ii) Income-tax deductible at source according to law prevalent from time to time in the country.
- iii) Any obligation of Contractor which by any law prevalent from time to time to be discharged by Company in the event of Contractor's failure to adhere to such laws.
- iv) Any payment due from Contractor in respect of unauthorized imports.

 When all the above grounds for withholding payments shall be removed, payment shall thereafter be made for amounts so with-hold.

Notwithstanding the foregoing, the right of Company to withhold shall be limited to damages, claims and failure on the part of Contractor, which is directly/indirectly related to some negligent act or omission on the part of Contractor.

39.0 In case any part of the work is sub-contracted to a Micro or Small Enterprise as per contract conditions than the contractor shall provide complete details (i.e. name of the sub-contractor, value of sub-contacted work, copy of valid registration certificate etc.) of the sub-contractor to OIL.

- **1.0** Definitions and conditions governing the services in this contract, unless the context otherwise requires.
- 1.1 "AGREEMENT" means this service Agreement.
- 1.2 "WORK" or "SERVICE" means each and every activity required for the successful performance of this contract.
- 1.3 "DISTANCE" means allocated distance through shortest route covered by " to & fro" journey of the vehicle.
- 1. 4 "ACID TANKER" means brand new rubber-lined acid tanker of 7.0 KL capacity built on a 16 MT GVW capacity brand new truck chassis and complete with acid resistant loading & unloading pump and dip system for transportation of various acid solutions up to 30% concentration.
- 1.5 "LOADING POINT" means OIL Industrial Area, Duliajan, Assam.
- 1.6 "UNLOADING POINT" means well sites in OIL's operational areas and as directed.
- 1.7 "BASE STATION" means the station/space provided by the company, where the acid tanker shall be permanently based/ parked. In case of non-availability of Company provided base station/operational exigencies Contractor's has to arrange base station, within 2 Km of the unloading station.
- 1.8 "BREACH OF CONTRACTUAL OBLIGATION" means amongst others also the following:
- i) Carriage of unauthorised passengers/materials other than acids & acid chemicals in the acid tanker by the Contractor while under this Agreement with the Company.
- ii) Unauthorised use of the acid tanker when released to the Contractor for repairing/servicing.
- iii) Withdrawal of the acid tanker from the service before expiry of the term of this Agreement for any reason whatsoever without the consent/instruction of the Company Engineer.
- iv) Failure of the Contractor to place the acid tanker for periodic inspection as per schedule as directed by Company Engineer.
- v) Failure to park the acid tanker after release on close of working hours at Company's approved Base Station.
- 1.9 "COMPANY" means Oil India Limited

- 1.10 "COMMENCEMENT OF SERVICES" means the date of placement of the acid tanker under this Agreement.
- 1.11 "COMPANY ENGINEER" means the following:
- i) General Manager (Chemical) or his/her nominee in case of the following events:
 - a) Normal day-to-day operation of service after placement under the department
 - b) Release of acid tanker for maintenance/inspection/fuelling
 - c) Instruct Contractor to replace by more suitable hand of divers/crews engaged for operating the acid tanker
 - d) Allotment of daily duties and timing of reporting and release
 - e) Authentication of monthly kilometerage statement-cum-bill
 - f) Determination of shutdown or standby, liquidated damages and penalties for default of breach of contract.
 - g) Release of acid tanker and termination of this Agreement in case of complaints as to its deteriorated mechanical conditions.
 - h) Initial placement of the acid tanker.
 - i) Release of the acid tanker upon conclusion of this Agreement.
 - j) Assessment of time to be allowed for repair in case of accident.
 - k) Initial and subsequent inspection of the acid tanker.
 - l) Scrutiny of documents regarding contractor's compliance with the requirements under this Agreement for permits, licenses, employee's roster etc.
 - m) Determination of instances of shutdown or standby due to Force majeure, Bundhs etc.
- ii) CGM Contracts in case of the following events:
 - a) Release/forfeiture of Security Deposit/ Earnest Money Deposit.
 - b) Any dispute under this Agreement as to the Contractor's obligations or otherwise.
 - c) Defaults or otherwise in case of dispute by the contractor.

- 1.12 "DUE DATE OF PLACEMENT" means the date stipulated in the contract for placement of the acid tanker.
- 1.13 "DETERIORATED CONDITION OF ACID TANKER" means the acid tanker found not acceptable to Company Engineer after mechanical inspection or/ and the acid tanker found to be unworthy of undertaking the services envisaged under the provisions of this

Agreement or/ and the acid tanker which is facing repeated breakdown due to inadequate, improper and timely repairs and maintenance and/ or the acid tanker refused by the Company Engineer/user department as being unfit.

- 1.14 "DAILY LOG BOOK" means the format annexed vide proforma-I hereof as may be certified by the Company Engineer on a day-to-day basis during the tenure of this Agreement.
- 1.15 "DRIVER" means an individual possessing sound mental and physical health who must be in possession of Professional Driving License (Heavy), explosive carrying licence (if applicable) and PSV badge (to drive the acid tanker under this Agreement) issued by the Regional Transport Authority, having jurisdiction over the area of operations of the Company, who is engaged by the Contractor and provided with the service envisaged under this Agreement, cost whereof included in the Contract costs.
- 1.16 "DEFAULT" means any of the following omissions or commissions by the Contractor or his/her crew, which will lead to shutdown of the acid tanker and/or breach of contractual obligations:
- a) Delay in initial placement of the acid tanker beyond the stipulated date.
- b) Unsuitability of the Driver or Attendant and/or working crew.
- c) Drunkenness and intoxication of the driver and/or the attendant/ crew.

- 1.20 "LEAVE" means Annual Leave to be granted to the Crew who are employees of the Contractor as per the stipulations of the Motor Transport Workers Act, 1961 as may be in force from time to time.
- 1.21 "CREW" means the driver and other personnel to be employed in the acid tanker as deemed fit by the Contractor for smooth running of the service in respect of whom payment shall be made as per the rates in force under "The Minimum Wages Act" from time to time.
- 1.22 "PENALTY" means the amount payable by the Contractor in the event of breach of Contract which shall be as per clause- 14 below. Penalty shall be levied irrespective of whether such breach resulted in a shut-down or otherwise. In addition no payment shall accrue to the contract in the event of breach of contract leading to penalty.

 - j) Inter-state Migrant Workmen (Regulation of Employment and Condition of Service) Act, 1979
 - k) Payment of Wages Act, 1936
 - 1) Motor Vehicle Act, 1988
 - m) Public Liability Insurance Act, 1991
 - n) Any other Act as applicable from time to time.

The Contractor shall be solely responsible for compliance with all statutory act at all time during the tenure of the service Agreement.

- 1.25 "SHUT DOWN" means disruption/ non-availability of the Service due to any of the defaults.
- 1.26 "SHUT DOWN" shall also mean the non-availability of the service due to an accident.

- 1.27 "STATUTORY OFF" means the off day per week or the compensatory off day in lieu thereof which the Contractor is required to give to his/her/their operating crew as per the Motor Transport Workers Act, 1961 in respect of which adequate relief driver/crew shall be provided at no extra cost.
- 1.28 "TAXES AND DUTIES" means Road Tax, Fitness Fee, Road permit Fee, Registration Fee, Inter-State Permit Fee, VAT for the acid tanker and crew etc (but excluding GST) as may be due and payable by the Contractor entirely at his/ her own cost towards operation of the services envisaged under this Agreement. - 1. Driver's Cabin: Sleeper type all steel construction original factory built by the chassis manufacturer with seating capacity for min. 2(two) persons excluding driver.
- m. In case of pump driven by PTO (Power Take Off) arrangement of the truck, the gearbox of the truck shall have original factory built provision (window cut) for fixing PTO.

NOTE:

- i. In case of supply of equivalent model as per Clause 2.3(b) above, Make & Model of the truck chassis offered shall be clearly indicated in the bid.
- ii. TECHNICAL LEAFLET CONTAINING DETAILED SPECIFICATIONS OF THE TRUCK CHASSIS SHALL BE SUBMITTED ALONG WITH BID IN ORIGINAL FOR SCRUTINY.

2.4 OVERALL DIMENSIONS & WEIGHT:

a. Overall length: Approx. 7750 mm

b. Overall height: Maximum 3000 mm

c. Overall width : Approx. 2100 mm

d. Tank width : Approx. 1600 mm

e. Tank length : Approx. 4000 mm

f. Overall weight: Within 7000 Kg without acid

2.5 OTHERS:

- a. Width of the tank shall be approximately 500 mm smaller than the overall width of the truck chassis for safety point of view.
- b. There shall be a gap of approximately 500 mm in between the driver's cabin and the tank.
- c. Tubular protective bars on either side of the tanker (along the length of the tank) for protection of the tank.
- d. 6-8 chemical bags/carboys may be loaded on the tanker from time to time as & when necessary and accordingly the tanker shall have provision of rack/s for keeping such chemical bags/carboys for transfer to different locations. These chemicals may be Ammonium Biflouride, Corrosion, Inhibitor, Lime, Surfactant, etc.
- e. Standard tool kit, wheel wrench, 1 No. minimum 20 MT capacity jack with handle, etc.

- f. All standard lightings, fittings & accessories like parking light, brake light, back light, traffic indicator light, side markers, reflectors, etc. as per Motor vehicle Act, Reversing Alarm, two large Rear View Mirrors, Towing hook, First Aid Box, Fire Extinguisher, two Flood Lights at rear top of driver's cabin for night operation.
- g. Any other fittings & accessories necessary for handling & transportation of acid solutions / chemicals as per applicable statutory rules & regulations and safety norms. h. Wire-mesh guard from outside for cabin rear window.
- i. The inscription "ON OIL INDIA DUTY" shall be painted prominently at front of the tanker and at the centre position of the tank body on either side. The size of each letter shall be approximately 30cm x 30cm.
- k. The tanker shall be painted with colour shade as per applicable norms, if any.

3.0 INSPECTION:

- 3.1 The tanker shall be duly inspected / tested by the company before accepting the unit for its operation. Such inspection/tests shall be carried entirely at contractor's risk. In case the tanker is found deficient or defective in any manner, same shall not be accepted for operation until such deficiently is completely rectified to the satisfaction of company engineer.
- 3.2 At the time of above inspection during initial placement, amongst others, following documents/details shall be submitted:
- a. Constructional drawing with materials description of the acid tanker along with pump & pump engine details as applicable and copy of Certificate of Fabrication from the tanker fabricator.
- b. Copy of Sale Certificate (Form 21) from the truck manufacturer.
- c. Tanker license from appropriate Govt. Authority, as applicable, Calibration certificate, etc.
- d. All statutory certificates as per MV Act viz. Registration, Pollution, Fitness, Permits, Insurance certificates, Driver's License, etc. in original.
- 3.3 The contractor shall maintain the acid tanker in perfect working condition in all respects during the period of contract. This is an essential obligation of the contractor. Accordingly, in addition to inspection as above, the tanker shall be inspected every three months thereafter or as & when considered necessary by company engineer during the tenure of the contract. Any deficiency / defect found during such inspection must be rectified by the contactor to the full satisfaction of the engineer.
- 3.4 For maintaining the tanker in perfect working condition, contractor shall have to stock sufficient spares for the tanker especially for the acid pump, valves, hoses, etc.
- 3.5 During each inspection, all documents as detailed in Clause 3.2 (c & d) above are to be produced in original for verification.

3.6 The tanker may be inspected at the fabricating works during fabrication in addition to inspection detailed above

4.0 JOB REQUIREMENTS, TERMS & CONDITIONS:

- 4.1 The Acid tanker supplied under this agreement shall primarily be used for loading, unloading and transportation of various acid solutions of concentration up to 30% in OIL's operational area in Assam & Arunachal Pradesh. In addition, from time to time, the pump fitted in the tanker may also be used for loading & unloading of acid solutions in various tanks, pumper units, etc. However, no additional payment shall be made to the contractor for such job.
- 4.2 The duration of the contract agreement shall be 4(four) years.
- 4.3 Crew for the tanker shall comprise of 1(one) driver and 1(one) helper/jugalie.
- 4.4 The contractor shall engage skilled supervisory staff/representative for necessary liaising with company engineer. The name of such persons should be notified in writing to the company.
- 4.5 The contractor must arrange of his/her own all kind of licenses required for plying the tanker.
- 4.6 Contractor shall provide all necessary gloves, aprons, masks, shoes, etc. (i.e. PPE) in adequate quantity to his/her crew for acid / chemical handling & transportation.
- 4.7 The tanker / contractor's representative shall report everyday to Chemical department (operating department) as & when required for receiving instructions for duties allotted for the day to day operations. The contractor's representative may also be asked to report to office on Sundays/holidays whenever operational urgency arises.
- 4.8 The 08-hours duty timing of crew shall be decided by the company and shall be binding on the contractor. The same may be changed from time to time at the discretion of company.
- 4.9 Journey/job authorised by the operating department shall be taken as Authorised and shall only be considered for payment.
- 4.10 In case, the tanker fails to report for duty in time on any particular day without prior permission from company, then the delayed placement will normally be not accepted. On such occasions the tanker shall be treated as shutdown and the same will attract pro-rata deduction of fixed charge and also imposition of penalty as applicable.
- 4.11 The contractors shall not engage the tanker for any private work. If the tanker is found to be deployed for any such unauthorized work even during the period when allowed for routine servicing/maintenance, the tanker shall be treated as shutdown and same will attract pro-rata deduction of fixed charge as well as imposition of penalty as applicable.
- 4.12 Acid transportation job under the contract may not be an everyday affair but occasional only depending upon actual job requirement. Accordingly, average run of the tanker per month shall be approximately 600 (six hundred) kilometres. Contractor shall

have no claim on the company in case no transportation job is allotted on any day; and in such cases only applicable fixed charge shall be paid for the period.

- 4.13 Depending on operational requirement, the contractor may have to keep the tanker loaded with acid/acid chemicals on standby without transporting any fluid. In such an event only fixed charge shall be payable. However, in case of such standby beyond the normal duty hours of the crew members, overtime to the crew member as applicable on pro-rata basis shall be paid.
- 4.14 The contractor shall not refuse parking of the tanker at such places as may be directed by company's representative arising out of interruption/incomplete acid job due to unpredictable reasons like equipment failure, re-scheduling of acid simulation program, etc. At times, even loaded tanker may also be required to be parked at site one day in advance for prolonged acid job.
- 4.15 All handling operation such as loading, transporting, unloading of acid solutions from the tanker shall be carried out by the contractor.
- 4.16 The tanker shall be based normally at Duliajan. But from time to time, the tanker may be required to halt overnight at any station other than the base station, but no additional halting charges shall be payable except overtime to the crew as applicable. In such an event, contractor shall have to arrange his/her own accommodation, expenditure, etc.
- 4.17 The tanker may be allowed to be parked in premises of company subject to availability of space at the end of duty everyday, but the same will be absolutely at the risk of the contractor.
- 4.18 Besides above, all other activities are to be in compliance with the provisions of Oil Mines Regulations 1984, Mines Act 1952.

5.0 PROCEDURE OF COLLECTIONS, TRANSPORTATION AND DELIVERY OF ACID/ACID CHEMICALS:

- 5.1 The contractor or his representative shall be intimated lifting program of acid / acid chemicals from time to time by Chemical department (operating department) depending on the behavior of the wells/fields.
- 5.2 The driver / representative shall collect requisition slip from the loading point before commencement of any loading / transportation job.
- 5.3 The driver / representative shall check and verify the quantity of acid / acid chemicals loaded to the tanker at loading point.
- 5.4 On taking delivery from company's representative, driver / representative must ensure that the lead seal at the outlet of each chamber and the top cover on top of each chamber are intact till the acid / acid chemical is delivered at the unloading points.
- 5.5 The contractor shall ensure proper safety of loaded tanker from any hazard.

- PART-III: SCC
- 5.6 The contractor must ensure that no loss of acid / acid chemicals occurs during transportation. Any damage to tanker or his/her staff & crew during transportation shall be the contractor's responsibility and he/she will be accountable for both legal and financial matters; OIL shall not have any liability for the same.
- 5.7 The tanker once loaded must reach the unloading point within the stipulated time as given hereunder:

S1. No	Distance Slab	Travel Time (one way between the loading point and the unloading point)
1	Up to 40 Km	1 Hr 15 min to 1 Hr 45 min
2	41 - 60 Km	1 Hr 45 min to 2 Hrs 30 min
3	Above 60 Km	2 Hrs 30 min for first 60 Km plus 5 min per each additional 2 Km

Note: Above travel time will be reviewed time to time depending on the road conditions.

- 5.8 In case of delay in arrival to the unloading point beyond the stipulated time given above, the driver shall bring a certificate from the contractor giving detailed reason for such delay.
- 5.9 Inordinate delay in travel time must be intimated to the company's representative either at the loading point or unloading point within a reasonable time not exceeding 12 hours.
- 5.10 In case of shut down/breakdown of the tanker en route, contractor must ensure to bring the entire quantity of acid / acid chemicals to destination within reasonable time as fixed by the company.
- 5.11 The driver of the tanker should be provided with a mobile phone for ease of communication with him as & when necessary en route.
- 5.12 During any unforeseen bundhs, strike, etc. and during subsequent periods of such bundhs, strikes etc. the contractor shall take all necessary steps as advised by the company to facilitate uninterrupted operations.
- 5.13 The seal fixed at the outlet of each chamber of the tanker must not be tampered. Company's representative at the unloading points will check and verify the seals before unloading the acid / acid chemicals. In case of any doubt on the seals, company will have the right to carryout through investigation and take necessary action as deemed fit.
- 5.14 The contractor must ensure that the quantity and quality of the transported acid /acid chemical remain intact till those are delivered at the unloading point. In case of any discrepancy/dispute in quality and / or quantity of the acid / acid chemicals on arrival at the unloading point, the decision of the company's representative shall be final and binding on the contractor. Any such shortfall & deterioration of the acid / acid chemical shall be contractor's responsibility and company may recover compensation against the same from the contractor's bill as deemed fit. Company's representative at the unloading point may refuse to accept loaded tanker if there is reasonable proof of

attempted tapering to the seals or pilferage in any nature as above. In such occasions, company may handover the case to the Govt. Authority at the earliest possible time.

- 5.15 For every trip of transportation, the contractor shall obtain signature of company's representative at loading & unloading points on the document/challan (delivery note) prepared for the purpose in token of delivering the right quality and quantity of the acid / acid chemicals at the unloading point. The documents are to be returned to the company at the office of the Officer-In-Charge of the unloading point.
- 5.16 The measurements before and after filling shall be done by taking dips or by weighing the tanker in weighing bridge and / or by any other suitable method adopted by the company.
- 5.17 The loaded tanker shall ply only on the specific routes as directed by the operating department. Prior written permission is to be obtained from the operating department in case the tanker needs to be diverted through an unspecified route for any reason.
- 5.18 The contractor and his/her staff & crew must cooperate with the company's vigilance personnel in case of any checking carried out by them. In addition, CISF or company's personnel may check the tanker at any time while loading, unloading & during transportation; and the contractor or his/her crew shall have no objection for such checks.

6.0 OTHERS COMPLIANCES:

- 6.1 The tanker shall be free from all financial/legal complications & encumbrances and should there be any interruption in company's operation due to such complications, contractor shall compensate the loss incurred to the company as decided by the company.
- 6.2 It shall be solely the contractor's responsibility to fulfill all legal/statutory formalities for the tanker & crew to ply in Dibrugarh, Tinsukia & Sibasagar district and in any other districts of Assam & Arunachal Pradesh as necessary from time to time. The tanker must have valid license from appropriate Govt. Authority, Registration, Pollution, Fitness, Permits, Insurance and any other certificates necessary for handling acid solutions throughout the tenure of the contract. The tanker shall at all times be Comprehensively Insured by the contractor. It shall also be the contractor's responsibility to procure and renew the necessary permits required for the tanker & its crew to enter and work in Arunachal Pradesh.
- 6.3 Crew for the tanker shall comprise of 1(one) driver and 1(one) helper/jugalie. The driver of the tanker shall possess valid Driving Licence (Heavy); in no circumstances a driver will be allowed to drive the tanker without having a valid driving licence. In such default, the tanker shall be considered as shutdown. Similarly, in case 1(one) helper/jugalie is not engaged, then the tanker will not be allowed to work and same shall be considered as shutdown. However, in case of emergency when situation arises to utilise the tanker without helper/jugalie, the payment against the default helper/jugalie shall be deducted from the contractor's bill.
- 6.4 It shall be entirely the responsibility of the contractor to ensure strict adherence to all safety measures during loading, unloading and transportation and safety of

his/her staff & crew. Accordingly, the contractor is deemed to be fully conversant with the current rules and regulation of Govt Authority regarding handling and transportation of acid / acid chemicals and shall declare the same in writing. An undertaking for the safety measures to be adopted has to be also given before the commencement of the contract agreement. The format for such declaration is available in OIL's Contracts office.

- 6.5 The contractor shall ensure complete safety to the loaded truck from hazard of any kind and also ensure no leakage or draining off of acid / acid chemicals in any manner during the transit or at any stage.
- 6.6 The contractor / staff / crew member must observe the safety and security rules of the company while working inside the declared prohibited areas. Any person found objectionable regarding safety and security must be replaced by the contractor.
- 6.7 The contractor will ensure that all the crew members of the tanker regularly use Personal Protective Equipment (PPE) as per requirement of Oil Mines Act, 1952 and Oil Mines Regulations, 1984. If any of the crew members is found without PPE, the default member will not be allowed to work and accordingly, the payment against the member shall be deducted from the contractor's bill.
- 6.8 The contractor shall be held responsible for any damage/loss that may be caused to company's materials during loading/ unloading/ transportation and loss incurred by the company due to such damage/loss may be recovered from the contractor as deemed fit.
- 6.9 Only adult physically fit persons shall be employed and in no case, minor or adolescent will be allowed to work as crew member/staff.
- 6.10 The crew shall refrain from smoking or carry any inflammable substance at any OIL installations while on duty.
- 6.11 All the crew members/staff must be in physically and mentally fit condition and shall not be under influence of intoxication of any type while on duty. The crew shall have to comply with all the requirements as provided in the Motor Vehicle Act and the Rules framed there under.
- 6.12 The crew members/staff engaged by the contractor may require to undergo Mines Vocational Training to be imparted by the company and contractor shall have no objection to it. Similarly, if company arranges safety class / training for the crew members, the contractor will not have any objection to such class / training.
- 6.13 The contractor shall ensure that his/her crew members follow the instruction of the company's Engineer / Junior Engineer / representative. The crew members shall also not refuse to follow any instruction of safe operation given by company's Installation Manager / Safety Officer / Engineer / Official / Junior Engineer at site.
- 6.14 The contractor shall not refuse to operate his/her tanker in slushy, muddy, and underfoot plinth conditions prevailing in oil field areas, if company engineer certifies the condition.

- 6.15 The monthly disbursement of wages to the Helpers, Drivers by the contractor will be made latest by the 10th day of the subsequent month. The mode of disbursing the monthly wages to the helper/ driver by the concerned contractors will be through account payee cheque or bank transfer/ e-remittance as may be agreed upon mutually themselves. The contractor will have to issue proper wages slip to the driver/ helper containing therein the requisite details such as income and deduction, if any.
- 6.16 The Contractor hereby undertakes that irrespective of his/her/their quoted rates, he/she/they will pay the wages and overtime (if any) of Driver and Helper as per MOS dated 24.01.2014, a copy of which is available at Head- Contracts, OIL, Duliajan's office. Any increase in wages and overtime rates of driver/helper during the tenure of the contract (including extension) will be borne by the Company. The mode of calculation for the payment for enhanced wages and overtime, if any, when the same arises will be decided by the Company. The Company's decision regarding this shall be final and binding on the Contractor.
- 6.17 The Helper, Driver will avail a weekly day of rest after working for 6 consecutive days. The Contractor engaging them shall have to provide reliever driver/operator/helper to run the services of the acid tanker during rest day.
- 6.18 The Helper & Driver will be extended 03 national holidays and 02 festival holidays in a calendar year by the respective contractor.
- 6.19 The Helper & Driver will be granted 18 (eighteen) days annual leave with wages by the contractor which will be non- cumulative and non- en-cashable. The annual leave with wages can be availed 03 times in a calendar year and it will not exceed 18 days in a year.
- 6.20 The Helper and Driver will be extended 5(five) days of casual leave in a calendar year by the contractor which will be non- cumulative and non- en-cashable. The casual leave cannot be combined with the annual leave and cannot be availed for more than 3 (three) days at a time.
- 6.21 The contractor will provide reliever helper and driver to run the services of the acid tanker on account of the above mentioned holidays, casual leave and annual leave. The reliever helper and driver engaged by the contractors during holidays and leaves will be entitled to the applicable daily rate of wages.
- 6.22 The contractor shall deposit the PF and EPF with the PF authority positively on or before the 5th day of the subsequent month and will submit the PF and EPF deposit challan to the company. On production of the challan, the amount will be reimbursed to the contractor. For compliance to the provision of the EPF & MP Act, the contractor will approach the concerned PF authority. In this regard, contractor must submit bill in the 1st day of the beginning of the every month.
- 6.23 The helper/ driver will be provided uniform and shoes by the contractor and the expenditure towards the same will be reimbursed to them by the company on submission of documents/ proof of receipt as given under:
 - a) 02 sets of uniform per year {@Rs.1500 x 2}: Rs. 3000.00
 - b) 01 pair of shoe per year {@Rs.500}: Rs. 500.00

Total: Rs.3500.00 per year.

- 6.24 The quoted rates should be inclusive of all taxes, royalties, levies etc. as applicable but excluding GST and no other charges whatsoever will be payable to the contractor during the currency of the contract. GST, if applicable, shall be to the Company's account. However, GST portion payable directly by the Service Provider (if applicable) shall be reimbursed to the Contractor on the basis of the documentary evidence.
- 6.25 Variation in the running charges will be effective provided fuel (Diesel) price changes plus or minus 5% (Five percent) over the tendered HSD price of Rs. 79.49 per litre. Subsequent variations in running charges will be effective once the fuel (Diesel) price decreases or increases by another 5% over the existing fuel price and so on i.e. for every 5% (or more) decrease or increase in existing fuel price there will be change in running charge accordingly. For any Diesel price variation within 5% of the prevailing rate less (fuel price in a particular time) there will not be any change in running charge.

Change in running charges for the tankers/bowsers will be reviewed once in every month. For this, daily rates of HSD at Duliajan for the previous month will be obtained from IOC and simple average will be worked out. This monthly average and the last amended HSD price of the contract will be used to calculate the variation in running charges in the month. However, the lower threshold limit of running charge per Km is limited to 0 (zero).

- 6.26 Service under this contract shall not be a regular one but occasional only depending upon company's operational requirement. Contractor will have no claim on the company in case no work is allotted. In that case, only fixed charge on prorate basis will be paid for those standby days and other terms and conditions of the contract.
- 6.27 The Contractor is to ensure complete safety of any kind to the loaded acid tanker. It will be obligatory on the part of the contractor to provide a leak proof system for transporting acid and acid chemicals in any manner at any stage during actual delivery at destination. Cost of aforesaid acid and acid chemicals lost during transit will be deducted at the prevailing landed cost of the acid and acid chemicals used for the preparation of the same. The decision of the Company in this regard will be final and binding on the Contractor.
- 6.28 In case the acid tanker is met with an accident damaging the life and property of 3rd party(s) in addition to loss of acid and acid chemicals wholly or partly, the contractor shall sort out the matter immediately with the 3rd party(s) and settle all the dues claims including insurance, if any, at the earliest. In the event of failure to settle such claim by the contractor immediately but not later than 24 hours, the Company may at its discretion, to avoid disruption to company's operation which may arise due to such accident, settle such claim of the 3rd party(s), in which case the amount so paid to the 3rd party(s) shall be deducted from the out standing bills of the contractor. For the accident case, (which is to be substantiated by proper Police Report and MVI Report) loss of acid and acid chemicals lost during transit will be recovered from the contractor's outstanding bills at the prevailing landed cost of the acid and acid chemicals used for the preparation of the same.

7.0 OBLIGATIONS OF THE CONTRACTOR:

- **PART-III: SCC**
- 7.1 The Contractor shall observe and abide by all the Statutory Acts and shall be primarily and solely responsible for observance of the rules and regulations stipulated hereunder.
- 7.2 The Contractor shall be responsible and liable for all claims, monetary or otherwise, arising out of the use of the acid tanker or operations of the services envisaged under this Agreement including liability under the Statutory Act or any other liability as may arise due to operation of this Agreement and the Company shall not be held liable or responsible for any such claim in any manner whatsoever. The Statutory requirements and obligations to be performed under the Statutory Acts affecting the operations of the services under this Agreement shall have to be performed by the Contractor only and shall be his/ her sole responsibility. Be it stated particularly that the Contractor hereby undertakes to fully implement entirely at his/ her own cost all the provisions of the Motor Transport Workers Act, 1961 and other Statutory Acts as may be in force from time to time and the rules framed there under as may be applicable to the operation of the service envisaged under this Agreement in the area of operations of the Company.
- 7.3 The Company shall not be liable for any dues, statutory or otherwise claimed by the employees/ workmen employed by the Contractor for the services rendered under this Agreement and all such claims, statutory or otherwise or operation of any settlement or award in favour of the employees/ workmen employed by the Contractor will be solely against the Contractor and not against the Company. Any demand by the employees deployed by the Contractor against the services envisaged under this Agreement shall have to be settled and satisfied by the Contractor solely and in the event of any loss or inconvenience or disruption that may result because of any non-settlement of such demands which may lead to a disruption of service envisaged under this Agreement shall also be deemed as a default.
- 7.4 The Company shall neither entertain any demands from the employees of the Contractor nor deal directly or indirectly with any recognized or un-recognized unions of such employees. It shall be primarily and solely the responsibility of the Contractor to deal, interact and settle any demands or disputes of his/ her employees individually or through any unions or otherwise and the Company shall not mediate in this matter at all.
- 7.5 Any unsettled disputes between the Contractor and his/ her employees leading to a legal or illegal strike by them would have to be settled by the Contractor expeditiously. Any failure on the part of the Contractor to settle the disputes expeditiously which results in interruption of the services envisaged under this Agreement would be considered as a default under this Agreement and the Agreement would be terminated at the discretion of the Company. The Contractor shall, however, be given reasonable opportunity by the Company to explain that the cause of the dispute was not due to delay on his/ her part or due to failure to implement the statutory obligations under the Statutory Acts as stipulated hereof. In the event if it is proved that the Contractor was in default as mentioned here above, the Company shall have the option to terminate the Agreement forthwith and the Contractor shall not be entitled to any damages or compensation whatsoever on account of such termination.

- 7.6 If the acid tanker is not available for duty due to driver's and helper's strike, the acid tanker will be treated as shut-down for the period of strike.
- 7.7 In case of any disruption/ interruption in the services under this agreement due to any action by any contractor(s) or his/ their acid tanker crew or by both, the contract(s) of the concerned contractor(s) shall be terminated as per the discretion of the company.
- 7.8 In case the acid tanker meets with an accident, the contractor or his representative shall lodge FIR with the nearest Police Station immediately and inform the company in writing about the accident as soon as possible but not later than 24 hours. The contractor shall arrange for guarding the vehicle as well as the product. If there is any spillage of acid & acid chemicals at the site of the accident, the contractor shall take immediate action towards collection and transportation of the spilled product to the respective Unloading Point and arrange for proper cleaning of the site for environment protection at their own cost.
- 7.9 If service of the acid tanker is stopped due to any Local Environmental Problem, the contractor will have to take necessary action immediately to solve the problem vis-avis for restoration of the service and lodge FIR in the nearest Police Station of the incident.
- 7.10 The Contractor shall ensure that the acid tanker deployed under this service Agreement do not cause any damage to the Company's properties. In the event of any such damages, the cost of repair in respect thereof as determined by the Company Engineer shall be deducted from the Contractors outstanding bills. The Company's decision in this regard shall be final.
- 7.11 The Contractor will park the acid tanker at the Base Station at the end of the day's work on round the clock basis with ready availability of the services of the crew in such a manner that the acid tanker can be deployed for any specified duties immediately on receipt of the instructions from the Company's Engineer. The Contractor found violating this will be liable for breach of Contract.
- 7.12 The Contractor must place the acid tanker for duties in time on any particular day as per the instructions of the Company Engineer. In the event of failure to adhere to the foregoing or in the event of unauthorised release of the acid tanker before completion of the normal duty hours, the acid tanker shall be treated as shut down and will attract the penalty for each such failure.
- 7.13 The Contractor shall keep the acid tanker roadworthy throughout the contract period by complying with the statutory requirement, failing which the acid tanker will be treated as shut down.
- 7.14 The Contractor should ensure that the Driver(s)/ Helper(s)/ Attendants (as applicable) are available every day, i.e. on Holidays, Sundays, off days or during leave of the regular driver/ crew as per the requirements of the Company Engineer. In the event of failure to do so, the acid tanker shall be treated as shut down, in which case the penalty shall be deducted from the Contractor.

- PART-III: SCC
- 7.15 The contractor will ensure good conduct of his/her/their acid tanker crew, while on duty. The contractor will be held fully responsible for any unruly behavior of acid tanker crew or any mishap created by acid tanker crew. Company reserves the right to ask the contractor to remove any unruly acid tanker crew and in such event contractor shall remove the crew immediately form the service and arrange suitable replacement in terms of the contract without any disruption of the service. In the event to failure to do so, the acid tanker will be treated as shutdown till such time a suitable replacement is made, in such case the penalty shall be deducted for the contractors bill(s).
- 7.16 The Contractor must maintain a register incorporating particulars with the names of the driver/ helper/ crew engaged by the Contractor and the aforesaid be required to sign the register maintained for this purpose, for monitoring their daily attendance, off days, holidays and leave roster etc. This will ensure proper roster of the crew in respect of compliance with the various Statutory Acts. This register must be available for inspection by the appropriate authorities as and when required. The Contractor will be required to submit a certificate to the Company every month along with the Monthly kilomereage Statement-cum Bill in the format set out in Proforma-III annexed herewith to the effect that all statutory requirements effecting the operations of the service under this Agreement under various Statutory Acts have been complied with.
- 7.17 The contractor shall undertake only journeys authorised by the Company Engineer. Any unauthorised journeys shall be treated as breach of Contract and shall attract penalty for each such occurrence without prejudice to the Company's right to terminate the agreement without any compensation to the Contractor on any account whatsoever.
- 7.18 The Contractor shall make all payments to the operating staff under the Agreement through Account Payee Cheque only. Further, if asked for by the Company, the Contractor shall produce certificate/statement from the concerned bank towards proof of payment of wages to their crew/operating staff. No payment shall be processed if aforesaid information is not accompanied in the Bill of the corresponding month.
- 7.19 The Contractor shall operate the service envisaged under this agreement in an efficient manner as per the instructions of the Company Engineer. The contractor shall abide by the Company Engineer instructions always and ensure continuous uninterrupted service on day-to-day basis.
- 7.20 Contractors will be required to arrange entry passes for the driver/ helper/ Supervisor employed by him and for himself from CISF for entering into OIL Operational Areas.
- 7.21 Contractors will be required to make refueling arrangement for the acid tanker from the petrol pump near the respective Loading/Unloading Points. For this purpose Re-fuelling time for the acid tanker shall not be more than 30(Thirty) minutes.
- 7.22 The contractor shall ensure use of Safety shoes, Safety hand gloves and uniforms by the acid tanker crew while on duty. These safety items and the uniform for the acid tanker crew shall be provided by the contractor. In the event of non-compliance of the clause by any contractor, the company will deduct at a rate of Rs.100.00 per day from his/ her monthly bill. Contractor should submit documentary evidence in support of purchase of PPE for his/ her crew at the time of placement of the acid tanker.

8.0 PARTICULARS, SPECIFICATIONS AND INSTRUCTION TO THE CONTRACTOR:

PART-III: SCC

- 8.1 The contractor shall instruct his/ her crew suitably to ensure that while driving speed limits as enforced are necessarily observed. Any breach of law due to violation of the speed limits shall have to be redressed by the Contractor entirely at his/ her own cost.
- 8.2 The acid tanker to be engaged for this service must conform to the specifications described in the Contract Agreement.
- 8.3 The Contractor must ensure timely renewals of all licenses and permits within the due dates. Otherwise the acid tanker will be treated as shut-down and penalty will be levied as per the agreement.
- 8.4 The Contractor shall provide at his/ her own cost the accommodation/ housing for his/her employees, sheds for repairing and servicing of the acid tanker, land/ garages for parking of the acid tanker (wherever applicable) in and around the base station.
- 8.5 The acid tanker must be maintained in first class road worthy condition along with uniform standards of safety as initially provided for at the time of acceptance of the acid tanker on the date of placement.
- 8.6(a) Speedometer and kilometreage reading must be maintained at a high standard of accuracy. Any defects noticed by the Company Engineer at the initial and subsequent periodical inspection must be rectified forthwith by the Contractor at his/ her own cost. Until such rectification, the readings of the instrument will be subject to such correction factor as may be determined by the Company Engineer. The Company's decision in this regard shall be final and binding on the Contractor.
- 8.6(b) Monthly payments shall accordingly be regulated according to the corrected readings.
- 8.7 All employees of the Contractor who are deployed under this service Agreement must observe the security and safety rules of the Company when working inside the declared prohibited areas or otherwise. Any individual found to be objectionable from security considerations must be replaced by the Contractor.
- 8.8 The acid tanker must also be provided with the towing hook. All expenses on account of the foregoing shall be borne by the Contractor entirely on his/ her own cost.
- 8.9 The Contractor shall furnish together with related power of attorney the names and specimen signature(s) of the authorised representative(s) who will be overall in charge of the Contractor's organization to carry out its obligations including preparation of bills, receipts of cheques etc.
- 8.10 The contractor or his representative should report to General Manager (Chemical)'s office at 7:00 AM and 12.30 PM on all working days for instruction for routine operation. Moreover, he may also be asked to report to office on Sundays/Holidays whenever operational urgency arises. In case of non-availability of

the contractor/his representative for handing over the transfer advice of acid & acid chemicals in aforesaid time, the delay period will be treated as shut-down as it will result in operational delay of the company. In such cases, company shall reserve the right to impose penalty at twice the rate of fixed charge/hour subject to a minimum of Rs.2000/-per day.

- 8.11 At the time of placement of the acid tanker, the Contractor must furnish to the Company the name(s) of the Driver(s), Helper(s), crew as may be applicable together with particulars of their driving license(s), Petroleum product carrying licence (if applicable) etc. In case any changes are made in the crew deployed under this Agreement at any time during the tenure of this contract, the Contractor must notify the Company in writing detailing the reasons for replacement and furnish similar particulars as required hereof in respect of the replacement(s). However the replacement crew shall be subjected to approval of the Company. For reliever driver /helper ,when the actual driver /helper is absent on account of leave, sick etc prior permission must be taken from the company submitting all the documents regarding driving licence (including petroleum product carrying licence, if applicable).
- 8.12 The contractor will be responsible for supervision of the entire job of transportation from loading point to the unloading point during the tenure of the contract.
- 8.13 The Contractor must have DOT telephone (landline) and/or mobile phone, so that the contractor can be contacted in odd hours as & when required i.e. even on holidays.
- 8.14 The Contractor must instruct their authorised representatives and driver to cooperate with the Company's vigilance personnel as and when required.
- 8.15 In addition to the vigilance personnel, CISF or Company's personnel may check the acid tanker at any time while loading, unloading & during transportation. The Contractor or his representative should have no objection for such checks.

9.0 RIGHTS OF COMPANY ENGINEER:

- 9.1 The Company Engineer shall upon initial placement of the acid tanker duly check the mechanical as well as physical parts along with all the relevant documentation before accepting it for the services under Agreement. Such inspection/ test shall be carried out entirely at the Contractor's risk and cost. The acid tanker found deficient or defective in any manner will not be acceptable till such deficiency is completely rectified to the satisfaction of the Company Engineer.
- 9.2 The Company Engineer shall arrange for allocation of the acid tanker duty to the various unloading points.
- 9.3 The Company Engineer shall have power amongst others as follows:
 - (i) Fix the normal duty hours/ timings of the Contractor and regularly monitor the same.

- (ii) Instruct the Contractor from time to time for such further inspection as may be necessary for the proper and adequate supply of services and for keeping such records as are deemed necessary.
- (iii) Instruct the Contractor to replace by another suitable person(s) if any of his/her crew engaged for running/ operating the acid tanker or for general management of the service is found unsuitable for the job. Company shall not be responsible or liable in the event of any action by the Contractor against his/her employees or workmen in any manner whatsoever arising out of their removal or replacement.
- (iv) Instruct the Contractor to remedy breach of contract and levy any penalty in relation thereto.
- (v) Refuse the services of the acid tanker found in deteriorated condition and advise the Contractor to rectify the defects or arrange for replacement till such default is remedied.
- (vi) Instruct the Contractor to utilize the services beyond the stipulated hours of service.
- (vii) Instruct the contractor to undertake authorised journeys to specified destination(s).
- (viii) Undertake periodic inspection of the acid tanker as per programme as may be decided by him/ her. Such inspection shall be carried out in the presence of the Contractor or in presence of his/ her authorised representative. Such inspection /test carried out by the Company shall be at the Contractor's cost and risk.
- (ix) Instruct the Contractor to rectify the defects or renewal of the documents revealed upon periodic inspection /test carried out by the Company. Such rectification shall be at the Contractor's cost entirely.
- (x) Instruct the Contractor to remove the acid tanker from the service under this Agreement in respect of which defects have been found upon periodic inspection till the time of rectification of the defects.
- (xi) Check the speedometer and kilometer readings and notify any defects and determine any correction factor on the kilometreage statement-cum-bill in case the speedometer and kilometer readings are found to be defective.
- (xii) Company Engineer shall clearly indicate the total shut down hours in a month due to shut down with reason in the monthly statement which will be treated as final for determining penalty, if any.
- (xiii) Instruct the contractor to remove any crew member, whom in his opinion is behaving in unruly manner or committing any misconduct while on duty.
- (xiv) Instruct the contractor to produce any document pertaining to the subject tender and / or contract agreement.

9.4 The Contractor shall at all time obey the instructions of the Company Engineer and ensure compliance of the above mentioned orders and instructions.

10.0 BILLING & PAYMENT:

- 10.1 For the purpose of payment for the service rendered the Contractor shall:
- i) Accept as final the daily log book as per Proforma-I which must be signed on a daily basis by the Company's Engineer/representative. Any deletions and/or overwriting on the Daily Log Book must be avoided as far as practicable and if such deletions and overwriting are incidence, the same must be countersigned by the Company's Engineer, otherwise the Monthly Kilometreage Statement-cum-bill shall not be accepted. Proforma-I must be made out in triplicate of which one copy is to be retained by the Contractor for preparing the monthly kilometreage statement-cum-bill only at the end of each month.
- ii)(a) Prepare monthly kilometreage statement-cum-bill as per Proforma-II and submit the same to the Company's Engineer for verification at the end of the month. The monthly kilometreage statement-cum-bill must be accompanied with a certificate every month furnished by the Contractor as per Proforma-III towards his/her compliance with the Statutory Acts effecting the operation of this service agreement.
- b) The monthly kilometreage statement-cum-bill must include a factual record of based on daily log sheet for services rendered as per instructions of the Company's Engineer, i.e., for Company duty only and should exclude for payment the following:
- Such kilometreage and time as may be involved for refueling is in excess of the allowable time.
- Such hours/days or part thereof as may be involved on for routine servicing and maintenance in excess of 48(Forty Eight) hours in a calendar month.
- Such hours/days or part thereof as may be involved in any month when the acid tanker was shut down due to default or otherwise.
- c. Accept such adjustments on the monthly kilometreage statement-cum-bill as the Company's Engineer may make on account of all or any of the following:
 - A) Deductions for defaults/shut downs not shown correctly.
 - B) Deductions for penalties in case of breach of contract.
 - C) Adjustment of kilometreage and corrections as per agreement.
 - D) Such other adjustments as the Company's Engineer shall consider necessary as per the requirements of the situation prevailing, the Company's decision in which regard shall be final.
- 10.2 The monthly kilometreage statement-cum-bill shall be certified by the Company's Engineer after adjustments have been made as reflected hereof and shall be processed for payment on receipt of a clear and unambiguous bill for payment along with the original of the Daily Log Book for that month.

- PART-III: SCC
- 10.2.1 Payment shall be made for the days/kilometreage actually logged on Company's duties as per instructions of the Company's Engineer and as reflected in the Daily Log Book. If the acid tanker is unable to ply for a particular day/period fixed charge for that day/period will not be paid.
- 10.2.2 For the days or part thereof when the services envisaged under this agreement are disrupted due to default/shut down etc, penalty will be applicable.
- 10.2.3 In case of a default by the Contractor leading to partial or total shut down of the services envisaged under this agreement whether for a full day or part thereof, penalty as per clause no. 14.0 below shall be levied for each such default on pro-rata basis. The penalty leviable shall be deducted from the monthly bills of the Contractor.
- 10.2.4 In case of any situation not provided under this agreement, the Company's Engineer or any other person authorised on his/her behalf by the Company, shall have the right to decide upon any further claim on the facts and circumstances, which shall be binding upon the contractor.
- 10.2.5 Expenditure towards Entry fees/ Parking charges incurred by the acid tanker enroute to Loading/ Unloading Stations will be reimbursed on actual basis on production of Receipts/ Cash memo in original.
- **11.0 TERMS OF PAYMENT:** The company will make payment only for the journeys/trips authorized by the Company's Engineer.
- 11.1 On receipt of the Monthly statement-cum-kilometreage Bill the Company's Engineer shall verify the same with the Daily Log Book and shall process the same after making adjustment as may be necessary for Payment Monthly kilometreage statement/bills submitted by the Contractor will be cross-checked by the Company with the records maintained by the Company. Wherever discrepancies are found the Company will have right to make necessary corrections in the statement/bill submitted by the Contractor before certifying/countersigning the same for processing payment.

The monthly statement-cum-kilometereage bill must be accompanied with the following:

- i) Daily Log Book in original for the month as per Proforma-I.
- ii) Statutory compliance statement per Proforma-III.
- iii) Proof of payment to acid tanker crew per Proforma-IV.

<u>Note:</u> The rates shall be fixed and firm for the entire tenure of the contract and shall be binding on both the parties. No changes of rates shall be allowed under any circumstances during the tenure of this service agreement including the extension period, if any, except as provided elsewhere in this agreement.

- 11.2 The Company shall pay the Contractor during the term of the contract the amounts due from time to time calculated according to the rates of payment set out hereof and in accordance with the other provisions of this agreement.
- 11.3 The Company shall within 30 (Thirty) days of receipt of invoice notify the contractor of any item under dispute, specifying the reasons thereof, in which event, the

disputed amount may be withheld till settlement of the dispute, but payment shall be made for the undisputed portion on or before the due date.

- 11.4 The Company will make monthly payment subject to adjustment/ deduction as necessary for the services rendered in each calendar month and will endeavor to pay before expiry of 30 (Thirty) days from the date of submission of monthly kilometreage statement-cum-bill as per Proforma-II annexed herewith and certificates as per Proforma-III &Proforma-IV annexed herewith for the month on the basis of accepted rates calculation as mentioned in General Conditions Of Contract (GCC) of this service agreement. The above period shall be counted from day when the kilometreage statement under this agreement is received by the Company.
- 11.5 In absence of the certificates as per Proforma-III &Proforma-IV, bill will not be processed for payment and any delay arising out of the same shall be attributable to the contractor.
- 11.6 A daily log book will be maintained in triplicate. The contractor's representative or his/her driver should collect the original and a copy of the daily log book has to be submitted with statement-cum-bill in Proforma-II for claiming payment.
- 11.7 All payments will be made by the Company to the Contractor by cheque / online transfer to the Contractor's bank account. Payment of any invoice shall not prejudice the right of the Company to question the validity of any charge therein, provided Company by way of written notice notifies the Contractor of objection to any item within one year after the payment is made to the Contractor.
- 11.8 Any reimbursement claim made by the Contractor after the expiry date of this Contract will not be entertained.
- 11.9 Except the rates payable as per terms & conditions detailed in this tender /contract document and reimbursement / escalation / deduction / reduction as mentioned elsewhere in this tender /contract document, no other charges, whatsoever may be, shall be payable to the contractor during the tenure of the contract.
- 11.10 For every trip of acid transportation, the Contractor must obtain signature of Company's authorized representative at the specified loading and unloading points based on the document issued for the purpose. Such documents will be required to be produced along with the bills against the service rendered.

12.0 ACID TANKER AVAILABILITY:

- 12.1 The Contractor shall supply and maintain the services of the acid tanker in normal service EVERY DAY with driver and attendant crew (wherever applicable) as required by the Company. In the event of default, the Contractor is liable to be penalised as per Clause no. 14.0 below. Such penalty will be recovered normally from the Contractor's running monthly/ outstanding bills. This is without prejudice to the Company's right to recover the amount in any other manner as laid out in the law including appropriation of the Security Deposit towards such outstanding.
- 12.2 In case of default not leading to shut down, the Company Engineer shall notify the Contractor to remedy the default within reasonable time and till such default is

remedied, if necessary, the acid tanker shall be released to the Contractor, whereupon it shall be treated as shut down and penalty as applicable shall be levied too.

- 12.3 In case of Bandhs, Road Blockade, Strike etc. called by various organizations, if the acid tanker is not available for duty due to absence of driver(s) or otherwise affecting Company's operation and if in the opinion of the Company such situation could have been avoided, then the acid tanker will be treated as shut down and penalty as per clause 14.0 below will be imposed and shall be recovered from the Contractor's bills with proper intimation. It is to be clearly understood that 48 hours time allotted per month for general maintenance without deduction of pro-rata fixed charge will not be adjusted against such bandhs/ strike period.
- 12.4 Major break-down: (A) In case of accident and consequence of non-availability of the acid tanker
- i) Pro-rata fixed charges will be deducted but the same will not attract penalty, if contractor notifies within 48 hours in writing to the Company with adequate proof about accident, copy of FIR (FIRST INFORMATION REPORT) lodged by the contractor shall be required in addition to other proof to be submitted.
- ii) In the above case, if the Contractor gives a replacement acid tanker of the same specification (with same vintage or latest) for the period of shut-down of the accident acid tanker, pro-rata fixed charges will be payable to the Contractor during the period of utilisation of the replacement acid tanker. However, this will not be applicable in case of:
 - a) Accident caused by rough/ rash driving/ overspeed (more than 35km/hr) or because of negligence of the driver engaged where a FIR is lodged by a third party and services of the acid tanker are not available for formalities to be observed as per the laws of the land.
 - b) The acid tanker is involved in litigation or in theft cases for which a case has been registered by the police.

In such situations the acid tanker will be treated as shut down and will attract penalty in addition to the deduction of pro-rata fixed charges.

- (B) In case of major maintenance (exceeding 48 hrs allowable) fixed charges will not be payable and the same will attract penalty. However, if the contractor gives a replacement acid tanker of the same specification (with same vintage or latest) for the period of shut-down of the acid tanker, the same will not attract penalty. During the period of utilisation of the replacement acid tanker pro-rata fixed charges will be payable to the contractor.
- (C) In case of (A) & (B), the time required to repair and place back the acid tanker into Company's service shall be decided by the Company representative which shall be final and not alterable. On expiry of such allotted time pending placement of the original acid tanker penalty will be recovered in addition to the deduction of pro-rata fixed charges.

13.0 TERMINATION:

13.1 In the event of the Contractor's failure to place the acid tanker in due time or render proper services as per terms of this Agreement, the Company reserves the right to

terminate wholly or partially the Agreement with 30 (Thirty) days notice in writing and on the expiry of this notice period, this service Agreement shall stand terminated and Contractor shall not be entitled to any damage or compensation on account of such termination or otherwise from any cause arising whatsoever.

- 13.2 The Company may without prejudice to any other remedy for breach of contract, by written notice of default sent to the Contractor to terminate this agreement in whole or in part if the Contractor fails to perform any of his/her obligations under this agreement or if the contractor does not cure his/her failure immediately upon receipt of notice from the Company or during any such time as the Company may authorize in writing after receipt of default notice from the Company.
- 13.3 In the event of Company terminates the contract in whole or in part pursuant to clause No. 13.1 hereinabove the Company may procure, upon such terms and in such manner as may deem appropriate similar services and in such event Contractor shall be liable for any excess costs incurred by the Company in this regard. However, the contractor shall continue performance of the contract to the extent not terminated.
- 13.5 This agreement shall stand partially or fully terminated in case of default due to delay in placement of the acid tanker beyond 01 (one) month from the due date of placement stipulated hereof. In such event, bidder shall be dealt as per the Banning Policy (available in OIL's website) of Company.
- 13.6 The Company may, at any time, terminate the contract if the acid tanker is found involved in any pilferage case and a police case is registered against the same.
- 13.7 In case the contractor fails to place his/ her acid tanker beyond 5 (five) months from the date of issue of Letter of Award (LOA), then his/ her particular contract will be cancelled terminating the service against the contract.

14.0 PENALTY:

i) For non-deployment of the acid tanker (excluding the allowable time for maintenance & refuelling) for a period upto 2 (two) hours, penalty shall be levied at the rate of Rs. 1,500.00 (Rupees One Thousand Five Hundred only) per day on pro-rate basis. In case the acid tanker is not available for a period of more than two hours, penalty shall be levied at the rate of Rs. 1500.00 per day. Penalty will be maximum Rs. 1500.00 for more than 2 hrs. of non-deployment of acid tanker.

Additionally, the pro-rata fixed charge for the period of non-deployment of the acid tanker will not be payable in both the above cases.

- ii) For non-deployment of the acid tanker during any bandh/ strike if company provides security, penalty will be levied at a rate of Rs.1500.00 per day and the pro-rata fixed charge for the period of non-deployment of the acid tanker will not be payable.
- iii) Transportation of acid to the desired destinations is to be done within the specified time considering average travelling time of acid tanker during transit @ 20 KM/hr. for both to and fro journey. Company shall reserve the right to charge for any failure on the part of the contractor regarding delay during transit. Time taken during transit in excess of 20 KM/hr will be considered as penalty at the rate of double the fixed

charge/hour in a day subject to a minimum of Rs. 2000/- per day. Decision of company in this regard will be binding on the contractor.

- iv) In case of default as mentioned below, penalty shall be levied as per sub-clause 14.0 (i) above.
- a) Delay in initial placement of the acid tanker beyond the stipulated date.
- b) Unsuitability of the Driver or Attendant and/or working crew.
- c) Drunkenness and intoxication of the driver and/or the Attendant/crew.
- d) Non-availability of the acid tanker due to any reason, whatsoever, including but not limited to the following conditions
 - (i) Deteriorated mechanical condition of the acid tanker and/or breakdown.
 - (ii) Due to inadequate routine maintenance.
 - (iii) Time taken for routine serving/maintenance in any particular month in excess of time allowed for such maintenance in any month.
- e) Non-possession of the valid permits and licenses for the crew and acid tanker.
- f) Non-supply of fuel.
- g) Delay in placement of the acid tanker on any day as per the instruction of the Company Engineer and/or unauthorised and un-timely release of the acid tanker on any day without prior permission and authorization from the Company /engineer during the tenure of this Agreement.
- h) If the Contractor keeps the acid tanker at a station other than the stipulated Base Station without the authorization of the Company Engineer.
- i) Non-availability of the acid tanker due to defects detected upon periodic inspection/tests by the Company.
- j) Non-rectification of defects expeditiously upon detection by the Company Engineer upon inspection/test undertaken by the Company.
- k) Non-availability of the acid tanker or crew when required by the Company Engineer.
- l) Failure on the part of contractor to discharge his/her obligations as set out in Clause 7.0 above and/or failure on part of the contractor to abide with particular instructions as set out in clause 8.0 above and/or failure on part of the contractor to obey the instructions of the company engineer as set out in clause 9.0 above.
- m) Any other acts or commissions by the Contractor or his/her crew whether specified or not hereof which disrupt the continuity of the service envisaged under this Agreement.
- n) Non-availability of the acid tanker /crew.
- o) Non-availability of services due to unauthorised/lightening strike by Contractor or his/her crew for any reason whatsoever. The period of non-availability of services will be treated as shutdown.
- v) In case, the Contractor fails to place the acid tanker for duties in time on any particular day, without prior permission from Company, then delayed placement/duty

timings will not be accepted. On such occasions the acid tanker will be treated as shutdown and the same will attract pro-rata deduction of fixed charge and also imposition of penalty at rates given above.

- c) Due notice would be given for any change of personnel under item (b) above.
- d) We hereby accept the responsibility for the safety of all the personnel engaged by us and for the safety of the Company's personnel and property involved during the course of our working under this contract. We would ensure that all the provisions under the Oil Mines Regulations, 1984 and other safety rules related to execution of our work would be strictly followed by our personnel. Any violation pointed out by the Company's Engineers would be rectified forthwith or the work suspended till such time the rectification is completed by us and all expenditure towards this would be on our account.
- e) We confirm that all persons engaged by us would be provided with the necessary Safety Gears at our cost.
- f) All losses caused due to inadequate safety measures or lack of supervision on our part would be fully compensated by us and the Company will not be responsible for any lapses on our part in this regard.
 - g) We shall abide by the following HSE (Health, Safety & Environmental) POINTS:

GENERAL HEALTH, SAFETY & ENVIRONMENT (HSE) POINTS:

- 1. It will be solely the Contractor's responsibility to fulfill all the legal formalities with respect to the Health, Safety and Environmental aspects of the entire job (namely; the person employed by him, the equipment, the environment, etc.) under the jurisdiction of the district of that state where it is operating. All the safety gears mentioned above are to be provided to the working personnel before commencement of the work.
- 3. The Contractor shall prepare written Safe Operating Procedure (SOP) for the work to be carried out, including an assessment of risk, wherever possible and safe methods to deal with it/them. The SOP should clearly state the risk arising to men, machineries & material from the mining operation/operations to be done by the contractor and how it is to be managed.
- 4. The contractor shall provide a copy of the SOP to the person designated by the mine owner who shall be supervising the contractor's work.
- 5. Keep an up to date SOP and provide a copy of changes to a person designated by the Mine Owner/Agent/Manager.
- 6. Contractor has to ensure that all work is carried out in accordance with the Statute and SOP and for the purpose he may deploy adequate qualified and competent personnel for the purpose of carrying out the job in a safe manner. For work of a specified scope/nature, he should develop and provide to the mine owner a site specific code of practice in line.
- 7. All persons deployed by the contractor for working in a mine must undergo Mines Vocational Training, initial medical examination, PME. They should be issued cards stating the name of the contractor and the work and its validity period, indicating status of MVT, IME & PME.
- 8. The contractor shall submit to DGMS returns indicating Name of his firm, Registration number, Name and address of person heading the firm, Nature of work, type of deployment of work persons, Number of work persons deployed, how many work persons hold VT Certificate, how many work persons undergone IME and type of medical coverage given to the work persons.

- 9. The return shall be submitted quarterly (by 10th of April, July, October & January) for contracts of more than one year. However, for contracts of less than one year, returns shall be submitted monthly.
- 10. It will be entirely the responsibility of the Contractor/his Supervisor/representative to ensure strict adherence to all HSE measures and statutory rules during operation in OIL's installations and safety of workers engaged by him. - 19. A contractor employee must, while at work, take reasonable care for the health and safety of people who are at the employee's place of work and who may be affected by the employee's act or omissions at work.
- 20. A contractor employee must, while at work, cooperate with his or her employer or other persons so far as is necessary to enable compliance with any requirement under the act or the regulations that is imposed in the interest of health, safety and welfare of the employee or any other person.
- 21. Contractor's arrangements for health and safety management shall be consistent with those for the mine owner.

INTEGRITY PACT

PART-VI: INTEGRITY PACT

Between

Oil India Limited (OIL) hereinafter referred to as "The Principal"

And

(Name of the bidder)......hereinafter referred to as "The Bidder/Contractor"

Preamble:

The Principal intends to award, under laid down organizational procedures, contract/s for Hiring the Services of O1 (one) no. Brand new Rubber-Lined Acid Tanker of 7.0 KL capacity built on a 16 MT GVW capacity 4x2 brand new truck chassis and complete with acid resistant loading & unloading pump and dip system for transportation of various acid solutions up to 30% concentration in OIL's operational areas in Assam & Arunachal Pradesh for a period of O4 (four) years. The Principal values full compliance with all relevant laws and regulations, and the principles of economic use of resources, and of fairness and transparency in its relations with its Bidder/s and Contractor/s.

In order to achieve these goals, the Principal cooperates with the renowned international Non-Governmental Organization "Transparency International" (TI). Following TI's national and international experience, the Principal will appoint an external independent Monitor who will monitor the tender process and the execution of the contract for compliance with the principles mentioned above.

Section: 1 - Commitments of the Principal

- (1) The Principal commits itself to take all measures necessary to prevent corruption and to observe the following principles:
 - 1. No employee of the Principal, personally or through family members, will in connection with the tender for, or the execution of a contract, demand, take a promise for or accept, for him/herself or third person, any material or immaterial benefit which he/she is not legally entitled to.
 - 2. The Principal will, during the tender process treat all Bidders with equity and reason. The Principal will in particular, before and during the tender process, provide to all Bidders the same information and will not provide to any Bidder confidential/additional information through which the Bidder could obtain an advantage in relation to the tender process or the contract execution.
 - 3. The Principal will exclude from the process all known prejudiced persons.
- (2) If the Principal obtains information on the conduct of any of its employees which is a criminal offence under the relevant Anti-Corruption Laws of India, or if there be a Page 2 of 6 substantive suspicion in this regard, the Principal will inform its Vigilance Office and in addition can initiate disciplinary actions.

Section: 2 - Commitments of the Bidder/Contractor

(1) The Bidder/Contractor commits itself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the tender process and during the contract execution.

- 1. The Bidder/Contractor will not, directly or through any other person or firm, offer, promise or give to any of the Principal's employees involved in the tender process or the execution of the contract or to any third person any material or immaterial benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.
- 2. The Bidder/Contractor will not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, Subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
- 3. The Bidder/Contractor will not commit any offence under the relevant Anticorruption Laws of India; further the Bidder/Contractor will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- 4. The Bidder/Contractor will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- (2) The Bidder/Contractor will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- (3) The Bidder/Contractor signing Integrity Pact shall not approach the Courts while representing the matters to IEMs and he/she will await their decision in the matter.

Section 3 - Disqualification from tender process and exclusion from future Contracts

If the Bidder, before contract award has committed a transgression through a violation of Section 2 or in any other form such as to put his reliability or risibility as Bidder into question, the Principal is entitled to disqualify the Bidder from the tender process or to terminate the contract, if already signed, for such reason.

1. If the Bidder/Contractor has committed a transgression through a violation of Section 2 such as to put his reliability or credibility into question, the Principal is entitled also to exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of the transgression. The severity will be determined by the circumstances of the case, in particular the number of transgressions, the position of the transgressions within the company hierarchy of the Bidder and the amount of the damage. The exclusion will be imposed for a minimum of 6 months and maximum of 3 years.

- 2. The Bidder accepts and undertakes to respect and uphold the Principal's Absolute right to resort to and impose such exclusion and further accepts and undertakes not to challenge or question such exclusion on any ground, including the lack of any hearing before the decision to resort to such exclusion is taken. This undertaking is given freely and after obtaining independent legal advice.
- 3. If the Bidder/Contractor can prove that he has restored/recouped the Damage caused by him and has installed a suitable corruption prevention system, the Principal may revoke the exclusion prematurely.
- 4. A transgression is considered to have occurred if in light of available evidence no reasonable doubt is possible.
- 5. Integrity Pact, in respect of a particular contract, shall be operative from the date Integrity Pact is signed by both the parties till the final completion of the contract **or as mentioned in Section 9 Pact Duration whichever is later**. Any violation of the same would entail disqualification of the bidders and exclusion from future business dealings

Section 4 - Compensation for Damages

- 1. If the Principal has disqualified the Bidder from the tender process prior to the award according to Section 3, the Principal is entitled to demand and recover from the Bidder liquidated damages equivalent to Earnest Money Deposit/Bid Security.
- 2. If the Principal has terminated the contract according to Section 3, or if the Principal is entitled to terminate the contract according to Section 3, the principal shall be entitled to demand and recover from the Contractor liquidated damages equivalent to Security Deposit/Performance Bank Guarantee.
- 3. The bidder agrees and undertakes to pay the said amounts without protest or demur subject only to condition that if the Bidder/Contractor can prove and establish that the exclusion of the Bidder from the tender process or the termination of the contract after the contract award has caused no damage or less damage than the amount or the liquidated damages, the Bidder/Contractor shall compensate the Principal only to the extent of the damage in the amount proved.

Section 5 - Previous transgression

- 1. The Bidder declares that no previous transgression occurred in the last 3 years with any other Company in any country conforming to the TI approach or with any other Public Sector Enterprise in India that could justify his exclusion from the tender process.
- 2. If the Bidder makes incorrect statement on this subject, he can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason.

Section: 6 - Equal treatment of all Bidders/Contractor/Subcontractors

1. The Principal will enter into Pacts on identical terms with all bidders and contractors.

- 2. The Bidder/Contractor undertake(s) to procure from all subcontractors a commitment in conformity with this Integrity Pact. The Bidder/Contractor shall be responsible for any violation(s) of the provisions laid down in this agreement/Pact by any of its sub-contractors/sub-vendors.
- 3. The Principal will disqualify from the tender process all bidders who do not sign this Pact or violate its provisions.

Section: 7 - Criminal charges against violating Bidders/Contractors/

If the Principal obtains knowledge of conduct of a Bidder, Contractor or Subcontractor, or of an employee or a representative or an associate of a Bidder, Contractor or Subcontractor, which constitutes corruption, or if the Principal has substantive suspicion in this regard, the Principal will inform the Vigilance Office.

Section: 8 - External Independent Monitor/Monitors

- 1. The Principal appoints competent and credible external independent Monitor for this Pact. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.
- 2. The Monitor is not subject to instructions by the representatives of the parties and performs his functions neutrally and independently. He reports to the Chairperson of the Board of the Principal.
- 3. The Contractor accepts that the Monitor has the right to access without restriction to all Project documentation of the Principal including that provided by the Contractor. The Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor is under contractual obligation to treat the information and documents of the Bidder/Contractor/Subcontractor with confidentiality.
- 4. The Principal will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the Principal and the Contractor. The parties offer to the Monitor the option to participate in such meetings.
- 5. As soon as the Monitor notices, or believes to notice, a violation of this agreement, he will so inform the Management of the Principal and request the Management to discontinue or heal the violation, or to take other relevant action. The monitor can in this regard submit non-binding recommendations. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action. However, the Independent External Monitor shall give an opportunity to the bidder/contractor to present its case before making its recommendations to the Principal.
- 6. The Monitor will submit a written report to the Chairperson of the Board of the Principal within 8 to 10 weeks from the date of reference or intimation to him by the 'Principal' and, should the occasion arise, submit proposals for correcting problematic situations.

- PART-VI: INTEGRITY PACT
- 7. If the Monitor has reported to the Chairperson of the Board a Substantiated suspicion of an offence under relevant Anti-Corruption Laws of India, and the Chairperson has not, within reasonable time, taken visible action to proceed against such offence or reported it to the Vigilance Office, the Monitor may also transmit this information directly to the Central Vigilance Commissioner, Government of India.
- 8. The word 'Monitor' would include both singular and plural.

Section: 9 - Pact Duration

This Pact begins when both parties have legally signed it. It expires for the Contractor 12 months after the last payment under the respective contract, and for all other Bidders 6 months after the contract has been awarded.

If any claim is made/lodged during this time, the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged/determined by Chairperson of the Principal.

Section: 10 - Other provisions

- 1. This agreement is subject to Indian Law. Place of performance and jurisdiction is the Registered Office of the Principal, i.e. New Delhi. The Arbitration clause provided in the main tender document/contract shall not be applicable for any issue/dispute arising under Integrity Pact.
- 2. Changes and supplements as well as termination notices need to be made in writing. Side agreements have not been made.
- 3. If the Contractor is a partnership or a consortium, this agreement must be, signed by all partners or consortium members.
- 4. Should one or several provisions of this agreement turn out to be invalid, the remainder of this agreement remains valid. In this case, the parties will strive to come to an agreement to their original intensions.
