Rules for Draw of Lots to be held on 20.08.2018 (09:30 am Onwards) at Contracts Department, Duliajan

(Ref. E-Tender No. CDO7861P19 - Hiring the Services of 02 (Two) nos. Water Tankers with driver's cabin and 09 KL capacity water tank mounted on the truck chassis of TATA Truck model TATA SE 1613/42 or TATA LPT SE 1613/TC-42 or any other equivalent Truck Chassis of vintage not earlier than 01.01.2014 having self-loading and unloading facilities for sprinkling of water over roads and water/kill fluid transfer in OIL's Operational Areas in Assam for a period of 06 (Six) months with a provision for extension by another 06 (Six) months with OIL's offered rate.)

This is for general information to all concerned that the following rules will be applicable for the above noted Draw of Lots (Lottery):

- 1.0 Numbers allotted for Draw of Lots (Lottery) have been assigned alphabetically.
- 2.0 The allotted numbers for Draw of lots are of **Single** digit.
- 3.0 Each technically acceptable bidder has been allotted 1 (one) lottery number.
- 4.0 There will be only one tombola cage. The cage will contain **three nos. each of digits "1" to "4"** (total twelve nos. tombola balls) for the draw of lots.
- 5.0 **Procedure for Draw:**
 - 5.1 First a digit will be drawn from the cage. The digit coming out (**within 1 to 4**) will be recorded and put back into the cage. **Priority Number** shall be assigned accordingly to the selected bidders.
 - 5.2 The bidder shortlisted first would be assigned as Priority No. **"1"** and will be considered for further processing as per tender norms. Draw shall be carried out similarly for selecting Priority No. **"1"** and **"2"**, in that order.
- 6.0 **Redraw:** Redraw for all the digits for a particular priority number will be done if the number found is a **repeat number**.
- 7.0 The numbers drawn, priority number and the name of the bidders shall only be announced during the lottery.
- 8.0 Draw of Lots (Lottery) will be done by a member from the public/contractor present at the time of Lottery in presence of OIL's officials and the person drawing the same will be required to put his/her signature against the numbers drawn by him/her.

- 9.0** Subsequent award of contract and hiring of the required services shall be guided as per terms & conditions of the tender. Selection through this Lottery is provisional.
- 10.0** All the 02 (two) bidders selected through draw of lots shall be considered for awarding of Contract as per priority no. of the bidder. Since, the requirement of Water Tanker under this tender is 02 (two) numbers, the bidder selected first (priority no. wise) shall be considered for awarding of contract for both the tankers.

Further the second (priority no. wise) bidder shall be kept in waiting list. In case of failure of the selected first bidder for the present requirement/any future requirement, the waitlisted bidder will be considered for award of contract. The waiting list shall remain valid upto 03.11.2018.
