BID REJECTION / EVALUATION CRITERIA:

1.0 BID REJECTION CRITERIA (BRC):

The bid shall conform generally to the specifications and terms and conditions given in the Bidding Documents. Bids shall be rejected in case services offered do not conform to the required parameters stipulated in the technical specifications. Notwithstanding the conformity of the bid to the stipulated specifications, the following requirements shall have to be particularly met by the Bidders without which the offer will be considered as non-responsive and rejected.

1.1) TECHNICAL:

The bidders shall have experiences of having successfully completed **similar work** as mentioned below during last 7 (seven) years ending last day of month previous to the one in which applications are invited should be either of the following:

- (i) **Three similar completed works each costing not less than Rs.5,75,500.00**

Or

- (ii) Two similar completed works each costing not less than Rs. 7,19,300.00

Or

- (iii) One similar completed works each costing not less than Rs.11,50,900.00

Similar Work shall be any one or any combination of the following works.

- a) Work of Installation and Commissioning of **Impressed Current Cathodic Protection System** for hydrocarbon pipeline, including supply of materials.

Or

- b) Cathodic Survey Work of any one or any combination of the following viz **Synchronous ON-OFF** or **CAT** or **CIPL** or **DCVG** or **A-FRAME** or **Coating Conductance** or **Current Requirement** or **Interference**.

Or

- c) Impressed Current Cathodic Protection System **Monitoring & Maintenance Work** for hydrocarbon pipeline.

DOCUMENTARY EVIDENCE:

- a) Documentary evidence in support of work experience and fulfilling the requirement of bidder's experience and similar work must be submitted along with techno-commercial bid.
- b) These documents should be in the form of copies of **Work Order(s) and/or Contract Document(s)** along with the **Completion Certificate (s)**.
- c) The **Work Order and/or Contract Document** shall contain detailed scope of work in support of work done.
- d) If the documentary evidence for work experience as submitted against **Similar Work** does not clearly provide evidence of experience in CAT survey(s), then bidder shall submit additional document (s) for experience in CAT survey, which should be in the form of copies of Work Order and / or Contract Document along with the Completion Certificate(s). There is no minimum financial limit applicable for these additional document(s). The Work Order and/or Contract Document shall contain detailed scope of work in support of CAT survey.

1.2 FINANCIAL:

Financial capability: Bidders must have,

1.2.1. Average Annual financial turnover as per Audited Annual Reports for the last three accounting years (ending 31st March 2015) should not be less than **Rs 4,31,600.00**

1.2.2 For Proof of Annual Turnover any of the following documents /photocopy must be furnished

A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business

OR

Audited Balance Sheet and Profit & Loss account.

1.3 All the supporting documents in compliance to BRC requirements under clause 1.1 & 1.2 above shall be scanned and uploaded along with the technical bid.

1.4 *Any bid not complying BRC requirements shall be summarily rejected.*

1.5 To ascertain the substantial responsiveness of the bid the Company reserves the right to ask the Bidder for clarification in respect of clauses covered under BRC and such clarification fulfilling the BRC clauses must be received on or before the deadline given by the Company, failing which the offer will summarily rejected.

1.6 In case, any of the clauses in the BRC contradict with other clauses of Bid Document elsewhere, then the clauses in the BRC shall prevail.

2.0 BID EVALUATION CRITERIA (BEC):

2.1 Bids conforming to the terms and conditions stipulated in the bid document and considered responsive and subject to qualifying the Bid Rejection Criteria will be considered for further evaluation.

2.2 To ascertain the inter-se-ranking, the comparison of the responsive bids will be made on the basis of total cost of various works envisaged under the contract.

2.3 Any discount/rebates offered shall not be considered for evaluation of bids. However, if the lowest bidder happens to be the final acceptable bidder for award of contract and if they have offered any discount/rebate the contract shall be awarded after taking into consideration such discount/rebate after negotiation or otherwise.

2.4 In case more than one bidder emerges as lowest bidder due to equal rate quoted by the bidder, then the lowest bidder will be decided by draw of lots. Company's decision in this regard is final and binding to all bidders
