Attested copies of Registration Certificate etc. must be submitted as evidence along with the Bid(s). Any commitment by the bidder(s) for transfer of ownership/procurement of vehicles after submission of bids will not be accepted.
- (b) One Bidder can offer maximum 1(one) Truck only. Priority list will be made through Draw of Lots amongst the eligible bidders.
- (c) The address of the bidder must not be of OIL's Quarters / Settlement Area / OIL Premises(excluding "OIL Market" and "Public Bus Stand", Duliajan). However this clause shall not be applicable for Sons/Daughters of OIL employees in service who are not dependent of OIL employee as per OIL's policy.
- (d) The bidder must not be employed in Government/Quasi Government/Public Sector\_Undertaking and/or dependent of OIL employee in service.
- (e) The bidder must not be an employee or dependent of any employee of any Government/Quasi Government/Public Sector Undertaking.
- (f) Eligible offers for trucks running under existing contracts of OIL will also be accepted.
