# BID REJECTION CRITERIA /BID EVALUATION CRITERIA (BRC)

# [A] Financial capability: Bidders must have

- 1. Average Annual financial turnover as per Audited Annual Reports for the last three accounting years (ending 31<sup>ST</sup> March, 2014) should be at least ₹7,37,500.00
- 2. For Proof of Annual Turnover any of the following documents /photocopy must be furnished
  - A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
  - Audited Balance Sheet and Profit & Loss account.

### [B] Experience: Bidders must have;

The bidder shall have successfully completed of the following magnitude during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

- (i) Three similar completed works each costing not less than  $\mathbf{\xi}$  9,83,400.00
- (ii) Two similar completed works each costing not less than ₹12,29,200.00

Or

(iii) One similar completed works each costing not less than ₹19,66,700.00
