BID REJECTION CRITERIA / BID EVALUATION CRITERIA (BRC)

[A] Financial capability: Bidders must have;

- a) Average Annual financial turnover as per Audited Annual Reports for the last three accounting years preceding scheduled bid opening date should be at least **Rs 6,43,500/-.**
- b) For Proof of Annual Turnover any of the following documents /photocopy must be furnished
 - A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
 - Audited Balance Sheet and Profit & Loss account.

[B] Experience: Bidders must have;

Experience of having successfully completed similar works <u>(similar work mean supply of Manpower)</u> during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

- (i) Three similar completed works each costing not less than Rs. 8,58,000/-.

 Or
- (ii) Two similar completed works each costing not less than Rs. 10,72,500/-.

Or

(iii) One similar completed works each costing not less than Rs. 17,16,000/-.

Documentary proof must be furnished in support of the experience by way of purchase order / work order / contract document along with completion certificate from the organization to whom such services have been rendered.

[C] <u>BID EVALUATION CRITERIA (BEC)</u>:
