# BID REJECTION CRITERIA /BID EVALUATION CRITERIA (BRC)

### [A] Financial capability: Bidders must have;

- a) Average Annual financial turnover as per Audited Annual Reports for the last three accounting years preceding scheduled bid opening date should be at least Rs 1,43,500.00/-.
- b) For Proof of Annual Turnover any of the following documents /photocopy must be furnished
- A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
- Audited Balance Sheet and Profit & Loss account.

### [B] Experience: Bidders must have;

Experience of having successfully completed similar works (similar work mean supply of Manpower) during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

- (i) Three similar completed works each costing not less than **Rs. 1,91,350/-.**
- (ii) Two similar completed works each costing not less than Rs. 2,39,170/-.

### [C] <u>BID EVALUATION CRITERIA (BEC)</u>:

- (i) Bids conforming to the terms and conditions stipulated in the bid document and considered responsive and subject to qualifying the Bid Rejection Criteria will be considered for further evaluation.
- ii) To ascertain the inter-se-ranking, the comparison of the responsive bids will be made on the basis of commission rates (%, percentage) quoted by the bidders.
- iii) Any discount/rebates offered shall not be considered for evaluation of bids.
