### **BID REJECTION CRITERIA /BID EVALUATION CRITERIA (BRC)**

## [A] Financial capability: Bidders must have;

- a) Average Annual financial turnover as per Audited Annual Reports for the last three accounting years preceding scheduled bid opening date should be at least Rs 1,04,000/-.
- b) For Proof of Annual Turnover any of the following documents /photocopy must be furnished
  - A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
  - Audited Balance Sheet and Profit & Loss account.

## [B] Experience: Bidders must have;

Experience of having successfully completed similar works (similar work mean supply of Manpower) during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

- (i) Three similar completed works each costing not less than **Rs. 1,38,600/-.**
- (ii) Two similar completed works each costing not less than **Rs. 1,73,200/-.**
