Average Annual financial turnover as per Audited Annual Reports for the last three years ( <u>year ending 31<sup>st</sup> March, 2014</u>) preceding scheduled bid closing date should be at least <u>₹ 67,000.00</u>

- A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
- Audited Balance Sheet and Profit & Loss account.

## 2.0 Experience: Bidders must have;

- 2.1 Bidders must have Experience of having successfully completed during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following
