Oil India Limited, a Government of India Enterprise intends for hiring the services for testing of Air Quality, Effluent water, Noise level etc. at PS9, Dumar, RS-15, Belgachi & RS16 Thanabihpur. Interested bidder may purchase the Bid Documents against payment of Rs.500/- in the form of demand draft from schedule Bank payable to **Oil India Limited, Guwahati** from the office of the (i) Chief Manager (Contracts) Guwahati-781171 or (ii) Dy.CEPL(Ops)PS9, Dumar from 29.04.2015 to 29.05.2015 during office hours from 8.00 AM to 10.00 AM. The Bid Closing Date (BCD) is as under :-

- i) Guwahati then BCD 04.06.2015 at 13.30 Hrs.
- ii) PS9, Dumar BCD 01.06.2015 at 13.30 Hrs

BID REJECTION CRITERIA (BRC)

- A) The bid shall conform to the specifications and terms and conditions given in the Bidding Documents. Bids will be rejected in case material and services offered do not conform to the required parameters stipulated in the technical specifications. Notwithstanding the general conformity of the bid to the stipulated specifications, the following requirements will have to be particularly met by the Bidders without which the same will be considered as non-responsive and rejected. All the documents related to BRC shall be submitted along with the Bid.

1.0 Financial capability: Bidders must have:

- 1.1 Average Annual financial turnover as per Audited Annual Reports for the last three accounting years (**ending 31st March, 2014**) should be at least **₹ 42,200.00**

For Proof of Annual Turnover any of the following documents /photocopy must be furnished

- A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
- Audited Balance Sheet and Profit & Loss account.

2.0 Experience: Bidders must have;

- 2.1 The Bidder shall have the experience of providing the services for testing of Air Quality, Stack Monitoring, Effluent water, Noise level etc in last 7 (seven) years reckoned from the date of bid closing date.

- 2.2 The above job experience shall be in :

- (i) Three similar completed works each costing not less than ₹ **56,200.00**
Or

- (ii) Two similar completed works each costing not less than ₹ **70,200.00**
Or

- (iii) One similar completed works each costing not less than ₹ **1,12,300.00**

Similar work means :

Services for testing of Air Quality, Stack Monitoring, Effluent water, Noise level

NOTE:

Documentary evidence in support of work experience and fulfilling the requirement as spelt out in clause 2.1 & 2.2 must be submitted along with bid. These documents should be in the form of copies of Completion Certificates/ Payment Certificates issued by the Owner of a pipeline. However, the originals of these documents shall have to be produced by the bidder, as and when asked for.

B) Evaluation of Bids:

The Bids will be evaluated as per the Bid Evaluation Criteria (BEC) as stated herein under:

BID EVALUATION CRITERIA (BEC)

1. Bids conforming to the terms and conditions stipulated in the bid document and considered responsive and subject to qualifying the Bid Rejection Criteria will be considered for further evaluation.
2. To ascertain the inter-se-ranking, the comparison of the responsive bids will be made on the basis of total cost of various works envisaged under the contract.
3. In case more than one bidder emerges as lowest bidder due to equal rate quoted by the bidder, then the lowest bidder will be decided by draw of lots. Company's decision in this regard is final and binding to all bidders
4. Any discount/rebates offered shall not be considered for evaluation of bids. However, if the lowest bidder happens to be the final acceptable bidder for award of contract and if they have offered any discount/rebate the contract shall be awarded after taking into consideration such discount/rebate after negotiation or otherwise.
