A) Financial capability: Bidders must have

1. Average Annual financial turnover as per Audited Annual Reports for the last three accounting years (ending 31st March, 2014) should be at least ₹ 2,27,800.00

For Proof of Annual Turnover any of the following documents /photocopy must be furnished

- A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
- Audited Balance Sheet and Profit & Loss account.

2. Experience: Bidders must have;

Experience of having successfully completed similar works during last 7 years and should be either of the followings:

- (i) Three completed works each costing not less than $\boxed{3.03.800.00}$
- (ii) Two completed works each costing not less than ₹3,79,700.00

Or

(iii) One completed works each costing not less than ₹ 6,07,500.00

The similar work means:

i) Experience of having supplied or undertaken similar work i.e.fabricated Fibreglass Re-inforced Polyster resin(FRP)with CPWD, Railways, APWD, IOC, ONGC or any other Government department/ public sector organizations or other corporate bodies during the last 7(seven) years as on date.

3.0 Other documents to be provided:
