BID REJECTION CRITERIA (BRC)

1. Financial capability: Bidders must have:

Average Annual financial turnover as per Audited Annual Reports for the last three accounting years ending financial year (ending 31st March, 2014) should be at least ₹88,900.00

For Proof of Annual Turnover any of the following documents /photocopy must be furnished

- A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
- Audited Balance Sheet and Profit & Loss account.

2. Experience: Bidders must have;

Experience of having successfully completed similar work during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

- (i) Three similar completed works each costing not less than ₹ 1,18,500.00 Or
- (ii) Two similar completed works each costing not less than ₹ 1.48,100.00

(iii) One similar completed works each costing not less than ₹ 2,37,000.00
