BID REJECTION CRITERIA (BRC)

The bid shall conform generally to the specifications and terms and conditions given in the Bidding Documents. Bids will be rejected in case material and services offered do not conform to the required parameters stipulated in the technical specifications. Notwithstanding the general conformity of the bid to the stipulated specifications, the following requirements will have to be particularly met by the Bidders without which the same will be considered as non-responsive and rejected. All the documents related to BRC shall be submitted along with the Techno-Commercial Bid.

1.0 Financial capability: Bidders must have:

Average Annual financial turnover as per Audited Annual Reports for the last three accounting years ending financial year (ending 31^{st} March, 2015) should be at least $\stackrel{?}{\underset{}{\sim}}$ 1.27,500.00

For Proof of Annual Turnover any of the following documents /photocopy must be furnished

- A Certificate issued by a practicing Chartered / Cost Accountant Firm, with membership number certifying the Annual Turnover and nature of business.
- Audited Balance Sheet and Profit & Loss account.

2.0 Experience: Bidders must have;

- 2.1. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which bids are invited should be either of the following
 - (i) Three similar completed works each costing not less than ₹ 1,69,900.00
 - (ii) Two similar completed works each costing not less than $\stackrel{?}{\underbrace{}}$ 2,12,400.00

(iii) One similar completed works each costing not less than ₹ 3,39,800.00

3.0 **Evaluation of Bids**:

BID EVALUATION CRITERIA (BEC)

- 2.1 The bids conforming to the technical specifications, terms and conditions stipulated in the tender documents and considered to be responsive after subjecting to Bid Rejection Criteria will be considered for further evaluation as per the Bid Evaluation Criteria given below.
- 2.2 To ascertain the inter-se-ranking, the comparison of the responsive bids will be made subject to loading for any deviation. Comparison of offers will be done on total evaluated cost on the basis of rates quoted in the Price Bid Format.
- In case of identical lowest offered rate by more than 1 (one) bidder, the selection will be made by draw of lot between the parties offering the same lowest price.

4.0 EXEMPTION OF TENDER FEE AND EMD:

- (i) Small Scale Industries (SSI) registered with NSIC under Single Point Registration Scheme are exempted from payment of tender fees for the items they are registered with NSIC. Valid registration certificate with NSIC must be enclosed along with the application for issuing tender documents.
