B) DOSING TANK with Heater; QUANTITY: One (01) No. per PACKAGE

Each tank shall be Rockwool insulated (thermally and electrically) provided with tubular level gauge, heater, thermocouple and temperature controller, bolted flat removable lid, welded nipple connection complete with SS globe or ball valves (minimum ½ inch NPT) for connecting to the suction end of the metering pumps. Each tank should also have 1" drain point complete with SS globe or ball valve.

- i. TYPE: CS fabricated, Vertical, Cylindrical design, Tori spherical Dished end formed bottom, with tubular level gauge, bolted flat removable lid.
- ii. MATERIAL: SS 304 conforming to ASTM A 240
- iii. SIZE: Ø 600 mm Dia x 750 mm H
- iv. CAPACITY: 200 Ltr (minimum)
- v. NOZZLES: Size of the nozzles shall be of 1" (inch) size and their numbers shall be as per flow plan.

- xi. HEATER: Plate type Heater of 3 Kw rating with FLP heater head. Heater head and temperature controller duly housed in Flameproof enclosure type tested and certified by Central Industrial Mining and Fuel Research Institute (CIMFR), Dhanbad, or any government approved NABL accredited test laboratory for use in hazardous area zone-1, gas group IIA & IIB. Tank to be provided with suitable electrical insulation.

iii. MATERIAL: Body and mesh of SS 316.

iv. MESH SIZE: 40

D) VALVES:

Suitable Ball Valves in Suction and Discharge line, Check Valve (Type: lift check) on discharge lines, Gauge Cock for pressure gauge isolation of size 1/2 inch NB (rated to suitable test pressure) conforming to ANSI B 16.34 shall be provided as per detailed flow plan & P & ID.

E) RELIEF VALVE:

i. Quantity: 02 nos. per package

ii. Type: Spring Loaded

iii. Port Size: ½"

iv. Operating pressure / Set pressure: 70 / 77 kg/cm2

F) FITTINGS:

- i. Suitable Socket welded fittings of SS 316 conforming to ANSI B 16.11.
- ii. FLANGES: Suitable Flanges to ANSI B 16.5, $\frac{1}{2}$ " (Inch) material to ASTM A 182 F 316 for suction and discharge.

All fittings shall be rated to suitable test pressure.

G) PIPING:

Seamless piping Sch 40 in SS 316 of % inch to ASTM A 312 as per flow plan piping requirement for suction and discharge. Piping shall be designed for use of thick viscous liquids during winters. Additionally, the bidder shall supply 100 Mtr of Seamless piping Sch 40 in SS 316 of % inch to ASTM A 312 as additional piping material for laying discharge piping from dosing system to point of dosing.

All piping shall be rated to suitable test pressure.

H) PRESSURE GAUGE:

i. TYPE: Bourdon type with accumulator type Pulsation Dampener.

ii. MAKE: Protech/Y2K/Ashcroft/Altop/SreeGuru

iii. LIQUID CONTACT: SS 316 iv. RANGE: 0-100 Kg / cm²

v. DIAL SIZE: For effective readability within given pressure range

vi. QUANTITY: 2 Nos / Package.

I) CALIBRATION POT:

i. Quantity: 01 no. per packageii. Type: Fill and Draw Typeiii. MOC: Borosilicate Type

iv. Volume: 100 cc.

J) CORROSION RESISTANCE:

The dozing package including dozing tank supports, Cabinet enclosure, Skid frame shall be painted with 02 (two) coats of epoxy primer or two (02) coats Epoxy paint for corrosion resistance.

K) SKID MOUNTING:

Dosing package shall comprise of One (01) Nos. Dosing tank with Heater assembly, two (02) nos. of dosing pump, Calibration pot and Suction strainer all of them shall be mounted on a common platform. Dozing pumps and Calibration Pot shall be mounted in an enclosure with two doors and plug locks for Safety.

Tanks and pumps shall be interconnected with suitable piping with isolation & drain valves and fittings as per flow plan confirming to specifications as above. Skid Frame shall be of ISMC 75 x 40, with suitable cross members for rigidity.

All system piping shall be rigidly supported to the skid frame for rough handling & vibration free standalone operation.

The piping network shall be provided with necessary flange/unions at suitable places for ease of dismantling and replacement/repairing of pump/filter/valves etc. in case of breakdown/damage.

SKID FRAME SIZE: Over all Skid shall be judiciously sized to accommodate all components of the dosing system along with adequate space for movement of work persons during maintenance/repair.

BB: SPECIAL NOTES TO BIDDERS

- 1.0 The items shall be brand new, recent manufacture, unused & of prime quality. The manufacturer shall warrant (in the event of an order) that the product supplied will be free from all defects & fault in material, workmanship & manufacture and shall be in full conformity with ordered specifications. This clause shall be valid for 18 months from date of shipment / dispatch or 12 months from the date of receipt at site, whichever is earlier. The defective materials, if any, rejected by OIL shall be replaced by the supplier at their own expense. Bidders must confirm the same in their quotations.
- 2.0 The bidder must submit the following documents with the bid for technical evaluation:
 - i) Detailed flow plan and P&ID diagram of the dosing system and Bill of material as per P&ID diagram.
 - ii) Detailed cross sectional/dimensional drawing of pump
 - iii) Literatures, catalogues, operating manual
 - iv) Detailed Electrical schematic and component layout Diagram of all electrical equipment involved.
 - v) Detailed Electrical Line Diagram, earthing scheme, wiring scheme.
 - vi) Quality assurance plan
- 3.0 The electrical components must be confirming to requirements of relevant Indian standard and shall be suitable for installation in Hazardous Area Zone 1, Gas Groups IIA and IIB, of Oil Mines. These items shall be type tested and certified by Central Institute of Mining and Fuel Research (CIMFR), Dhanbad, or any government approved NABL accredited test laboratory for FLP & WP construction for use in above area. A copy of the valid type test certificate shall be submitted along with the bid for technical evaluation.
- 4.0 The FLP electrical equipment shall have name plate of corrosion resistant material. Test certification no. and other relevant details shall be embossed on the name plate.
- 5.0 The FLP electrical equipment shall be guaranteed for one year after date of supply and tested for routine tests at manufacturer's factory.
- 6.0 Frame size & make of the offered heater should be mentioned in the offer
- 7.0 Copy of the drawing of the offered FLP heater enclosure showing terminal box & cable entry arrangement with double compression FLP & weatherproof cable gland should be submitted with the offer for scrutiny, otherwise the offer will not be considered for evaluation.
- 8.0 All unused cable entries holes must be plugged with CMRI certified FLP sealing plugs made of cast iron.
- 9.0 Packing shall be adequate to avoid transit damage & protection against tropical rains
- 10.0 Bidder shall categorically mention that their offer complies with all the features mentioned in the tender specification & all the relevant documents required as per above points are enclosed in their offer.

- 11.0 The bidder shall, in the event of an order, agree to submit the following documents along with supply of the unit:
 - a. Detailed flow plan and P&ID diagram/Foundation Drawing of the unit.
 - b. Detailed Operation & Maintenance (O&M) Manual.
 - b. Guarantee Certificate of entire unit and its components for 12 months after date of receipt of supply.
 - c. Valid Test certificate of electrical components for routine tests done at manufacturer's works.
 - d. Layout of earthing and wiring scheme.
 - e. Detailed Electrical schematic and component layout Diagram of all electrical equipment involved.
- 12.0 The bidder shall supply all the spare parts required for initial commissioning of the unit at OIL field installation in and around Digboi, Assam. Cost of such commissioning spares must be included in the total material cost of the pump packages.
- 13.0 The bidder shall quote for recommended spares along with price, part nos. of individual items for two (02) years trouble free operation of the dozing unit. While quoting for these spares, the bidder shall take into account the consumption pattern as deemed fit. **The price of these spares shall not be considered for evaluation.** However, procurement of these spares shall be at the discretion of OIL.
- 14.0 The bidders shall also confirm availability of all the spares quoted, for a period of five (05) years from the date of supply of the dozing unit.
- 15.0 In the event of an order, first fill of lubricant shall be within the scope of supply of the bidder.
- 16.0 The Bidder to submit Technical Compliance Check List along with technical bid as per annexures attached.
- 17.0 The bidder shall categorically confirm that the pump shall be able to handle various chemicals used in E&P activity, i.e. Oil Soluble Demulsifiers, Deoilers, Pour Point Depressant (Flow Improver), Methanol etc.

18.0 Inspection & Testing:

- i. Bidder shall quote third party inspection charge separately.
- ii. The unit will be inspected by Third Party Inspection Agency approved by OIL viz. M/s IRS, M/s Lloyds, M/s Rites, M/s Bureu Veritas, M/s DNV only with the following scope of work:
 - a) To review and ensure use of raw materials as per purchase order.
 - b) To review the material test certificates.
 - c) To witness hydro test of the tank & fittings.
 - d) To witness final dimensional inspection and ensure proper workmanship.
 - e) The above scope of inspection is for general guideline only. If the thirdparty desires to carry out any additional inspection, the same should be included under intimation to OIL.

- 19.0 Any deviation(s) from the tender specification should be clearly highlighted specifying justification in support of deviation.
- 20.0 Bidder to sign and submit completely filled up Technical check list and Technical Evaluation Matrix for Bid evaluation criteria and Technical specification.
- 21.0 Bidder should categorically confirm in the technical bid that the tendered items will be supplied within 06 (six) months after receipt of purchase order, without which the bid will be rejected.


