- A) Types Of Engine:
- a) The Engine must be 4(four) stroke, water cooled, diesel engine, counter clockwise rotation (viewed from the flywheel end), governing class-A1, capable of developing minimum 125 HP @ 1800 RPM at flywheel end for continuous duty (Operating speed range 1500-2200 RPM).
